

Bush, Saudi Prince Holds Hands As Big Oil Companies Bloom

CRAWFORD — President Bush and Crown Prince Abdullah of Saudi Arabia turned a few heads walking through bluebonnets at his Prairie Chapel Ranch last Monday, while the Big Four oil companies announced a net gain of \$28.8 billion for the first quarter of this year.

The de facto leader of the world's largest oil-exporting nation was in Texas to meet with Bush to talk about increasing oil production to theoretically drive high energy prices down in the United States.

By the end of the week, oil prices dropped to its lowest level since February — below \$50 a barrel from \$55 to \$49.72 on the New York Mercantile

AAA reported that the national average remained at \$2.24 per gallon last Friday, up from \$1.81 at the same time last year. Motorists in California and Hawaii pay more than \$2.50 per gallon. A gallon of regular gas in Crawford was selling for \$2.18 last

Bush kept pushing the Senate to pass his energy bill, but what seemed to stick in the eye of popular opinion was a picture of Bush leading the Saudi Crown Prince by the hand around his ranch, as they discussed a variety of issues, from the Palestinian-Israeli conflict and terrorism to security and trade.

This hand holding not to mention Bush's kiss on both of Abdullah's cheeks, coupled with high gas prices and the memory of the 2001 terrorist attacks (15 of the 19 airplane hijackers were Saudis), failed to sit well with more than a few Americans because it was yet another sign of Bush-Saud

Blogger Charles Featherstone (www.lewrockwell.com/blog) explained the guesture: "The holding of hands by Saudi men ... means the person you are talking with is important to you and considers you important. You have each other's undivided attention. It is usually done during a

one-on-one conversation, or by someone who wants to get, keep and hold your attention while he is talking with someone else — 'Hold on a minute, you're next."

Wahhabism

Although both Bush and Abdullah agreed to once again share resources to fight terrorists last week, the Crown Prince presided over the arrest of 40 Pakistani Christians on the Friday before traveling to Crawford.

The Pakistanis' crime, according to Nina Shea, the director of Freedom House's Center for Religious Freedom, was "praying in a private home in the capital Riyadh in violation of the state's strictly enforced religious law that bans all non-Muslim worship."

Shea states in her recent National REVIEW column: "As the State Department has determined, there is no religious freedom in Saudi Arabia and everyone there, Muslim or not, must obey the rules of the extreme sharia of the kingdom's established religion, the Wahhabi interpretation of Islam.

The Saudi state indoctrinates its nationals from an early age in the Wahhabi ideology of zero tolerance for the 'other.' Government textbooks and publications teach that it is a religious obligation for Muslims to hate Christians and Jews and warn against imitating, befriending, or helping them in any way, or taking part in their festivi-

ties and celebrations.
She continues: "The state teaches a Nazi-like hatred for Jews, treats the forged Protocols of the Elders of Zion as historical fact, and avows that the Muslim's duty is to eliminate the state

Indeed, Sec. of State Condoleezza Rice nor the Bush administration's rhetoric for "democracy" around the globe has little room in Saudi Arabia since monarchy is "king" there, and women were not allowed to vote the week prior, even in that country's first national elections.

Summer Oil

Industry analysts say that U.S. gasoline prices will probably hover over \$2 per gallon through the summer. They also expect the oil compa-

nies to continue to perform well, due to energy demand's growth to outpace supply.

President Bush also suggested last week that oil refineries should be built on closed military bases to increase production.

Saudi Arabia said that by 2009, it will increase production to 12.5 million barrels a day from today's 11 million limit. Saudi Arabia now pumps about 9.5 million barrels daily.

Royal Dutch/Shell Group of Cos., BP Group PLC, Exxon Mobil Corp., and ChevronTexaco Corp. have earned a combined \$97 billion since the end of



Citizens Fight For Clean-Up **Of Toxic Towers**

NEW YORK CITY — Fallout from the 9/11 terrorist attacks continues to rain down on Lower Manhattan three and a half years after the World Trade Center Towers collapsed.

The Environmental Protection Agency, Lower Manhattan Development Corporation, and citizen advocacy groups here are still clashing on the removal of the toxic dust circulating in the area and on funds for research and treatment of people who will suffer from the effects of contamination years from now.

Variance Grievances

Activists said last Thursday night at the Community Board #1's committee on Lower Manhattan redevelopment that the LMDC's proposed variances for the asbestos abatement of the former Deutsche Bank building will make the demolition more hazardous to residents and

"The people from the LMDC would not give an inch, but they were sharply challenged in many regards," said Jonathan Bennett, New York Committee for Occupational Safety and Health. "Basically they are impervious to logic. I mean, all they really respect is power. If you have the power to make them do it right, they will do it right, but you can't persuade them to do it right no matter how dangerous or illogical what they are proposing is.'

Bennett, in a telephone interview with The Lone Star ICONOCLAST, said that the LMDC's variances that fit into its asbestos protection plan will not be sufficient to protect workers inside the Deutsche Bank building (130 Liberty) from a plethora of other toxic debris. Though the LMDC plans to seal off four floors of the building at a time to safely strip bare concrete and steel in a negativepressure atmosphere, its variance included using ex-

haust fans with filters that only trap asbestos particles.
"They (LMDC) just say, 'Well, we're assuming that asbestos is a surrogate for all the other contaminants.' We know they're not right about mercury, but the other things, there's no science behind it," Bennett said.

"If you were to protect yourself from mercury, you'd need an additional filter in your respirator," he said, noting that gas is the state mercury generally forms. "There are serious questions about whether the asbestos filter will protect people from dioxin and lead. There's no reason to assume that it will protect you from any of those things.

Another variance asks for contractors and their employees who belong to specialty trades to be allowed into the asbestos abatement area, even though they hold no licenses to handle asbestos. Under the law, everyone who

enters these areas must have an asbestos-awareness license and be respirator qualified, said Bennett.

"This is one of the biggest cities in the world. It makes no sense that they

couldn't find elevator constructors and others who are qualified, and if they're not qualified, they can get qualified. The licensing is not that difficult," he said. "And also the community will be safer if the workers are licensed because there's always the possibility someone is going to do something (by accident) inside the abatement."

Jenna Orkin LMDC also applied for a variance to use a shredder in the abatement area, saying doing so will increase workers' safety because it will make the demolished material easier to handle.

'When you're dealing with asbestos, the object is to keep it out of the air if possible," said Bennett. "Nobody we could find has said anything about using a shredder in an operation like this, but they want to do it.

Bennett said that judging from the variance requests, LDCM only wants to save money. "They're not essential. It's not like there's something about this building that makes it impossible for them to do it without getting the variance. It's just that they want to do it. We say that's not a good enough reason."

The variance package was sent to New York State Department of Labor earlier this month. Final action by the NYSDOL is to be taken this week.

'We've already moved them far off the dime. Their original plans were really dangerous," said Bennett. "Now, while never acknowledging that their plans were dangerous at all, they've made them a lot less dangerous. I think we're going to move them more still. It will never be the way we would do it, but it'll be a lot closer to it.'

The EPA Region 2 Communications Division and LMDC failed to return phone calls for interviews

Dust Devils

The EPA would be the lead governmental agency to oversee the clean up of the remaining three WTC-contaminated buildings, if the member organizations of the World Trade Center Community/Labor Coalition had their

The EPA is currently serving in an advisory role, making recommendations to the LMDC whose first demolition plan for 130 Liberty was returned to further strengthen environmental safeguards.

'The contaminated buildings are a clear and present danger. We are currently demanding every place we can that the EPA steps up to the plate and undertakes its responsibility under the EPA's own law and regs," said Kimberly Flynn, member of community advocacy group 9/11 Environmental Action.

Presidential Decision Directive #62 of 1998 states that the EPA's job is to handle contaminated areas from terrorist attacks

Had the EPA taken immediate action respiratory illnesses would have been prevented in hundreds of thousands of people from rescue workers at Ground Zero to residents of Brooklyn from the toxic cocktail of lead, asbestos, mercury, dioxin, PCBs and PAHs, argue Jenna Orkin, mother of a teenager who attended school four blocks away from the disaster.

"You have the synergistic effect of

these contaminants working together. Little is known about that, but for instance, if you're an asbestos worker and a smoker, it's not just twice as bad as being one or the other. It's 80 or 90 times as bad," said Orkin. "At Stuyvesant High School, where my son was a student, they not only had the World Trade Center site, but they also had the waste transfer

barge where all the debris was brought on their north doorstep, so they had it on both sides. No matter which way the wind was blowing, they got it, and the ventilation system (in the school) was only 10 percent effective (in capturing the toxic dust)."

The August 2003 EPA Inspector General's report revealed that the White House Council on Environmental Quality edited the EPA's press releases soon after the WTC's collapse to downplay the asbestos dangers and to reopen Wall Street. The IG Report also explained that EPA performed only limited cleanups of sites.

"We hold the White House responsible. This is well documented," said Flynn, in a telephone interview with THE LONE STAR ICONOCLAST, noting that then-EPA chair Christie Todd Whitman announced on Sept. 13, "EPA is greatly relieved to have learned that there appears to be no significant levels of asbestos dust in the air in New York City."

The EPA in fall 2002 during its volunteer indoor cleanup program for residents cleaned only 4,100 of the estimated 30,000 residences in certain areas. Cleaning for nonresidential buildings or businesses using public funds has not been available.

What is happening here is that instead of designing a program in the spirit of lessons learned to correct the earlier inadequacies of the testing and clean up, EPA is essentially making the same mistakes all over again," said Flvnn.

Grave Buildings

At the forefront of the clean up conflict are the three WTC-contaminated buildings near Ground Zero, each on different timetables for demolition. Two of the buildings are owned by local government bodies, while the other is privately owned.

"We say that the EPA should have overall authority over the demolition over all three buildings. We're not saying that EPA should do the demolition, but we're saying that he EPA should be in a position to enforce whatever standards that are agreed upon for the demolition for these buildings,' Bennett of NYCOSH. "We think that it shouldn't be a matter of a private company doing the work and the government agency coming in on the basis of a complaint or occasionally to make sure that it's being done right

The EPA has since doubled the cost of the bank building's demolition to \$90 million for more safeguards. The bank and its insurers, Allianz AG and Axa SA, have been asked to pay. The site is

slated to be cleared by 2009 for an \$11 billion office tower, memorial, and transit hub at the World Trade Center site.

"It's our position that because they (the buildings) have so much in common that there really should be a single protocol for dealing with preventing the workers and residents from the toxic materials in these buildings," said Jonathan Bennett, New York Committee for Occupational Safety and Health (NYCOSH), an advocacy group for worker safety. "We don't see any reason for why that particular thing should be invented three times."

The building at 4 Albany Street, owned by the Deutsche Bank, is in the process of having its interior excavated. Action on the second building Fiterman Hall, owned jointly by the City University of New York and the state Dormatory Authority, might take place as early as the fall of 2005.

The Lower Manhattan Development Corporation, the New York state agency overseeing Ground Zero redevelopment, is currently in talks with the EPA and the state to raze the former Deutsche Bank building at 130 Liberty this summer. The LMDC purchased this 40-story building — the most visible reminder of the terrorist attacks for \$90 million from Deutsche Bank last year with the sole intent to tear it down.

"It's the most toxic building in the

world. The LMDC is in way over their heads," said Flynn. "We believe they let the Duetche Bank off real easy.

A 15-story gash across the Deutsche Bank caused by fallen girders from the trade center's south tower has exposed the interior to dust containing asbestos, lead, dioxin, and rain that brought mold and bacteria. The Deutsche Bank is opened to the elements. A chain-mail type of material is currently draped over the bank building. Seven months ago, pieces of glass from a window crashed to the ground. No one was harmed because it happened on a low foot-traffic day — Sunday.

Advocates continue to encourage the LMDC and the EPA to hold more meetings with the various community groups, from First Responders and the Metro Transit Authority to parent/teacher organizations and labor unions, for the good of New York City. Flynn added that the winds on Lower Manhattan, which are strong enough to lift people off the ground, constantly help contaminate the area with toxic dust from the Duetche Bank building.

"There's a subway intake right there (by Ground Zero), so it's very likely that if there's a toxic release from the building, it's going to get sucked into the train," Flynn said. "The NYC subway system is ventilated solely by air being Continued On Next Page

pulled in as the trains run by. The trains act like a piston that drive air through the subway. The vent is under the building."

Also nearby are two residential buildings and the World Financial Center, home of Dow Jones & Company, Merrill Lynch & Company, and American Ex-

press Company.

"We are not the greatest admirers of what the EPA has done in Lower Manhattan, and it is a little odd of us to put so much faith in them, but they are the agency with the expertise," said Bennett. "They are the only agency capable of doing it right. We happen to keep our fingers crossed that if they take the responsibility, which they have yet to do, they will make sure that it gets done right."

Dangerous Precedent

Orkin pointed out that not only the way the federal, state, and local governments are handling the demolition of these "toxic towers" sets a dangerous precedent for cleanups of future terrorist attacks, but also the way the government allocates funds to recover the economic and physical health of communities and individuals.

Flynn stated that a portion of the \$2 billion community development block grant earmarked by Congress to respond to the ongoing impact of the disaster on people's lives, such as for job training programs and low income housing, is being used toward the demolition of 130 Liberty. She noted that about 500 firefighters had to retire because their lungs are shot, and they can't be exposed to more smoke and fire, and that neighborhoods like Chinatown with its renowned restaurants were a part of a frozen zone that forced laborers out of work.


"Everyone needs to understand that the heroes of Ground Zero are ailing, and the government for the most part has abandoned them," Flynn said. "And a large part of Chinatown's economic subsistence is restaurants, and what happens if Chinatown is frozen for two months? This is was the rolling impact of 9/11.

"Some 40 small garment factories shut down on Sept. 9/11 and never re-

opened, so at one point you had one-inthree low wage workers in Chinatown forced out of work. That meant people couldn't pay their rent. People lost their housing. I mean, this is the kind of situation that this community health block grant money was earmarked to respond to. The LMDC sat on it until now."

Flynn seemed optimistic by the actions of Michael Chertoff, new Homeland Security Czar, who toured the city with Mayor Michael R. Bloomberg (RNY), Senator Hilary Clifton (D-NY) and Congressman Jerrold Nadler (D-NY). Chertoff has said that the federal counter-terrorism money will be allocated in accordance with a risk based formula, which is good news for New Yorkers who have seen funds sent to Wyoming, a state receiving more per capita in funding than New York.

"It's a story Texans need to understand. People think that George Bush is the guy who can make us all more secure. Well, ask New York City how secure we feel in the aftermath of 9/11," said Flynn

New DVD On Ground Zero Contamination, 'Confronting The Evidence,' Being Distributed

SANTA BARBARA, Calif. — It isn't every day that the producers of a DVD encourage the public to copy and distribute their work, but this is the case with a new DVD entitled: "Confronting The Evidence — A Call To Reopen the 9-11 Investigation."

Over 250,000 copies of the DVD, which has been produced by "Reopen911.org, Walden3.org," are being distributed worldwide to schools, fire and police stations, libraries, New York businesses, and private individuals. The producers ask viewers to "see the true story of how the Bush Administration deceived America about Ground Zero air quality in this disturbing new DVD."

in this disturbing new DVD."

According to the producers, when President George W. Bush came to Ground Zero two days after the 9/11 attack, he urged everyone to shop. "Ironically, the expression – Shop Till You Drop

- would have been more appropriate. In fact, the raw truth about the air is that is was, as scientist Marjorie Clarke says, 'Equivalent to dozens of asbestos factories, incinerators and crematoria."

The White House Council on Environmental Quality changed EPA's press releases turning warnings of asbestos into reassurances, say the producers. "The EPA also said 'The air is safe to breathe' at the World Trade Center. This has seriously injured the health of Manhattan workers and residents. It is even killing some of the heroes who worked at Ground Zero."

In the DVD, testimony suggests that Christine Whitman, EPA administrator, and New York Mayor Rudy Giuliani lied to New Yorkers and visitors from around the world that there were "no significant problems."

"Shockingly and no consciousness of forethought, the New York City Dept of Health told residents to clean their apartments with a wet mop or wet rag," notes the DVD.

In "Confronting the Evidence," scientists Dr. Cate Jenkins, Dr. Marjorie Clarke, Paul Bartlett, and others say

they issued warnings about inhaling toxic dust and fumes, but were ignored by the agencies in charge.

Among the contaminants being spread from Ground Zero were these, according to the DVD:

- · 200,000 pounds of lead from 50,000 computers at WTC
- · Hundreds of tons of cancer-causing asbestos
- · Over 10,000 fluorescents, and each of which contained enough mercury to contaminate a quarter of a city block
- · Thousands of smoke detectors containing radioactive americium 241
- · The alkalinity of the air equivalent to that of Drano
- · Highest levels of vanadium ever recorded

It was noted that some rescue workers were not allowed to wear respirators on the ground that they might frighten the public and that insurance companies often refused to pay for cleanup on the grounds that the EPA said the air was safe

The DVD explains how some children in nearby schools have developed serious respiratory problems and half of those who cleaned ground zero have serious health problems.

"Confronting the Evidence" reveals that the man responsible for cover-up was previously an industry lawyer who represented major asbestos and toxic polluters, that hundreds of firefighters can no longer work, and that 15 rescue dogs have died.

And, says the DVD, "despite the studies which continue to point to the hazards of exposure to Ground Zero contaminants, neither the federal government nor New York City has yet cleaned up the

city's firehouses. One firefighter who did not join the department until after the World Trade Center fires had gone out has now been found to have new onset asthma attributable to exposure at his firehouse near Ground Zero.

"Plain and simply — extremely hazardous materials became airborne when the

World Trade Center disintegrated and thus posed a most serious health threat to people who live and work in the downtown area, not just Ground Zero."

The DVD explains that public trust in government has diminished as some workers and residents have become sick and required medical attention. Comprehensive, representative testing has yet to be performed in the area affected by the dust and fires of the disaster. Following a year of discussions with the World Trade Center Expert Technical Review Panel, the EPA is expected to release a new sampling plan within a few weeks. A preliminary plan submitted to a panel of outside technical experts was found wanting in several areas including quality control, number of contaminants to be studied and reliance on a 'signature' to determine the presence of World Trade Center dust.

Oil Company Profits Show Dramatic Increases While Gasoline Prices At The Pump Soar

IRVING, Texas — Exxon Mobil Corp., the world's largest publicly traded oil company that is based in Irving, posted a 44 percent profit gain during the first quarter of this year, as its net income jumped to \$7.86 billion, up from \$5.44 billion a year ago.

Royal Dutch/Shell Group also saw

increased profits, from \$4.33 billion a year ago to \$5.55 billion during the first

With the price of gasoline at the pump reaching record highs forcing consumers to adjust personal budgets or limit travel, oil companies claim that demand is rising faster than the supply, thereby allowing them to justify dramatic increases in the cost of the fuel they sell. Much of the increased de-

mand, they say, that is allowing them to reap record profits, is economic growth in Asia and North America that is tied to consumption of oil products.

They claim that the trend in rising prices appears to be solid, with no signs of abatement.

Combined net income at four of the biggest oil companies — Exxon Mobil, BP Plc, Shell, and ConocoPhillips — saw a rise of 39 percent during the first quarter.



House Okays Gay Marriage Ban Amendment

AUSTIN — The Texas House last Monday approved a proposal to ban same-sex marriages and civil unions through an amendment to the state constitution. The bill, as of last week, had no Senate sponsor.

Approved 101-29, the amendment won one more vote than the 100 necessary for approval of a constitutional amendment

The amendment, if approved by twothirds of the senators, will be put on the ballot next fall for voters.

Texas has a law against same-sex marriages, but the amendment's supporters said this new action will cut off potential courthouse battles over samesex unions.

Opponents argue that the amendment will support discrimination, not unlike that of African-American segregation when interracial marriages were deemed illegal.

The Senate two years ago approved a similar law prohibiting the recognition of same-sex unions from any other





Women Peace Activists Release Book About War

SAN FRANCISCO — CODEPINK: Women for Peace released a new book last Sunday, the two-year anniversary of President Bush's declared the Iraq war "mission accomplished." The authors are currently on a 50-city book tour, with CODEPINK chapters throughout the country supporting the tour by holding

town-hall style events, book release parties, and political actions.

The book entitled Stop The Next War Now: Effective Responses To Violence and Terrorism captures not only the expertise of policy makers but also the insights of those who have experienced the effects of war first hand.

More than 70 experts and activists contributed to this new collection of essays about how the global peace movement can successfully stop the next war. Edited by CODEPINK cofounders Medea Benjamin and Jodie Evans, with a forward by Alice Walker and an introduction by Arundhati Roy, the book offers a time-sensitive, poignant, and practical examination of the increasing world threat of more war and violence; and provides tools that range from changes we can make in our daily lives to ways we can rally the millions of people who support nonviolence to actually take action. Inner Ocean published the book.

A sampling of the essays includes those written by Congresswoman Barbara Lee on taking risks for peace, Nobel Peace Prize winner Wangari Maathai on preventing resource wars, journalist Helen Thomas on the responsibility of the media, writer Barbara Ehrenreich on feminism as a counterterrorism strategy, radio host Amy Goodman on the power of dissent, columnist Arianna Huffington on overcoming oil addiction, conscientious objector Camilo Mejia on dissent in the military, and Pakistan's Benazir Bhutto on ending poverty.

Before the Iraq war, CODEPINK encouraged women throughout the United States and the world to make the color pink synonymous with political rabble rousing. The group hung 40-foot pink banners with political slogans out hotel windows, handed out pink educational flyers at pink lemonade stands, and awarded pink slips (actual women's slips) to political and corporate leaders who were leading the US toward war. They yelled out questions during Donald Rumsfeld's testimony in Congress about torture at Abu Ghraib; chained themselves to the entrance of the Halliburton's shareholders meeting; and brought US military families to Iraq to meet Iraqi victims of US bombs.

For EPA To Come Clean

he first travesty of 9-11 is that it happened. The second is that the Environmental Protection Agency forgot its middle name

The third is that too many Americans remain convinced that the "official story" behind that tragic day is the truth. They have been told that to believe otherwise is unpatriotic. If one official story, such as WMDs were in Iraq, was a lie, another might also be.

While Iraqis and American soldiers are poisoned with silver bullets that pelt the dust of depleted uranium into the air, residents of New York City are facing another deadly hazard — toxins from the 9-11 attacks that the EPA has been steadfast to ignore. As the heros of Ground Zero and the residents of New York are struggling to survive the lingering plague of exposure, the federal government has all but abandoned them.

It has been three years since the World Trade Center towers were blown up, yet the EPA has chosen to take a back seat, apparently under orders from the White House, allowing the continued rain of fallout to ruin the health of thousands of New Yorkers.

Now that redevelopment of the targeted areas is planned, and demolition initiatives will again stir the particulates of asbestos and other cancer-causing agents, New York activist groups want the EPA to fulfill its true responsibility: protection of the environment and ultimately the populace that resides there, by finally doing the clean-up that should have been done immediately after the attacks and by seeing to it that redevelopment activities in those areas don't put residents at further risk.

The EPA dropped the ball immediately following the attacks by encouraging residents to believe that it was safe to breathe toxic dust. According to the August 2003 Inspector General's report, the White House Council on Environmental Quality edited the EPA's press releases soon after the WTC's collapse to downplay asbestos dangers and to reopen Wall Street, an act tantamount to their becoming accomplices in murder. Too, the report indicates that the EPA performed only limited cleanups of sites — only 4,100 of the estimated 30,000 residences in selected areas and ignoring nonresidential buildings.

Again, without the complete supervision and due diligence of the EPA, American citizens are poised to witness yet another example of privatization at work. Private companies given the leeway to profit from demolition and reconstruction will be free to cut environmental corners to save a buck. Profiteers will have to be assured there are no costs associated with cancer, birth defects, and chronic illness, and that the health of the citizens does not matter. It is a mindset that money in their pockets is more important than people.

Since three years of dancing the limbo proves that the federal government does not care, and simply wants 9/11 to be put to rest, the requirement now exists that the public demand the entire matter be looked into anew, from the attacks themselves, to how money dedicated to job training and low income housing was actually spent, to how many New Yorkers lost their jobs and homes while officials sat on money for aid, to a failed clean-up effort, and beyond.

Enough is enough. It's time the people got the answers they deserve — answers that break the bonds of a hidden agenda.

Rangers, Indians Wage War On Comanches

Texas Rangers and Indian allies in war paint crossed the Red River on April 29, 1858, in search of their common enemy — the Comanches.

The key to Hardin Runnels' surprising upset of Sam Houston in the election of 1857 was his pugnacious attitude toward the North and the Indians. While the new governor could not declare war on the Yankees, he was free to turn Rip Ford loose on the Comanches.

Ranger, soldier, newspaperman and politician, John Salmon Ford was also Texas' top Indian fighter. Eight years after ridding the Rio Grande of pesky raiders, he was asked to perform the same service along the Red River.

Putting Old Rip in charge of the state militia, Runnels empowered him to pick and choose a hundred experienced hands. His mission was to "follow any and all trails of hostile or suspected hostile Indians you many discover, and if possible, overtake and chastise them."

From the northwest frontier in February 1858, Ford reported that the bonechilling tales of terror and devastation were tragically true. In the wake of the This Week In Texas History

Comanche onslaught, entire communities were deserted and commerce was

at a complete standstill.

Ford realized his 102-man force would be no match for the Comanches on their home ground above the Red River. So he sought reinforcements from the most promising source, the Brazos Indian Reservation.

The 18,000 acres near the present town Graham was home to the weary remnants of the Caddo, Anadarko, Waco, and Tonkawa tribes. Though remarkably well-adjusted to life on the reservation, they were always eager to take revenge on their ancient nemesis, the Comanche

Strengthened by the addition of 113 Indian volunteers, the expedition cautiously crossed the Red River in late April. Ford took his time moving forward only after scouts gave the all-clear.

For 11 days the column advanced into Comanche territory without finding a trace of its quarry. Many of the Texans, who questioned the wisdom of Ford's decision to bring along the braves, wondered if the Indians were leading them on a wild goose chase.

Then on May 11 the Tonkawa scouts spotted a small hunting party homeward bound with a fresh kill. With the main body following at a discreet distance, the Comanches led them right to their camp.

After a tense and sleepless night, Ford unleashed a dawn attack. The handful of Comanches never had a chance, but in the confusion two somehow slipped away to sound the alarm.

In a flash the entire detachment was in hot pursuit. Three miles later, they galloped headlong into the waiting band of Comanches.

The heads of the autonomous tribes waved off the Texans and closed ranks to confront their old adversary. There on the hilltop, his distinctive metal breastplate shining brightly in the morning sun, was none other than the infamous Iron Jacket.

Ford and his Rangers felt strangely out of place, witnesses to a timeless ritual no white man was ever meant to see. They watched in reverent fascination as the horsemen formed two lines for the latest act in the centuries old

A half dozen reservation Indians raised their rifles and fired a deadly volley knocking the Comanche chieftain's horse out from under him. Iron Jacket scrambled to his feet only to take the second barrage squarely in the chest.

The loss of their invincible leader momentarily dazed the Comanches. Before they came to their senses, the

Brazos brigade was upon them and the battle began in merciless earnest.

The Indians fought to the death in the traditional style of single combat. The hit-and-run, one-on-one contests soon covered 20 square miles.


Ford held the restless Rangers in check until, as he later noted in his official account, "Our red allies sent up a wild shout of triumph." Only then did he release the Texans to help finish off the

Those that got away were not content to escape with their lives. Determined to reclaim their warrior dignity, they regrouped for a final face-off.

Prancing back and forth on their blood-stained ponies, the Comanches taunted their reservation rivals in hope of provoking a rash reaction. On this occasion, Ford ordered the white troops into position and to his relief the Comanches withdrew.

That night the comrades-in-arms celebrated their respective victories. The Texans took satisfaction in teaching the renegades that their northern stronghold was no longer safe from attack. But for the Indian fighters, the defeat of the hated Comanches meant they could return to the reservation with heads held



Today's Word — *Hubris*

I've picked up the term "hubris" from watching on of television's great dramatic series, *Law & Order*.

When are the news media going to ask the President of the United States some real hardball questions?


