

Memogate Hearings Scheduled For Tomorrow

WASHINGTON, D.C. — Rep. John Conyers, Jr., Ranking Member of House Judiciary Committee, and other Democratic members will hold on Thursday, June 16, a Democratic hearing to hear testimony concerning the Downing Street Minutes and the efforts to cook the books on pre-war intelligence.

On May 1, a Sunday London Times article disclosed the details of a classified memo, also known as the Downing Street Minutes, recounting the minutes of a July 2002 meeting of Prime Minister Tony Blair that describes an American President already committed to going to war in the summer of 2002, despite contrary assertions to the public and the Congress. The minutes also describe apparent efforts by the Administration to manipulate intelligence data to justify the war.

The June 16 hearing will attempt to answer the serious constitutional questions raised by these revelations and will further investigate Administration's actions in the lead up to war with new documents that further corroborate the Downing Street memo.

Those expected to testify include Joe Wilson, Former Ambassador and WMD Expert; Ray McGovern, 27-year CIA analyst who prepared regular Presidential briefings during the Reagan administration; Cindy Sheehan, mother of a fallen American soldier; and John Bonifaz, renowned constitutional lawyer co-founder AfterDowningStreet.org.

Directly following the hearing, Rep. Conyers, members of Congress, and concerned citizens plan to hand deliver to the White House the petition and signatures of over a half million Americans that have joined Rep. Conyers in demanding that President Bush answer questions about his secret plan for the

AfterDowningStreet.org is a rapidly growing coalition of veterans' groups, peace groups, and political activist groups, which launched on May 26, a campaign to urge the U.S. Congress to begin a formal investigation into whether President Bush has committed impeachable offenses in connection with the Iraq war.

Energy-Wars: Return of the Navajo

Navajo Nation Bans Mining, Processing Of Uranium On Navajo Land

CRAWFORD — Indians still exist, but more importantly, they're flexing their muscles.

The U.S. energy industry suffered a blow in late April when Navajo Nation President Joe Shirley, Jr. signed the Diné Natural Resources Protection Act which bans the mining and processing of uranium on Navajo land as well as reenforces the sovereignty of the Navajo people.

The DNRPA is designed to protect the water resources of the Navajo Nation, as well as the health of its citizens, 15,000 of whom are residents in the Church Rock-Crownpoint region of New Mexico.

"I don't want to subject any more of my people to exposure to uranium and the cancers that it causes," Shirley said during the signing ceremony before about 50 people who had gathered in the Crownpoint Chapter House.

"As long as there are no answers to cancer, we shouldn't have uranium mining on the Navajo Nation," he added. "I believe the powers that be committed genocide on Navajo land by allowing uranium."

President Shirley was referring to over half a century of unexplained cancers and other health effects due to his people mining the radioactive ore on their land for the energy industry, as well as for U.S. government's nuclear weapons arsenal.

Despite the few Navajo who stood to gain income from the mining of their land allotments where ore is located, the reservation has overwhelmingly supported the Act. The Navajo Tribal Council, in fact, voted 63-19 on April 19 to approve the prohibition, sponsored by George Arthur (Burnham/San Juan/Nenahnezad), chairman of the Resources Committee.

"Members of these communities have already given enough lives to the uranium industry. New mining, whether it be conventional or ISL, would likely devastate a new generation of Navajo citizens," said New Mexico Environmental Law Center Staff Attorney Eric Jantz in a written statement.

"Dozens of communities have passed resolutions declaring their opposition to new uranium mining, and thousands of Navajo have signed petitions against new mines," he continued. "We and our clients applaud the Navajo Tribal Council for exercising its inherent sovereignty to protect its valuable resources and the health of its citizens."

Officials for Hydro Resources Inc. cried unfair for not receiving as much face-time as the Eastern Navajo Diné Against Uranium Mining to explain the

mining process with the Council. However, HRI has tried to gain federal permits for the last decade to begin in-situ leach uranium mining southwest and east of Crownpoint and uranium processing north of the defunct United Nuclear Corporation's uranium mill.

Activists said that saving the quality of their drinking water and air is more important than the price of uranium, which has more than doubled over the past two years, from less than \$10 per pound to over \$23 per pound. HCI is a subsidiary of Dallas-based Uranium Resources Inc.

The Law Center added that this victory is significant because earlier this year the Nuclear Regulatory Commission okayed HRI's license for the first of its four proposed mine sites around Church Rock and Crownpoint.

That being said, HCI might still challenge in federal court the right to mine on allotments on the grounds of the defi-

nition and scope of what constitutes Navajo land.

Human Experimentation

The Navajo ban of uranium mining has both important social and historical significance as well, because for over 80 years, Navajo miners and their communities have suffered the effects of radiation poisoning under close watch of the U.S. government.

Since 1920, the tribe prior to exposure to uranium radiation was also exposed to radium from mining the ore on their reservation. Four inactive uranium mill sites and over 1,200 abandoned uranium mines are on the reservation. Most of these mines are unreclaimed.

The largest quantities of uranium were mined in the Four Corners area where New Mexico, Arizona, Colorado, and Utah converge. The Navajo reservation itself is equal to the size of West Virginia and home to 275,000 of the 350,000 people scattered around the

world.

According to Diné (the name of the Navajo people use for themselves) linguists, uranium is known as "leetso" — meaning yellow brown or yellow dirt. From this dirt, the first atomic bombs were developed at the secret Manhattan project in Los Alamos, N.M., and tested at the Trinity Site at Alamogordo, N.M. The Diné mined more than 13 million tons of uranium ore from their land to the U.S. between 1945-1988, according to Jaime Chavez, organizer for the Water Information Network.

"During the 1940s-80s, there were a lot of open pit uranium mines and a huge flux of cancers happening. The widows were coming together saying, 'What's going on?' They made the connection that all the husbands had worked in the uranium mine, and sure enough, they were," said Lori Goodman, treasurer of the nonprofit, activist group Diné Citi

zens Against Ruining Our Environment (CARE).

As more and more miners came forward with their stories, Goodman said, the U.S Congress passed the Radiation Compensation Act in 1990. Under this Act, the U.S. government was supposed to compensate individuals with diseases from exposure to radiation connected with the federal government's nuclear weapons testing program. The Act was also designed to compensate the medical costs attributed to the lung cancers of Navajo uranium miners exposed to radiation on the job in Arizona, Colorado, New Mexico, Utah, or Wyoming from 1947 to 1971. <www.eh.doe.gov/ ohre/>

"We all thought it was taken care of, but we were also seeing that our elders who were never uranium miners were also dying of the same cancers as the uranium miners. They lived off the land. We were asking questions of the public health officials. We were going into communities, and what came out was that the uranium miners were supposed to get compensated, and they weren't. At that point, politics took over," said Goodman.

The Act, it was found, discriminated against the very people it was trying to help. For instance, Goodman said, "laws said that you have to have a marriage certificate in order to be eligible to receive this compensation, and our people back then had traditional marriages. They didn't have marriage licenses. They were being eliminated right there, and there were questions of cultural significance to smoking. The government officials would ask them, 'Do you smoke?' And without the proper interpretation, it was taken as they were smoking cigarettes when in fact the miners were talking about ceremonial smoke that you don't inhale. It's done once or three times a month. So they were automatically eliminated, put off the record.'

As a result of community activism, Senator Orrin Hatch (R-Utah) introduced an amendment of 1990 RECA, S.1515., in 2000, that added the mill workers who processed the ore to the qualification list; expanded the diseases, which were mostly cancer and respiratory illnesses; and expanded the geographic coverage for "downwinder claims." The bill also lowered the radiation exposure thresholds for eligibility for more individuals on the reservation.

Unfortunately, the RECA 2000 bill President Clinton signed was an unfunded mandate. Uranium miners were given IOUs, the RECA Trust Fund was empty, and RECA regulations were not written on time. No one so far has been compensated under 2000 RECA, even after a lawsuit was filed against U.S. Attorney General John Ashcroft which charged that the Department of Justice failed its obligation to implement RECA regulations within 180 days of the amendment's enactment.

Shockwaves ran through the Navajo reservation again when in February 1995, the Department of Energy's Office of Human Radiation Experiments published Human Radiation Experiments: The Department of Energy Roadmap to the Story and Records. The Roadmap exposed the U.S. government's role in conducting and sponsoring Cold War human radiation

experiments, some of which included Navajo uranium miners.

"They would find out how long it would take these miners to get cancer and then from that point in time find out long they would die," said Goodman, referring to the U.S. government. "At the same time the government was telling us that they didn't know that radiation was harmful, so they were blameless was what they were trying to say."

2005 Energy Bill

"As soon as President Bush came into power, he wanted to start uranium mines again, and in fact with his first energy bill, he had \$30 million for energy companies to start uranium mining again. It's in this one again," said Goodman referring to latest energy bill drafted by House Energy Committee Chairman Joe Barton (R-Texas).

Goodman referred to the House energy bill as the "dark side" version, "with every tax credit for industry, every restriction on environmental protection, every means possible to make it possible to extract energy resources—no matter what the people think or what the impacts might be."

Goodman noted that the Senate energy bill, which hit the floor this Monday, is "less destructive than the House version;" however, both the Senate and House bills, she said, contain similar socalled "Indian energy" sections. "They try to encourage energy production on Indian lands by getting the tribal governments to develop their own sets of rules. Then the Bureau of Indian Affairs (BIA) can just rubber stamp approval of individual projects that are developed under those rules. It will make it harder for communities, groups or individuals to challenge decisions under federal environmental and cultural protection

As one lawyer used by Diné CARE noted in an email to The Lone Star Iconoclast, "In addition, Title V of H.R. 6 could remove the application of federal laws, such as NEPA and the Na-

tional Historic Preservation Act, from energy development decisions on tribal lands

"The bill affects land both on and off reservation. It provides that once the Secretary of the Interior approves a tribal energy resource agreement providing a process for making energy development decisions, individual energy projects would proceed without federal approval," he continues. "Since no federal action would occur, the existing guarantees of environmental review and public participation under NEPA would be lost. Concerned tribal community members and communities adjacent to the project would lose the mechanism that they have now to make their voices heard.3

In other words, the Bush Administration is moving lock-step with the philosophies of globalization and the free market by removing any and all governmental regulations and safeguards that protect the community interests, agreed Goodman. When asked if she thought it would be fair to compare the plight of the Navajo with its uranium mines to the Venezuelans with their oil reserves with regard to U.S. foreign policy, Goodman said, "That is very accurate. We all remember how U.S. removed (President Hugo) Chavez. But the community united brought Chavez back."

Goodman added that a few tax credits for building renewable energy production are included in the House bill, but both versions fail "to emphasize energy conservation as a way to increase our 'security' or 'energy independence.' Everything is focused on producing more energy."

Joan Claybrook, Public Citizen President, responding to the House Energy and Commerce Committee's draft energy legislation in a statement, said, "(This bill) offers more of the same failed proposals that have doomed energy legislation in the past two Congresses. It showers nuclear and oil companies with subsidies, gives pollut-

ers a break from protecting the environment and promotes further electricity deregulation while doing nothing to protect consumers from high energy prices."

Claybrook noted that oil prices continue to soar despite Congress passing a billion-dollar subsidy in October 2004 to encourage more domestic energy production and its March 16 budget vote to open Alaska's Arctic National Wild-life Refuge to oil drilling. "You would think that such a radical change in federal oil production policy (the successful Senate vote represented the first time in 24 years that the Senate has approved the measure) would send a clear signal to oil traders in New York," she said. "But the prices of oil and gasoline have only skyrocketed since the vote, raising doubts about the claim by the Bush administration and Congress that giving energy producers what they want will somehow lower prices for consumers."

Coal Plants

There will be a potluck and rally on this Saturday, June 18, at Shiprock Park in Shiprock to help stop the proposed Desert Rock Power Plant in the Four Corners area

According to Diné CARE in a letter to the editor of The Albuquerque Tribune, three Navajo chapters (Burnham, Sanostee and Two Grey Hills) have passed community resolutions directly opposing the plant. Other chapters (Newcomb and Sheep Springs) are making motions to officially oppose it as well, the letter said, jointly written by Anna Marie Frazier, Diné CARE Coordinator, and Sarah Jane White, Dooda (No) Desert Rock Committee President (Burnham/Sanostee Chapters).

"All but one of the local communities oppose the power plant. Our people living in this area suffer rates of asthma, reproductive disorders, cancer and other illnesses that are far in excess of national averages," said the letter. "Do you really imagine the communities are going to vote for more pollution and its associated destruction?"

Proposed by Sithe Global, LCC, of Houston, Desert Rock is a coal-fired plant that would emit 3,400 tons of mercury and ozone into the air. The plant is planned to use a hybrid dry cooled coal-fired electric power-generating technology, south of Farmington in northwestern New Mexico. The project development agreement was entered into with Diné Power Authority (DPA), an enterprise of the Navajo Nation.

The Navajo, however, are expected to not see one watt of energy from this plant due to the agreement, although 80 percent of the tribal revenue comes from coal royalties and tax. About one billion ton of coal reserves are within the tribal lands. Two coal fired power plants (Four Corners and Page) and three mines (Peabody, BHP, and PNM). Total permitted for mining is 95,724 acres and total disturbed is 16,767 acres.

Goodman said that probably 30 percent of Navajo don't even have electricity. Their primary source is wood and also some use coal. The Navajo people are not so reliant on these plants for jobs either, she said.

"I wouldn't say very much. I mean, I have nine brothers and sisters. None of them work for any energy company on

Navajo land. There aren't that many jobs. Peabody Coal Company has 50 employees," she said. "When you factor in how much is the community benefitting. Are we getting any return? When you factor those in, those 50 people that work there, that's nothing because all the energy goes off the reservation.

There are two other power plants already in the area from which the Navajo people have received negative health consequences. Goodman said that 40 years ago when the Four Corners Power Plant, which is one of the biggest polluters, Peabody failed to live up to its promises to make life easier for the people.

"They were saying that if you move, we'll build you a new house. 'We'll make sure you have electricity and water in your homes,' Goodman said. "Well, 40 years later, they are still living the same way they did, and so the community is saying, 'Hey, we're not going to be fooled the second time around."

Goodman added that the landscape is a bit ironic: the Navajo homes, many of which use solar power panels, are located right next to the transmission lines leading from the plant. "It's really quite the picture — families with no electricity and no running water, and they have just one panel of solar that they use and in the background are these huge shovels and drag lines coming toward their homes. That's the picture," she said.

A draft of the environmental statement has yet to be released, probably at the end of the summer or the fall, said Goodman. "They are planning that it will all go through, and they'll start to build in 2006, and the plant will be in operation in 2008."

In The Name Of Sovereignty

When asked of the other challenges facing the Navajo people, Goodman said, "It's funny you should ask. It's like an energy war happening here now. With Bush and with Chaney's secret meeting with the energy cartel, they've sliced up Indian lands here. It's very interesting in who all is investing in these projects."

The U.S. government under the Bush administration, as well as the U.S. energy industry, has changed its tactics and language to compel the Navajo and other Native Americans to secure natural resources from their native lands. "Now they are talking about giving in the name of sovereignty: 'We want the Indian people to decide for themselves. We want them to make their own environmental laws,' said Goodman. "It is like they only recognize our sovereignty when they put toxic waste on our lands,

and then when we go out to fish and hunt for ourselves then our sovereignty is not recognized. In the name of sovereignty they put in the Four Corners Power Plant."

"Once you turn it over to the Indian people, then the federal government can't come in," she added. "It allows the energy companies to come in and just wreck the place, and we can't make them clean up. They won't clean up. It's not in the name of self-determination. It really is termination. They don't want to be responsible and at the same time, the time is right for the companies to come in and rape the land with no legal recourse. They are not responsible."

Goodman said that the healthcare costs for treating the symptoms of air and water pollution are "killing us." In Shiprock, N.M., there are two power plants nearby. "Shiprock is sort of like in a bowl, and the pollution just hangs there. The asthma and upper respiratory problems are sky high," she said. "They're taking the healthcare monies and giving it to the corporations to poison us to death," she said.

This past March, the Republicans de-

This past March, the Republicans defeated \$1 billion for Indian health, housing and education, Goodman said. The Navajo Nation's Indian Health Service

is currently 55 percent funded and the vacancy rate of doctors and nurses is 20 percent, she added.

"We live in scary times, just because for an administration that really harps on Christian values that's certainly not reserved for all people, they have no knowledge of history — nuclear testing again — and that is scary," she said.

Goodman said she doesn't know if the tribal government can stand up to the multinational corporations or the U.S. government because "they have to be thinking about not pissing them off." However, she still has hope.

"It's going to take citizen activism to fight off the energy companies, and people have done that before and they are ready to do it again. It has to be done because what we learned from doing the RECA, it's only shame in the eyes of the world is what makes them back off, so there's a need to be as public as possible for what's taken place," she said.

"We had some major projects that we've accomplished that gives me hope. What it really is is that they don't really know what we're going to do. They're so set in what people with money do to protect themselves that they don't know what people without money do."

Goodman said that Diné CARE is con-

tinuing to build coalitions working on similar issues with Anglo activists like the San Juan Citizens Alliance. "We understand that race is always used to divide us," she said.

"We've learned something from working in the uranium mines. Right now we have asthma. We're not willing to project all that garbage on our children. No way. It's the stand people are making right now," she added.

Free Press:

Take Action To Keep Municipal Broadband Services In U.S.

CRAWFORD — U.S. Rep. Pete Sessions (R-Texas), a former telephone company executive, has introduced a bill (HR 2726) that would let cable and telecom companies shut down municipal and community efforts to offer broadband services.

The act, called the "Preserving Innovation in Telecom Act of 2005," take away the right of cities and towns across the country to provide citizens with universal, low-cost Internet access.

"Giant cable and telephone companies don't want any competition — which might actually force them to offer lower prices, higher speeds and service to rural and urban areas," said a statement released by Free Press.

Companies like SBC, Verizon and Comcast have been introducing laws state by state that would prohibit municipal broadband, undercut local control and prevent competition. "But we've been fighting back — and winning," said Josh Silver, executive director of Free Press.

An alliance of public interest groups, local officials, high-tech innovators and organized citizens have defeated anti-municipal broadband measures in nine of the 13 states where they've been introduced this

What the industry couldn't pass in the states, they're trying to push through in Washington. Sessions' bill — the "Preserving Innovation in Telecom Act" — would prevent state and local governments from providing "any telecommunications service, information service or cable service" anywhere a corporation offers a similar service.

Congressman Sessions worked for telephone giant SBC for 16 years, and his wife currently serves as a director of Cingular Wireless, an SBC subsidiary. SBC and its employees have been Sessions' second-biggest career patron, pouring more than \$75,000 into his campaign coffers.

"We can stop this legislation and send a clear message to Congress that local communities — not the giant telephone and cable companies — should determine their own communications needs. But you must act now," said Silver.







Supreme Court Plays HMO With Medical Marijuana

orget the use of an effective drug to relieve suffering.

Forget that it was prescribed by a medical doctor.

Forget the agony of a patient.

Forget science.

Forget common sense.

Politics, commerce, and an evolutionary venture back into the trees are more important, at least to President Bush and his cronies in Washington.

The Supreme Court, at Bush's bidding, last week ruled that Federal authorities may prosecute sick people who smoke

marijuana on doctors' orders to alleviate pain. The Court concluded that 10 states' medical marijuana laws do not protect users from a Federal ban on the drug, even though the drug's distribution does not involve interstate commerce that crosses state borders.

At issue was an appeal by the Bush Administraon whether California's medical marijuana law, passed by voters in 1996, that allows people to grow, smoke, or obtain marijuana for

medical needs with a doctor's recommendation, would hold water on a Federal level.

Several states have laws similar to California's, including Alaska, Colorado, Hawaii, Maine, Montana, Nevada, Oregon, Vermont, and Washington state, where patients with serious illnesses can be prescribed marijuana for ease of pain.

The Court ruled that, although some states allow it, the Federal government deems it a Federal crime to grow small amounts of marijuana in one's own home for one's own medical use. The reasoning behind the ruling was that it interfers with the Controlled Substances Act that prevents the culti-

vation and possession of marijuana, even for medicinal use.

The case was established after the Drug Enforcement Agency in 2001 began raids against patients using the drug in California. Among those arrested was Angel Raich, who has brain cancer, and Diane Monson, who has chronic back pain. They were authorized to use limited amounts of the drug to relieve suffering. The case focused on them.

Although a Federal appeals court decided that the use of

medical marijuana was non-commercial, lawyers for the U.S. Justice Department disagreed, saying that homegrown marijuana represented interstate commerce, as the homegrown variety would affect "overall production," since much is imported across American borders.

"The trafficking of drugs finances the work of terror, sustaining terrorists," said President Bush in 2001.

Of course, pharmaceutical corporations do not make a penny off drugs raised in one's patio garden, nor do they profit on many natural health foods. Is there a hidden agenda here?

The anti-drug laws are big business. We spend billions on

prison construction, law enforcement, anti-drug propaganda, inderdiction, judges, lawyers and courts. The drug trade itself makes billions for our allies. The new Afghan government, for example, would collapse without the heroin trade. A realistic approach to drug use and abuse in this country would cost the rank-andfile of the Mexican government its largest source of revenue: bribery

If the concern that some of the marijuana might end up in the hands of

those who are not medical patients is an issue with the Supreme Court, then why not just go ahead and outlaw all drugs, for that might happen with any of them.

And for that matter, why not go ahead and outlaw food, for you never know when someone might eat one hamburger too many and get fat.

While you are at it, let's outlaw water. You never know for sure what's in it.

The bottom line is that Bush is spending his "electoral collateral" to buy America away from the people and give it to the international corporate machines. With his anti-Christian, anti-ethical philosophies, public trusts are vanishing, as are rights. And, overall, many citizens simply do "not see" what's happening to them...yet.

Public approval of President Bush's handling of the conflict in Iraq has dropped to its lowest point with growing fears that the United States is bogged down and rising criticism of Bush's handling of the prison abuse scandal, according to the latest Washington Post-ABC News

Army Recruitment Goals Down For 4th Straight Month

WASHINGTON — Army boot camps are just 46 percent full, according to the Pentagon, as the number of new recruits continues to be sluggish. Recruitment goals have not been met for four consecutive months, but the Army hopes the military manpower crisis will improve this summer.

To improve the odds at reaching the sought-after 10,000 recruits a month this summer, the Army has added 500 active-duty recruiters and is pondering asking Congress to increase the enlistment bonus from \$20,000 to \$40,000, while also raising the age limit for active-duty service from 35 to 40.

So far this fiscal year, the short-fall of recruits is 8,321. The goal for the year is 80,000 enlistees, with 40,964 having signed on in eight months.

U.S. PATRIOT Act Hearing Gets Dirty As GOP Chairman Walks Out

WASHINGTON — President Bush's push to have certain segments of the U.S. PATRIOT Act renewed was met with heated debate Friday, resulting in House Judiciary Committee Chairman Rep. James Sensenbrenner (R-Wis.)

abruptly ending the meeting and walking out.

UP IN SMOKE

The co-author of the Act, which has segments poised to expire in September, departed during a protest by Rep. Jerrold Nadler (D-NY), who raised his

voice after his microphone went off.

"We are not besmirtching the honor of the United States. We are trying to uphold it," commented Nadler, who noted that Sensenbrenner was rude, "cutting everybody off in mid-sentence with an attitude of total hostility."

Immediately after Sensenbrenner's departure, James Zogby, president of the Arab American Institute, said, "I'm troubled about what kind of lesson this gives" to the rest of the world.

Anslinger has the dubious honor of being nicknamed, "The Father of the Drug War."

In 1930, Treasury Secretary Andrew W. Mellon (yes, of the Mellon Bank and founder of Gulf Oil Corporation) appointed Anslinger head of the new Federal Bureau of Narcotics. Harry got the job because he was engaged to Mellon's niece.

Coincidentally, Anslinger was known to one William Randolph Hearst, the publishing giant who swayed American opinion with whatever his "news" papers decided to print - truth be damned.

Hemp had been a major crop in the original 13 Colonies. Growers included George Washington and Thomas Jefferson. They were but two of many early Americans who realized the many uses of this rich fibrous plant. A 1794 quote from Washington goes, "Make the most you can of the Indian Hemp Seed and

If around today, these two original Patriots and countless other Founding Fathers would be Bubbas' sweethearts while rotting in prisons for felony crimes of

humor show called "The Firesign Theatre" arose in Southern California. This theatre-of-the-mind brainchild of Philip Austin: Peter Bergman: David Ossman: and, Philip Proctor, expanded to records, video and live performances. We couldn't get enough of them, listening in barracks and college dorms.

One of their more popular albums is "Everything You Know Is Wrong," which debunks pretty much everything we've ever been taught growing up in America. One bit is a parody of those awful blackand-white 16mm educational films we were shown in the 1950s. You know, the ones with little or no truth as depicted by hammy re-enactment actors.

Anyway, this "film" depicts our Forefathers gathering at Ye Olde Hashfire Inn where they "got smoked like Boston scrod." They had figured out some of the ulterior benefits of hemp, it was a hot summer, and they weren't gonna take any more garbage from the King. So they decided to start a revolution.

Much as their Hippie beneficiaries tried 200 years later.

By the way, the four Firesign guys are still around today, often on PBS, the net-work the Republicans would like to censor completely off the air. And my son loves their stuff

It was long known that many items, such as rope, textiles, linens, damask tablecloths, canvas (actually derived from the word cannabis) – literally thousands of everyday items - could be made from hemp fiber. One estimate is 25,000 common products! The benefits from hemp fibers and stalks included superior paper and wood products, as well as a variety of oils for myriad uses from cooking (with high protein yield) to mechanical applications.

I'm not even remotely qualified to attempt to breach the plethora of medicinal uses for cannabis.

From what I've read, one acre of hemp will produce as much fiber as two to three acres of cotton, and it's stronger and softer. Hemp is frost tolerant, thus it will grow in any state, not just the warmer South.

It would take two to four acres of trees for paper to grow an equivalent amount of hemp on one acre; trees take years to grow, hemp takes months.

The fact is, hemp was a completely legal cash crop in the United States until the Anslinger/Hearst/DuPont Triumvirate of Greed and Racism came along.

A number of events came together in the early 1930s to give these three putzes the opening they needed to destroy an entire industry just as it was about to make major advances – while wholly demonizing a medicinally viable plant and agreeably safer substitute for alcoholic consumables.

First, there was a large influx of Mexican and Filipino workers. They actually smoked the hemp, because they knew what portion of the plant was potent. Before these people came along, nobody was familiar with the term "marijuana.

Then, there was the increasing popularity, especially among the teens and young adults, of jazz music. In what part of the population were jazz musicians predominantly found? Negroes. And word was that jazz musicians could not play that

"debil" music without being doped up on marijuana first.

Here's the simplified version of the Demonization of Cannabis:

When Anslinger took control of the Federal Bureau of Narcotics, there weren't a lot of narcotics to be bureaucratic about. William Randolph Hearst not only owned the newspapers, he also owned the forests. And Willie detested Mexicans because he had lost a huge chunk of forestland to a foray by Pancho Villa in the early part of the 20th Century.

So, Anslinger and Willie put together stories that had no basis in fact and ran them in Hearst papers across the country. (Legend has it they personally wrote the preponderance of these fictitious exposés, but that would be difficult to prove.)

Anslinger was the first person to really make "marijuana" part of the American lexicon. In doing so, he was able to give hemp that Satanic vilification that was necessary to make it dreaded throughout middle America. The Anslinger/Hearst fables were filled with unsubstantiated tales of woe: Young girls turned to prostitution for marijuana; teen boys gone insane after just one joint; church-going youths committing armed robberies and murder to get their marijuana fixes; suicides caused by marijuana withdrawal; hopped up young white women consorting with Negro men; the destruction of all American values caused by the Devil's weed.

With surreptitious backing from unnamed sources, sensationalistic movies such as "Marijuana: Weed With Roots in Hell," "Assassin of Youth," and "Tell Your Children" (known today infamously as "Reefer Madness") purported to tell the true story of marijuana abuse. In reality, there was nary a shred of truth in any of

This was a well-orchestrated campaign to obliterate the hemp industry by repeated headlines in Hearst papers about the "powerful narcotic" and its direct line to "MURDER! INSANITY! DEATH!"

Herr Karl Rove and George W. Bush must have studied up on this technique. On May 24 Dubya was touting his Social Security scam for the ultra rich big biz types to get richer in front of a typically hand-selected, blindly allegiant audience. While his handlers weren't near enough to shut him up and the cameras were rolling, Dubya actually said, "See, in my line of work you got to keep repeating things over and over and over again for the truth to sink in, to kind of catapult to propaganda."

Dubya snorted his arrogant frat-boy snicker as he said that, like look at what a good BS artist I am. And the true believers actually applauded him! I'm sure Der Karl and Miz Laura were neither smiling nor applauding. Never veer from the script, Georgie.

Back to the 1930s... The DuPont Chemical Corporation fit into the mix as the big bully in the newly emerging industry of being able to fabricate all sorts of neat stuff from literally nothing. They already held patents worth billions on synthetic petrochemicals, wood pulp paper, lead gasoline additives, synthetic fibers, and plastics – all materials that could be made naturally using hemp.

DuPont wanted no competition from a fibrous plant of limitless versatility that can be grown virtually anywhere, by practically anyone, at essentially no cost, using nothing but sun and water.

Around 1935 Anslinger began a two-year effort contriving a bill and tax law to run through Congress. In 1937, new technologies came to the fore to make harvesting hemp a more practical and profitable venture, as noted in a Popular Mechanics Maga-

ZINE article, "New Billion-Dollar Crop."

Anslinger countered with an article he co-authored in The American Magazine (July, 1937), a diatribe of tales of the evil results of marijuana addiction, completely lacking in factual detail, names, dates, or any specific witness or court records.

In 1937, with the assistance of oil tycoon, and former Spindletop oil field business partner of Mellon, Joseph Guffey, a member of one of the Congressional subcommittees, Anslinger brought his "findings" to Capitol Hill. Here are some of the comments he made to sway Congress at what amounted to secret hearings:

"How many murders, suicides, robberies, criminal assaults, holdups, burglaries and deeds of maniacal insanity it causes each year, especially among the young, can only be conjectured... No one knows, when he places a marijuana cigarette to his lips, whether he will become a joyous reveler in a musical heaven, a mad insensate, a calm philosopher, or a murderer... The operative word here is *conjectured*, because all Anslinger ever did was guess at what someone smoking reefer might do; the same way the Bush Regime and the Supremes conjectured that "unscrupulous doctors" would pass out pot prescriptions like candy.

"There are 100,000 total marijuana smokers in the U.S., and most are Negroes, Hispanics, Filipinos, and entertainers. Their Satanic music, jazz, and swing, result from marijuana use. This marijuana causes white women to seek sexual relations with Negroes, entertainers, and any others."

...the primary reason to outlaw marijuana is its effect on the degenerate races.'

"Marijuana is taken by... musicians. And I'm not speaking about good musicians, but the jazz type..

"Marijuana is an addictive drug which produces in its users insanity, criminality

'You smoke a joint and you're likely to kill your brother."

"Marijuana is the most violence-causing drug in the history of mankind.'

Any knowledgeable person or interested organization that would have denounced Anslinger's comments was not notified of the hearings. The American Medical Association was only given two days' notice, hardly enough time to prepare, and its opposition went unheeded. In fact, one of Anslinger's staff said the AMA was okay with his findings, the lie capping off all the

Considering Anslinger to be an expert on marijuana, which he indeed was not, Congress passed The Marijuana Stamp Tax Act of 1937 after a mere half hour of floor debate, and it went into effect that October 1. I've attempted to read the Act, but it's impossible to be understood by a human being.

The tax is ridiculously small, from \$1 per sale to no more than \$24 per year. The tax stamp law makes it illegal to trade in hemp/ cannabis/marijuana without the stamp, but one must possess the product in order to purchase the stamp. However, one must have the stamp to get the product. It's a Catch-22, a circle with no beginning. The government has never issued any stamps.

Are you ready for this? Anslinger headed the FBN until 1962, and nobody even knew who he was.

Fast forward to 1970. When Congress passed the Controlled Substances Act that year, marijuana was labeled as a Schedule I substance, but there was no proof that it should have been categorized with heroin, et al. So Richard "Tricky Dick" Nixon (don't you just love Republicans?) put "law

There is so much going on right now with toll legislation, proposals, back-door legislation and "behind the scenes" activities and power-plays

Gov. Perry WANTS toll roads, in particular his dream of a Texas Toll Corridor originating from Oklahoma to Mexico, but then beyond to include Canada in the north to Central America down south. The governor is being "romanced" by special interests to proceed "full guns" on ensur-

and order drug warrior" Raymond Shafer, former Pennsylvania Governor, in charge of the National Commission on Marijuana and Drug Abuse. What Nixon didn't count on

Despite their best efforts, this commission couldn't find any reason to make pot

Tricky Dick lost it, as was his way. Just as the Commission was ready to release its report recommending decriminalization – and un-demonizing marijuana – Nixon ordered an "all out war" on drugs, focusing on pot. -Albert Einstein, My First Impression of the USA, 1921 ing toll roadways throughout Texas. Toll road plans reinforce for the GOP the issue of "NO new taxes"; however, what are tolls if not taxes?

In order to fulfill this mission. Perry has "Yes-man" Speaker Tom Craddick heading the house who is also "gung-ho" toll roads and anything else Perry wants. Craddick ensured house compliance and pro-toll direction by selecting Mike Krusee as the Chair of the Transportation Committee. Krusee has been the most influential member and prime-mover of the house in promoting toll roads to the legislature and big business. Krusee also sits on the board of CAMPO and persuaded the house and senate to approve and implement the bill for the Regional Mobility Authorities (RMA) -– several which determine future roadway plans in various counties. Currently Krusee is trying to ensure a stable long-term pro-toll RMA by getting his bill passed that will give RMA members a longer term of six years. Under the guise of maintaining "experienced" members, it will ensure a stable pro-toll membership and state agenda for at least the next six years

Furthermore, the Central Texas RMA is comprised mostly of Williamson County residents/special interests who are determining the toll future of Travis and surrounding counties — meanwhile, they are bypassing most of their own county with their future toll plans. Krusee is the representative of Williamson County and had no real opposition when he was recently reelected several months ago write-in candidate Karen Felthausen Krusee got more than 90-percent of the

As the key point, Krusee is one of the main reasons that the toll road issue has become such a force here in Texas. He voraciously has ensured, along with Perry and Craddick, that the gasoline tax has remained the same for the past decade, which has inhibited the amount of taxes available to build and maintain roads throughout the state. In addition, TxDOT has been sitting on vast amount of prepaid tax dollars by holding up on various transportation projects. Furthermore, TxDOT was "advised" by the governor to come up with "creative methods" for quickly building and maintaining roadways — hence, pushing the governor's toll

Krusee helped to increase the authoritative power of CAMPO, TxDOT and the RMA while not mandating their accountability to the people of Texas, as may be seen by the CAMPO and TxDOT request for public input on tolls and then CAMPO voting anyway for tolls after more than 90percent of the response was anti-toll.

Recently, many individuals and groups successfully demanded that the crossover bridge on Š. MOPAC above William Cannon Drive be taken-off as a tollway, the reason being that the project was already paid for by gasoline taxes. Thanks to ongoing public involvement and mounting pressure, that piece of completed highway now is free to drivers. If not for this effort, we'd be paying a toll on that stretch of MOPAC at this very moment.

Currently, there are similar toll issues prevalent. One is the proposal to toll Highways 290 and 71 near the "Y" in Oak Hill. These roads were built and paid for with gasoline taxes. Now TxDOT, CAMPO and the RMA want to charge tolls for enlarging the scope of those roadways. Point of fact is that the state cannot charge tolls on already paid for thorough-fares — but with the help of Krusee and these three committees they are trying to do so. There is a move by TxDOT to build an aboveground section of highway over the existing road, which it then defines as a new road, thereby attempting to circumvent the law against tolling already paid for existing roadways. We are all fighting this as we did with the S. MOPAC overpass project. So far, the "Y" area is projected still as a toll project.

Up in part of north Travis County toll booths have already been set up and the plan is to build a toll way on existing roads. Public groups are still fighting this for the same reason as mentioned with the two previously mentioned toll projects. These

are existing roadways.

To expedite toll projects, special interests e.g., CINTRA, the world-wide toll maven, has agreed to pay the state \$7.5 billion dollars for its consideration as the primary toll building and management company for Texas toll road projects. One of my complaints to the Office of the District Attorney is the illegal nature of such a maneuver and obvious conflicts of inter-

There was a measure in the legislature to place a moratorium of two years on the building of any and all toll roads until an independent investigation is completed to learn whether toll roads are the only and/or most viable means of building and maintaining Texas roadways. Instead, the legislature passed a bill that included providing TxDOT with more leeway in determining what roads may be considered toll roads.

Basically, toll roads are more than a 90-percent certainty unless the public vocalizes its anger and disagreement with the state's special interest drive for toll roads. While there are other alternatives to tollways, few have been or are being reviewed. One of the reasons that tollways are being pushed so vehe-mently is that TxDOT has "frightened" counties and legislators with the prospect of losing millions of state and federal dollars if toll roads were not voted for before a miniscule period of time. Consequently, this premeditated "persuasion" was very effective and instrumental in getting boards, committees and legislators to become proactive for tollways, and why the vote by CAMPO succeeded within such a short span of

Because of this "persuasive" tactic, I and others have complained formally to the Travis County DA, Ronnie Earle, to investigate the actions and motives of those pushing for toll roads. Those I named in the formal complaint range from the governor and house speaker to Krusee and TxDOT. The investigation is being performed as I write this synopsis. and hopefully, it will uncover some illegal activities and conflicts of interest prevalent in this massive push for tollways

There is much more going on at this time, but that's a VERY brief summary of the toll road status within the state. Definitely there is a toll road "conspiracy" afoot. If we all sit back and watch, our children's children will be paying toll taxes forever. We need to communicate more vigorously to elected officials, demanding alternatives to toll roads throughout the state. Austin is the Texas toll frontier. If it

happens here, it happens everywhere. People must quickly comprehend what this means. Many are being misinformed by the Office of the Governor and by legislators who tell them that state law reguires that there be alternate comparable roadways to every toll project; however, that is a sham. Many people believe they have an option whether or not to pay the tolls. THEY DON'T!!!

They may have the option whether or

not to go on the toll roads; however, EV-ERYONE in Texas will pay a toll tax at the 'cash register" when they buy goods and services. Businesses will pass along their toll costs to the consumer. In this manner it is estimated that EVERY Texan could pay a yearly total toll TAX of up to \$6,000!!! People need to hear this, because those in charge do NOT admit to it.

Furthermore, it is historical fact that once toll roads are built they remain for-- even when the roads have been fully paid for with tax dollars. Only once in my lifetime do I recall a toll road system being removed. That one in the late 1970's was the toll system for the Southern State Parkway in New York; however, there were some "behind the scenes" political reasons for that, which I won't go into here.

I have written the governor and legislators MANY times regarding the toll issue and NONE admit to prevailing agendas and negative impact on the community, even though it is a REALITY.

Feel free to contact me with any further question on toll roads. I am dead set against them. I have lived in areas that have extensive toll systems and have seen first-hand that they do NOT work. In fact, for a brief period of time I worked for the Transportation Dept. in NYC and have recognized that tollways are ineffective and inefficient. While people are told that they will free-up traffic congestion and decrease air pollution, that is contrary to what actually occurs. In addition, there is an increase of noise pollution and frequently extensive ecological and physical destruction occurs to the immediate environment. Toll roadways change the entire lifestyle of a community and overburden its residents. Toll roads are NOT cost-effective, are a bad idea and should be considered ONLY as a very last

So, what can we do?

Communicate the above facts to EV-ERYONE! We must educate the entire community. That includes store owners, residents, and even legislators who know almost as little as everyone else.

Only by an ongoing commitment to communicate our disagreement to lawmakers, do we stand a good chance of eliminating the "toll-road-it is" that has become a contagion among elected officials. The people must be in control of their transportation fate. We must present alternative options to toll roads. Even raising the gas tax is an option, though the governor doesn't admit that.

The governor's office states that people don't have an option to pay the gas tax but will have the option to pay tolls. That is bogus. While everyone will have to pay a toll tax at the register, people do have an option to fill their gas tanks, to cut down on their driving, and to develop car pools to save money. The problem is that gas taxes have remained the same for almost one decade. It's time they are updated and used properly to build and maintain roads.

Furthermore, legislators determined years ago that part of the gas tax goes to higher education. With the recent deregulation of higher education tuition, we need to divert that portion of the gas tax back to transportation alternatives. Special interests continue to keep all this as statusquo. We must voice our disagreement and demand realistic long-needed change.

Only when communities join together and demand things persistently in a unified manner will our elected officials listen and act accordingly.

It simply isn't possible for me to rush right out to make a \$3,000 purchase right now. There are certainly times I am in no position to borrow, either. (That's how a lot of landowners have lost their land, and I don't want to join those ranks). The thing about borrowing is that it must defi-

I'm not whining, and I'm not complaining. In fact, I've always considered myself pretty comfortable, all things considered. I am exceedingly grateful to have a roof over my head and enough to eat. There are plenty of others with less. Sometimes I just wonder when it happened that the average American had to start working so hard and so long to pay so much for so little. Of course, we are subsidizing a lot of welfare programs. But that would be a whole OTHER column.

So to all my wealthy friends and family and the rest of you out there (you lucky devils), who are so much better heeled than most of us: Next time you can't understand why I am not able to do this or that or to buy something or fly here or there. . . Three articles in Wednesday's Evansville IN Courier-Press are intimately connected, among them illustrating the current hazards to appropriate health and sexuality education in this country. One, the 'Community Comment' by Betty Cockrum, celebrated the 65th anniversary of Planned Parenthood in Indiana. Another displayed the bare bones of what has become escalating challenges to continued availability of family planning information, accurate and appropriate sexuality education, and access to medical choices for women, both in this country and around the world. And the third reports the unfortunate death of an infant born into a religious sect believing in the power of faith and prayer instead of appropriate and necessary medical care.

To The Editor:

The Texas Funeral Service Commission (TFSC) investigated complaints about Service Corporation International (SCI) and assessed fines of \$450,000 for 244 violations by SCI in 1998, including using unlicensed embalmers, consumer fraud and failure to comply with subpoenas. Robert Waltrip, CEO of SCI was a major financial supporter of then-governor George W. Bush.

When Eliza May, executive director of TFSC, was fired she sued Bush stating that she had been wrongly terminated for persisting in the investigation. In 1999, to avoid deposition, Bush gave a written

statement under oath that he had not spoanyone or interfered with the TFSC investigation. However, Waltrip and an SCI attorney stated that they had talked to Bush about the investigation. Charles McNeil, a Bush appointee who had voted to fire May, stated in a deposition that Bush had spoken to him about the investigation, and that "we attempted to enforce the law and we got squished like a bug." In a news conference, August 1999, Bush said that May's lawsuit was frivolous, and that he had talked to Waltrip about the investigation, contradicting his sworn statement.

U.S. Supports Undemocratic Regimes Worldwide

The U.S. has a funny way of dealing with undemocratic regimes around the world: it sells them guns. According to a study recently released by New York's World Policy Institute, more than half of the top 25 recipients of US arms deals in 2003 were defined as "undemocratic' by our own State Department. The criteria was that in these countries "citizens do not have the right to change their own government" or "that right was seriously abridged." We might be nurturing future Saddams right now!

Some of the top recipients of U.S. largesse? Saudi Arabia (\$1.1 billion), Egypt (\$1.0 billion), Kuwait (\$153 million), the United Arab Emirates (\$110 million) and Uzbekistan (\$33 million). No Saudi citizen dare challenge the rulers. Mubarak of Egypt is the sole contender in national elections. In Uzbekistan, a staunch U.S. ally in the "war on terror," state police recently killed in cold blood several hundred unarmed protesters in the capital, Andijan. President Karimov called the protesters "terrorists," but according to an Associated Press report they were ordinary civilians demanding free business activity and better living conditions, and complained about the stark poverty they've been forced to live in since the ex-Soviet republic became independent in 1991. A favorite method of dealing with Karimov's critics: Boiling. Very medieval, but highly efficient.

The World Policy Report also found that "when countries deemed to have poor human rights records or serious patterns of abuse by the State Department are factored in, 20 of the top 25 US

arms clients in the developing world in 2003 — a full 80 percent — were either undemocratic regimes or governments with records of major human rights abuses." The U.S. fans the flames of war around the world. As the worlds leading arms peddler the U.S. in 2003 supplied arms to 18 out of 25 active conflicts, sometimes to both sides.


The U.S. has a sordid history of dealing with terrorists also. Ronald Reagan once welcomed to the White House a group of fierce looking bearded warriors from Afghanistan he referred to as the "moral equivalent of America's Founding Fathers." The men belonged to a group of radicals who had been recruited by the U.S. for a program funded by the Saudis, and trained by Pakistans military strongman; Zia-ul-Haq to kick the Soviets out of Afghanistan. These men became known to the whole world later as the much hated Taliban. More recently, neocons in Bush's administration were attempting to restore the Mujaheddin e Khalq, a known terrorist group based in Eastern Iraq that is opposed to the current regime in Iran. The MeK, a well trained 4,000 member militia, the neocons are hoping will be used to topple the mullahs in Tehran much as the Northern Alliance was used in Afghanistab to bring down the Taliban.

If you listen to our leaders in Washington, the United States is fearlessly fighting evil in the world by spreading freedom and democracy. The sad truth is the U.S. empowers ruthless dictators and corrupt authoritarian regimes globally, foments death and destruction by selling massive quantities of arms, sometimes to both sides in a conflct. Rather than being a force for peace and stabilty in the world the U.S. is the cause for much misery and suffering

The United States has global strategic and geopolitical interests. The Bush administration callously pursues a policy of supporting regimes that help reach its policy goals. Nations that do not comply are sometimes ruthlessly

the 90s or bombed back to the stone age, as in Afghanistan. Words like "spreading freedom and democracy" and "war on terror" are meaningless window dressing meant for a gullible citizenry and a defeated, unquestioning media, unwilling to do its job.
