# **Bridges Elected President Of State Teacher Union**

## To Lead 51,000 Educators As Second Round Of School Finance Debate Looms

AUSTIN — Texas Federation of Teachers members elected Linda Bridges—a longtime union activist and president of the Corpus Christi American Federation of Teachers (CCAFT) as its president Friday at the group's biennial convention in San Antonio. Bridges takes the reins from John Cole, who is retiring after 24 years at the post.

Bridges officially takes office on July 1. "I'm energized and ready to go, which is good because with my election comes news that the Legislature is ready to try and tackle school finance again next week," Bridges said. "Our members are juiced as well. It may be summer vacation time, but we're going to be on the front lines letting legislators know every day that we're watching and we're working to ensure that adequate education funding is the key focus this time around."

Bridges has a long history of successful activism in Texas, including a campaign that led to CCAFT becoming the first teachers union in Texas to win the right of elected representation, which allows a group elected by all employees of a district to negotiate exclusively on issues affecting those employees.

As the local leader in Corpus Christi, she worked with the school district to emphasize professional development for teachers and support personnel, including mentoring programs and safety training. "We're going to continue on the path of providing teachers and support staff with the training they need to improve their effectiveness, which translates into a better education for schoolchildren," Bridges said.

Bridge also worked hard to help school employees play an active role in community efforts for education initiatives, such as work on reducing drop out rates. And she stressed involvement in other community-based programs. "It's my belief that educators need to reach out in all areas of community development, because it helps form a network of support for education," she said.

Bridges was president of Corpus Christi American Federation of Teachers, an affiliate of TFT and AFT, since 1981, and a full-time officer since 1978. She formerly taught special education in the Corpus Christi Independent School District and served a six-year term as a Del Mar College regent.

Bridges also was one of the community members appointed by plaintiffs to negotiate in a landmark desegregation lawsuit against Corpus Christi ISD in the early 1980s that ended school busing and instituted improvements in lowincome schools in the district.

### Rove's 9/11 Remarks Enrage Democrats

WASHINGTON, D.C. -- President Bush's White House advisor Karl Rove made blistering remarks last week against liberals causing Democrats to call for his resignation and apologies.

Rove said at a fund-raiser in Manhattan last Wednesday that liberals had poorly responded to the Sept. 11 attacks.

"Conservatives saw the savagery of 9/11 and the attacks and prepared for war; liberals saw the savagery of the 9/ 11 attacks and wanted to prepare indictments and offer therapy and understanding for our attackers," said Rove. Did you follow the advice of experts such as General Shinseki who correctly advised you about the troop levels needed to actually succeed in Iraq? No, you didn't."

# Countdown To Extinction

An Iconoclast Interview With

## Dr. Rima E. Laibow, M.D.,

Natural Solutions Foundation

CRAWFORD — The United Nations is not exactly a cute and fuzzy bunny, according to one environmental physician. It can also behave like that evil, maneating rabbit in the movie *Monty Python and the Holy Grail*, although in this case the hare ain't funny.

Dr. Rima E. Laibow, M.D. of the Natural Solutions Foundation, a not-for-profit corporation, says that the quality of food grown in the United States and elsewhere is at stake as new trade regulations on foods and nutrients are about to be imposed by the U.N. through the World Trade Organization.

She adds, however, that not only will organic milk, natural herbs, and high potency supplements go extinct in the United States due to this European vitamin and mineral policy know as Codex Alimentarius but also a very large portion of the world's population, if its strict guidelines are implemented.

Based in part on Napoleonic Law, the Codex Alimentarius sets the stage for all food trade and processing to be regulated through a narrow, nutrient-low expectation that has the potential to cause about half the world's population to eventually become sick and ultimately die, as predicted by the World Health Organization (WHO) and the Food and Agriculture Organization (FAO), she said.

As a joint project of the FAO and the WHO the group responsible for this policy involves the go-to guys for the international pharmaceutical corporations. These representatives sit on the six-member Codex Commission, an unelected bureaucratic board that asks for no input from health, consumer, and agricultural activists during meetings in Rome, Italy. Its next meeting is this coming July.

Ultimately, this illegal Codex policy harmonization could wipe out the United States' right to govern it's own food supply, leaving the red and blue parties here holding the grocery sack. At least three U.S. Congressmen have

At least three U.S. Congressmen have signed on to Dr. Laibow's petition, and one, Congressman Ron Paul (R-TX), filed a congressional bill that called for the severing of relations between the U.S. and the U.N. and the WTO. Doing so would have stopped the Codex from trumping U.S. law.

During an interview with the LONE STAR ICONOCLAST'S Nathan Diebenow, Dr. Laibow gave her take on the impact of Codex on consumers around the world, the influence of multinational corporations on the U.N., and the ways in which Codex policy harmonization can be stopped in the U.S.

ICONOCLAST: First off, what exactly are you a doctor of and where did you receive your training?

DR. ŘIMA E. LAĬBOW: I'm an M.D, and I have practiced nonpharmacuetical, drug free, non-toxic advanced medicine for 35 years. I graduated from Albert Einstien College of Medicine in 1970, and I did a recidency in adult general psychiatry and a fellowship in child psychiatry back when psychiatry was a great deal more being a vending machine with a perscription pad attached. Then I did a fellowship in child psychiatry.

I finished my training in 1975 and I practiced drug-free psychiatry for 20 years with remarkable success. I had the practice people sent their patients to when they didn't want them as their outpatients. I treated and wrote about what I was doing. I published articles in scientific literature on autism, post-traumatic stress disease, and a variety of other difficult things. I treated them non-pharmacuetically.

In 1991, I learned from a speaker at a meeting that actually was put on by my foundation in conjunction with the University of Kansas School of Medicine – I learned that there was such a thing as EEG – biofeedback – now we call it neuro-biofeedback.

Since the brain is the regulatory organ for the entire being, I thought this was very, very interesting. I went to the institute of the speaker at my meeting in California which is now defunct, unfortunately, and I learned some about neuro-biofeedback for peak performance and I met at that seminar General Stubblebine, who there interviewing the CEO of the organization and we looked at each other and said, "Hmm, if we take this out of the relm of peak performance and put it into conventional medical practice or at least a medical practice" - I never had a conventional medical practice – "we can create the medicine of self-regulation.

So we did that, and along the way, we realized that if we were having extraordinary success in training the brain to regulate correctly and properly but the body didn't have the nutrients in which to heal, we were paddling upstream, so I became a nutritional physician.

Then after a while I said, "This is terrific. We're having technological mediated miracles, but if we don't detoxify people, if we give them all the nutrients and we did the biofeedback, we're still paddling upstream," so I became an environmental physician." Along the way we've been using frequency medicine in our practice for quite some time.

People come to me who have been everywhere and done everything that al-

ternative so-called and conventional medicine, witchcraft and voodoo, burying themselves in mud, can offer to them, and they are still dying or intractably ill and then they come to me, and more or less, most of them get well. Some of them don't for a variety of reasons, like they want to die, but I have a very challenging and interesting practice.

The things that I do are well beyond any conventionally allopathic physician can do but well within the

range of expectation of somebody who practices advanced medicine. I don't like the term alternative. The alternative for chronic, degenerative diseases in wellness promotion is conventional medicine and it's a pretty poor alternative so I use the term advanced medicine.

ICONOCLAST: How were you first informed of the existence of Codex Alimentarius?

DR. LAIBOW: I've been watching the Codex issue for about 10 years, and I've been sending in my letters to Congress to try to beat back harmonization legislation and so on and then round about December 2004, I looked at the 109th Congress, counted up the votes that we could count on to beat back harmonization legislation. Te margin has been diminishing over each of those votes until we didn't have a margin anymore. We had disaster. I also looked at the health activism community in the United States, and I said, "Oh, shit!"

ICONOCLAST: (laughs) Quite literally. DR. LAIBOW: (laughs) Oh, yes, I said, "You know, if we don't have somebody who can stand up, think strategically, organize a grassroots with grasstops Congressional and international assault on this evil that is coming towards us, we're done."

And once we're done, because this is not regular legislation, because this is compliance with a world trade organization, that's what Codex is – Codex is the World Trade Organization – because of that, once it's passed, once it's ratified by the Codex Alimentarius Commission, we cannot modify it. We cannot cancel it.

We cannot modulate it or bring it into conformity with law unless we get out of the World Trade Organization, which wouldn't be such a bad idea to say the least, but the point is that we're stuck with it.

So a bunch of lowlevel bureaucrats are deciding international health policy, or rather international death policy – I'll explain that in a moment – without any democratic input, and we send FDA, USDA, and EPA representatives as our delerates and they don't

aibow, M.D. egates and they don't get a chance to vote because Codex runs on consensus. That means that when the chairman wants something to happen, he bangs down his hand and says, "Approved by consensus." That happened in the Committee for

That happened in the Committee for Nutrition and Foods Special Dietary Uses when the representative of India, who has at his back one-third of the population of the planet, said, "Mr. Chairman, we can't put this ingredient in baby food because it causes death in 10 percent of the infants of malnourished mothers and lots of our mothers are malnourished."

The chairman said, "Approved by consensus."

This happened in 2004, by the way. The Indian delegate said, "No, no, no, no. We've got to talk about this." And the chairman had the man physically removed by security guards and said, "Approved by consensus."

So we're talking about nothing that even bears the whiff of democratic process, and these are bureaucrats, unelected people who are making the decisions that the World Health Organi

zation and the Food and Agricultural Organization that are putting this monstrosity together at the behest of the U.N. I'll explain that in a minute, too. If vou look at those two organizations'estimates at what happens if you take away supplemental feeding on the population of the Earth what you come up with is a minimum death of one billion people by starvation, and the next two billion fragment of the population is going to die because of a chronic diseases of under-nutrition. That's their figuring. If you look at their numbers and you do the math, you come up with those minimum estimates of

what just taking nutrients away from people will do globally. Now, you could ask, "Why would they want to do that?" And you'd have to answer your own question because, unfortunately, they don't invite me into their inner circle meetings where they say, "Hey, here's what we're going to do, and here's why." So the Bible says, "By their works shall you know them." And the only thing you can do is look at who makes money out of all of this. Follow the money. The Jerry McGuire rule: "Show me the money!"

So who makes money? Let's see. A healthy populous that has access to abundant nutrients and therapeutically potent nutrients as we do in this country currently and a health populous has access to clean unadulterated food as some of us choose to in this country currently - food which has not been irradiated, food which has not been adulterated by having the animals universally treated with antibiotics and growth hormones, foods which have not been adulterated by pesticides, food which has not been grown in toxic environments so that the toxic levels of pesticides, herbicides, and toxins are incompatible with longevity and health, and food which has not been genetically modified – a population that would access to all of that uses fewer pharmaceuticals. doesn't it?

So what's good for the bottomline for the pharmaceutical industry is the same for the petrochemical industry, by the way. The same industry, the same controlling interests run both of those industries. They also run the agro-business industry, the chemical-pesticide industry, and the biotech industry – it's all sort of one club! So now you have all these "Bigs" – Big Pharma, Big Chema, Big Agra, Big Biotechna, and Big Medica – all profiting hugely from a sickened population.

Did you know that out of every dollar of foreign aid that the U.S. spends, 86 cents goes to the pharmaceutical industry?

try? ICONOCLAST: No, I did not know that.

DR. LAIBOW: It's another corporate welfare trick. Foreign aide has turned into pharmaceutical aide, so it's P-H-O-R-E-I-G-N.

ICONOCLAST: How do they get away with that?


DR. LAIBOW: How do they get away with all of this shit? How do they get away with it? They own the legislature. They own the executive branch of the government. Last year the pharmaceutical industry spent – I hope you're wearing your intellectual seatbelt – \$758 million on 522 legislators. You do the math. They get away with it, and that's the declared money. In Indonesia, if you remember, Eli Lilly was fined a million and a half dollars in this country because they were laying sacks of \$50,000 on the desk of Indonesians officials. How do they get away with it here? They don't use sacks.

ICONOCLAST: (laughs)

DR. LAIBOW: But it's the same deal, isn't it? So we have the Bigs who have decided for whatever reason – it could be that they're stupid, but I don't think so; maybe they're really out to reduce the population, and I suspect so – but whether we live or die, the five Bigs plan to make it big financially. What good is money when the planet has been reduced in population by half? I don't know, but the point is that the Codex is a tool of incredible death and destruction.

Now, people say, "Well, it's just international trade." Wrong. I have to tell you that there's a significant amount of disinformation about Codex that comes from the FDA, USDA, two trade associations which back when DSHEA was being valiantly fought for by the population – DSHEA being the Dietary Supplement Health Education Act. Back then during the DSHEA days, the National Natural Foods Association (NNFA) was really on our side. So was the Council for Responsible Nutrition (CRN). They really were on our side, and they were about helping us. They were about protecting supplements. Well, the pharmaceutical industry is anything but dumb. They said, "Hey, this is a good business. This is a business that will grow, and with every dollar that it grows, it will reduce our bottom line, so we need to get into this business."

On the membership list and on the board of directors of the NNFA, the major trade group for manufacturers is Pfizer, Monsanto, BASF, Weiss, Glaxo, Smith-Klein-Beecham, Novartis, Archer Daniels Midland, Eastman Chemical, and on we go to the other major trade organization, the CRN, and who is on their board of directors and membership list, well, son of a gun! The same companies. They're just so generous. They



They have taken over leadership of policy roles and financing, I suspect, of these two organizations. CRN's position on Codex Alimentarius is "Hooray, hooray! This is going to protect us from those nasty dangerous supplements and nutrients!" Excuse me? Dangerous supplements and nutrients? Interesting. Where are the bodies?

ICONOCLAST: (laughs)

DR. LAIBOW: On the other hand, Codex is not going to protect us from – oh, say, Vioxx, which is estimated by the FDA to have caused anywhere between 55-188,000 American deaths. Excuse me, I'd **Continued On Next Page**

like to choose what I'd like to get protected from.

ICONOCLAST: (laughs)

DR. LAIBOW: So we're talking – and on my website, I'll point you to some literature that substantiates what I'm saying because how do you know what I'm saying makes any sense? How do you know I'm not making this us up? I'm not, but I substantiate everything that I say. It's very important to me. Where I can't substantiate, like the intent of these people is, well, I make that very clear. This is my opinion.

ICONOCLAST: So what does Codex do?

DR. LAIBOW: Codex will make all natural health options illegal. Right now, herbs aren't part of that because they gave away herbs to the WHO because so many countries were saying, "But wait, wait! Our people use herbs. It's the only medication that they have available. They don't want to use pharmaceuticals. They can't afford them." They gave herbs at the suggestion of the U.S representative. They apparently illegally gave herbs to the WTO, and the WTO will, we expect, at the 11th hour when Codex goes into global implementation on Jan. 1, 2010, come back and say, "Herbs are untested drugs and therefore have to be banned world-wide." We be-lieve that is their strategy there, but it's very clear what the strategy is with nutrients and supplements.

If you look at the European food supplements directive, and there is a piece on the "Additional Materials" section called "Risk Assessment and Nutrition: A Toxic Brew" on my website <www.HealthFreedomUSA.org> where I discuss the specific levels that have been set in the European food supplements directive which is set to go into effect on Aug. 1, which will remove 75 percent of the natural products from the shelves of Europe permenantly because anything that can cause physiological change is considered to be a food as long as it's not a drug, and therefore comes under Codex. What they've done is list 28 items, one of which is a toxin, Flouride, so low that they are designed by intention to have no impact on any susceptible human being. That's the European implementation of Codex principles.

Dr. Grossklaus, who is the chairman of the nutrition committee has stated that the European food supplements directive is the future face of Codex. He has also stated that nutrition has no place in medicine. He is a nutritional physician but I don't quite know how he squares those two things, but he is rumored to own BFR which is a company - as far as I understand – that is the sole source of the risk assessment information and so Dr. Grossklaus owns the company that is submitting the risk assessment data using toxicology to control nutrients guarenteeing every single human being that comes under the sway of Codex will be chronically undernourished.

Now there are three things important here. The first thing is that Codex is being foisted upon the developing countries. They not only follow Codex in terms of international standards and international shipment and so on, but they also adopt Codex as their own values. That means that it will be forbidden in Rwanda, Nigeria, Tanzania, Ethiopia, China, the United States – the countries adopting it into their own standards – to use supplemental nutrition above the level of Codex standards, and those standard levels are designed to have no impact on human beings.

Let's say there is a famine in Ethiopia. It could happen, or the gingu weed is rampaging again, driving refugees into camps and aid organizations want to bring in nutrient rich food. They can't. A): They can't ship it internationally, and B): it will be against the law of the country to use supplemental nutrition higher than those levels, even with a physician's prescription. Anything other than those small number of nutrients and any nutrient that is listed in a higher dose is considered an illegal substance, like heroin. That's what happens to the developing world.

I have written a letter to every country in Africa, to their ambassadors here in the United States, saying "Hey, guess what? Are you aware that at least 50 percent of your people are going to die under this set of regulations? Don't you think you ought to do something about it? Please contact me."


I've been contacted by South Africa, Nigeria, and Egypt. Nobody else. Either they don't get it or don't believe me – they think that I'm some kind of preciousbodily-fluids lunatic from the wilds of Never-Never Land, or they think it's okay. Again, they don't invite me into their circles, but three countries have contacted me.

South Africa really got it. The health attache here really got it, but she said, "Nobody in my country understands this about Codex."

I said, "You got it because it's compartmentalized and separated into particles so that nobody sees the whole picture." The way my mind works is to look for the whole picture. That's the kind of physician I am, and that's why I have the kind of practice and success I have.



So, consequence one is widespread domestic legislation under-nutrition. The second thing is that U.S. manufacturers will be under significant pressure to reduce the potencies of their vitamins and minerals and to make the food shipable that we grow because we are an exporter of food. It's a big industry here. In addition to removing any effective nutrient-potency and making it illegal for any supplement to contain any nutrient-density higher than found in food, it also makes mandatory that ev

ery single food animal be treated with antibiotics and growth hormones inspite of the significant health hazard. It makes it mandatory that every dairy cow be treated with monsantos recombinant bovine growth hormone.

There's a sweet little hearts and flowers story to that.

Dr. Yetley was the U.S. representative to Codex from the FDA and at the time she was married to the man that was in charge of world-wide marketing for monsantos recombinant bovine growth hormone. And somehow or the other, she helped the Committee for Nutrition and the appropriate animal husbandry committee understand that every dairy cow on the planet needs to be really treated with growth hormone. That's one of the cute little things Codex does. Doesn't that warm the bottom of your heart? Forget about the health hazards. Forget about the cancer. Forget about the premature puberty, the bone distortion, and all of that - it's just nice to know that they were working together.

The pressure on manufacturers to have one line of food and one line of supplements, too, not two: one line for domestic use and one for international use. However, some people may continue to raise bio-dynamic or organic food. Some people may continue to make potency vitamins here in the United States, and the position of the NNFA is that'll be just fine: "It won't effect domestic standards." That is not true. That is shear disinformation. On my site there is an article on disinformation. The NNFA position and the FDA position is that this will have no impact on domestic standards, and that's untrue because of something called sanitary and psydosanitary agreement, which is part of the World Trade Organization's structure. The SPSA has a clause in it, Article III, which states that all member nations of the WTO, that's us, *must* – not may, might, could, kinda, shoulda - the word they use is shall bring the domestic standard into conformity with Codex. What that says is "Bye, bye, DSHEA! Bye, Bye consumer protection!" because poisoned food, and it's literally that severe, poisoned food will have to be the only kind of food available.

ICONOCLAST: How was the Codex Alimentarius created and what does it do?

DR. LAIBOW: Codex is a trade commission. It's not about consumer protection. It's not about safe food. It's a trade commission, and it was founded by the United Nations in 1963 as a trade commission. Way back in 1956, one of the committees that was rolled into Codex actually had determined that nutrients should be treated as toxins. That's why they are using risk assessment science to determine the highest dose of something you take without having any benefit from it - that's how risk assessment works. The trade commission said, "Okay, here's what we're going to do. We're going to remove any barriers to trade of food for people on the planet because if people aren't starving, they won't go to war." A little bit naive but that was the Zeitgeist at the time.

Then in 1994 the World Trade Organization was created out of GATT, and when that happened, the multinational interests took over Codex, so the change was to go from removing barriers to trade to controlling every aspect of all oral materials - anything that goes into your mouth now comes under Codex.

Now, if you're raising biodynamic chickens and I'm raising chickens in - I don't know - Japan, and my chickens are not biodynamic, but you're selling your biodynamic chickens to your neighbor and to people in Minnesota. I say, "Wait a minute. If I export my chickens into the U.S. people would rather buy the biodynamic chickens than buy my poisoned chickens." So here's WTO-speak: "You, Mr. Biodynamic Chickens Raiser, are creating a hidden barrier to trade. How are you doing that? Your chickens are being raised at a higher standard so people prefer your chickens to my Japanese chickens, so stop raising those chickens, mister, or I'll take you to WTO's dispute resolution process." And you say, "Ŝcrew you! I'm going to raise my chickens." And they take not just you but the United States to the WTO's dispute resolution process, and you inevitably lose because the country that conforms to Codex is assumed to be in

compliance.

The United States has now lost, and let's say that the biodynamic chicken business is worth - I don't know - \$1 billion a year. Well, Japan which brought you to the WTO's dispute resolution process gets to choose any trade sanctions it wants against the United States, not just the biodynamic chicken trade sanctions but any trade sanctions it wants that equals \$1 billion a year. So if they have been having trouble getting their steel into the United States, shazam! Trade sanctions on steel or whatever.

ICONOCLAST: So it's not a one-to-one deal

DR. LAIBOW: Anything you want. ICONOCLAST: Oh, great!

DR. LAIBOW: Wait, wait, it gets better.

ICONOCLAST: (laughs) DR. LAIBOW: This is a true horror. Eighty-seven representatives voted on Congressman Ron Paul's resolution HR 27 on June 9 to get out of the WTO. Well, we need not 87, we need all of them getting the idea that this is a disaster. So is CAFTA, so its FTA. They're a little bit further off than the vitamin and mineral standard in July, but back to what this means.

So now you are still raising your bio-dynamic chickens, right? But the steel manufacturers - who are pretty powerful and probably more powerful than the biodynamic chicken raisers – say to their friends in Congress, "For God sakes, make bio-dynamic chicken raising ille



gal so we can get our steel unsanctioned!" Congress says, "Okay." And all of a sudden it's illegal to raise biodynamic chickens in the United States because chickens have to conform to - guess what? - the Codex policy!

That's one way it works. The other way it can work. Congress says, "I love Co-dex, and Codex loves me." So they pass harmonization legislation and everything that Codex specifies is now U.S. law. But there's another way. Let's say that there's too much opposition, and I believe in every politician's cytochrome P-450 liver enzyme detoxification chain. there is one enzyme, possibly more, that requires reelection to function.

**ICONOCLAST:** (laughs)

DR. LAIBOW: So let's say that enzyme is really prominant in that politician's functioning. They wouldn't think about doing that. They wouldn't think about passing harmonization legislation. No, the last way is administratively. Let's say the FDA, which is an organization that you may be surprised to learn is subject to industrial pressure, gets leaned on and decides to make domestic non-hormone treated chickens illegal but they don't have legislative power. They are a part of the executive branch but have administrative and regulatory power. They'll promulgate a regulation that says, "Every chicken, for public safety, must treated with antibiotics and hor-mones." But I'm raising biodynamic chickens, and they say, "Tough nookie! We're getting stock options, and you're screwed."

Now interestingly enough, according to a lawyer with whom I work closely, who is very much involved in this kind of law and regulations, this action has the impact and effect of harmonizing us as if we had been legislatively harmonized. Once we're harmonized, there's no going back. It's like losing your virginity. You can't fix it up later. So Congress has to apply significant oversight to make sure that the regulatory agencies do not do this. That means we have to apply significant oversight on Congress.

The United States has announced its policy on the vitamin and mineral standard, and it's policy is illegal. It's policy is not merely a bad idea, it is illegal because in 1997 the United States passed a law that says that it is illegal for the United States to harmonize with a standard which violates U.S. law. Here in the United States we have a law called DSHEA, the Dietary Supplements Health and Education Act, which was passed unanimously by Congress 1994. Unanimously! Of course, a law is a law whether it passes by one vote, but it was passed unanimously. DSHEA guarantees access to supplements as food, and the implication there is that there are no limits on lettuce, rutabagas, and lamb, so there are no limits on supplements. However, under the Codex vitamin and mineral guidelines, everything not permitted is forbidden and anything is only permitted at these ultra low, insane doses.

Let me explain how that works. Here in the United States, our thinking is based on Common Law prinicples. Our very brains are shaped by Common Law assumptions. However, the Codex Alimentarius comes out of the Napoleonic tradition. In the Common Law tradition, anything that is not prohibited is permitted. In the Napoleonic code, anything that is not permitted is prohibited. If you've ever tried to live in France, you'd understand the difference.

(Laughs)

So what we have is a foreign legal system taking over U.S. law and regulation. It's not like a British legal system. Ours is based on the same legal principles. It's a foreign legal concept, and it trumps U.S. law because it says in the U.S. Constitution that in Article VI Clause 2, treaty law trumps domestic law except it also says in the Constitution that Congress shall do nothing that derogates Common Law. We've got a Constitutional law clash. You can't do it, and you have to do it. Oops!

ICONOCLAST: Oh geez.

DR. LAIBOW: There's another wrinkle here. This is like looking at the skin of a 104-year-old woman. (Laughs) You keep finding new wrinkles. Here's another wrinkle: Article VI Clause 2 talks about treaty law. However, is something a treaty if it's not ratified by Congress? Ooo, isn't that interesting because the World Trade Organization agreements

After the introductions, the first substantive paragraph which is question number one asks, "What is your liability, the President's, the secretary of agriculture, of commerce, health and human services, transportation, the EPA and FDA commissioners, and other related persons' responsibility or liability in terms of crimes against humanity?

ICONOCLAST: (laughs) Yeah, that's cutting it to the chase, isn't it?

DR. LAIBOW: Well, that's only the first one, but I figured I'd wake them up? And if you think that's not where we are going, guess again because if you knowingly do something that A) violates your country's laws and B) sets up a minimum of three billion people to die, let's see, is that a crime against humanity? What do you think?

ICONOCLAST: It sounds like one in my book.

DR. LAIBOW: It's in my book, too, and the only people who can take a person to World Court where crimes against humanity are charged are countries.

Individuals have no standing in the World Court, but you know what? That's okay because it makes the point. The point is Dr. Scarborough, you're in deep shit. And Dr. Scarborough is a bureaucrat. He may have allowed himself to become what I call a "running dog of death," but he is a bureaucrat and bureaucrats take the easy way out. That's how they stay employed.

It turns out that if you've read my latest blog, Venezuela, Argentina, and China have decided at the last minute (they are very much in favor of the vitamin and mineral guidelines) to make some little bitty changes. Australia wants to insert one word, for instance. Well, that makes a bureaucrat happy. It makes them feel like they're doing something, and I guess the government feels like they should pay them for what they

DR. Yes!" because that gives us one or two years. What can we do in that one or two years? Plenty. Plenty.

My hope is that by putting a great deal of pressure on Congress now to put pressure on Scarbough by having people sign the petition that he will climb down and go back to "Well, we really should gives other countries the opportunity to perfect the document as they wish. We should sent it back to committee." Fine, because that one year or two years will give us the time we need to take this sucker down. It's a golden opportunity from the hand of people who have no interest in giving up any opportunity whatsoever

**ICONOCLAST: Where are American** doctors' organizations in all of these Codex discussions? You said earlier that there really were no health activists talking about Codex. Why is that?

DR. LAIBOW: I'm a member of the American Academy of Environmental Medicine, for instance, people who think more or less like I do and use nutrition and environmental detoxification stuff, and I called up the past president who put me on to the current president, and said, "Hey, you know all you guys are going to be going out of business in two years?" He said, "What? Say what?" I explained the Codex and I wrote a

lengthy letter that was published in the newsletter at that point back in April and then I wrote a subsequent letter and I asked people to activate their patient load because after all, these are people who have chosen natural medicine. I contacted the International College for Intigrative Medicine, the American Holistic Medical Association, and all the associations I could think of.

To date the only response has been from the American Academy of Environmental Medicine. The American Academy signed on to the Declaration of Health Independence. The president elect and the past president came to a meeting of so-called activists that I instigated in April which was as basically as useless as tits on a warthog because all they wanted to do was call each other names and take turf. Be that as it may, they came and they're good guys and they are doing what they can.

I'm continuing this battle because it's not over. Whatever happens in July, I will be there with my husband as an offical observer, which means we'll be allowed in the chamber but we will not be allowed to speak. We will record what happens in detail, and I will do live radio broadcasts for my show and for some other shows. We have a radio show on Internet radio - <www.ficaa.com >- 7 p.m. EST, Wednesday. It's also archived so people can listen at their convenience.

It's going to be a fevered battle. We have not given up, and even after ratification takes place if it does in July, there's a long heavy battle ahead not just over the vitamin and mineral guidelines but around all the other evils of Codex.

ICONOCLAST: I went to Congressman Ron Paul's website and found it very, very interesting. I didn't realize that he was so outspoken on the policies of the Bush administration and one of them is this Codex deal and others include

# — Editorial — **CONGRESS:** Say No To CAFTA

ow many blank checks will Congress give to giant corporations before its members realize they have created a monster that is wealthier, larger, and more powerful than the government itself?

Don't forget, some of these large corporations manufacture military weaponry and hire their own mercenary armies.

President Bush is urging Congress to again sell out the United States of America by affirming CAFTA, the Central America Free Trade Agreement with Costa Rica, El Salvador, Guatemala, Honduras, Nicaragua, and the Dominican Republic, which is nothing more than another means of dismantling national laws in favor of globalization and privatization - causing a new wave of job exportation and placing global laws over U.S. laws and the Constitution itself.

He wants Congress' stamp of approval prior to the July 4th holiday.

Bush sells it as a means of extending our borders and protecting minor democracies abroad.

The clear aim, however, is to transform privileges enjoyed by multi-national corporations into the right to plunder.

Bush might argue that U.S. sugar and textile companies are taking a selfish view of his proposal, since they would be targeted for extinction first, but that the overall picture is what counts.

The devil, however, is in the details, and they aren't pretty.

First of all, CAFTA is a close cousin to NAFTA (North American Free Trade Agreement), which for the past 10 years has done little, if anything, to benefit the U.S. In fact, NAFTA has played a role in the outsourcing of prized U.S. jobs.

The "F" in CAFTA stands for "Free," when what this country actually needs is 'Fair" trade, to be based upon circumstances and conditions that change with the times. As an example, a provision in CAFTA discriminates against products by non-government organizations and producer cooperatives, allowing agribusiness cartels to utilize CAFTA as a tool to eliminate trade from fair trade products, basically "freeing" multi-national cartels from legitimate competition.

CAFTA licenses biopiracy, whereby intellectual rights are extended to improved crops, or their seeds, prohibiting farmers the recognized traditional right to save and plant their own seeds from year to year. CAFTA would give multi-national biotech corporations the right to sue farmers for "patent" violations, even if pollen drift causes certain crops they don't plant to grow on their property.

CAFTA would prohibit governmental agencies at all levels from favoring local suppliers in government contracts for goods and services. It would eliminate any government regulations on foreign investment or investors, including performance requirements.

There is even a provision of CAFTA that allows foreign investors to bring complaints to international tribunals against any government instituting public policies that, in the judgment of the investor, could affect the non-existent profits they project to receive in the future.

Any disputes would be decided by a newly established global entity that has ties to the World Bank and the United Nations Commission for International Trade and Law.

These are but a few of the negative impacts. There are many more.

With the passage of CAFTA, Congress will be saying good-bye to thousands of middle-class jobs in the United States while weakening the government itself.

Bush's argument that CAFTA will contribute to America's national security is ridiculous; it will probably do the opposite.

Bush should wipe the smirk off his face and spend some time on the Texas-Mexico border. There exists a constitutional mandate to protect our borders and it isn't happening, even all these years after 9-11. He has involved our country in a guerilla war in Iraq instead.

Follow the money.

# **The Overton / Hulen Family Tales**

## Life And Death Along "THE BREAKS"

The Great Plains, or more specifically, the High Plains of the Texas Panhandle, are flat! At least that is the general consensus of most Americans. We read this in literature. It is depicted in movies. We are taught that the plains are flat in school. And, in many locations and to many people who trek from the mountains (or hills) of the Ozarks, the Ouachita, and even the Appalachians, the plains are flat, relatively speaking.

However, to those of us who have lived or spent much time in this environment, the plains are not really flat. [A Masters Thesis a few years ago compared the plains of Kansas to a pancake to disprove the old saying, "flat as a pancake." When adjusted for scale, the pancake was actually not as flat as the plains. I guess a better saying is "flatter than a pancake." But that's not really relevant - just a saying.]

I am intimately familiar with the plains of the Texas Panhandle, as well as those of Western Oklahoma and Western Kansas. I grew up out there and didn't move to the hills of Arkansas until much more recently in my life. Most of the stories Dad told related to a plains existence. I made the fatal mistake of marrying an Arkie.

But the Texas Panhandle is somewhat unique. It is relatively flat when compared to say Western Arkansas or Eastern Oklahoma and assuredly the Rocky Mountains of Western Colorado. But when viewed closer, it isn't all that flat. There are vast areas that are hilly, many of which are stabilized sand dunes. Some are the result of geologic structures, such as the more erosion resistant sandstone or shale formations as opposed to the softer sand or clay deposits. And in some areas of the High Plains, limestone deposits range from relatively flat-lying to gently uplifted.

But dispersed throughout these features are the breaks. The breaks are erosional features that break up the more monotonous flat plains geomorphology. These might be described in other locals as wide gullies or ditches. But on the plains of the Texas Panhandle they are simply, the breaks. They do differ from these other geomorphologic features in that they are normally wider, in some places more than a mile, and have a relatively flat floor with a small streambed meandering through.

The breaks are both a boon and a liability on the plains. They are sometimes life-saving features that attract wildlife and sustain livestock and provide shelter to both. At other times they are death traps for the same critters – as well as people.

They are critical to some of the unique eco-systems of the High Plains. Some of these erosional features actually penetrate deep enough into the overlying unsaturated soils to intersect the local groundwater table, or at least wet weather water tables that are "perched" sometimes well above the regional water tables. As such, they provide a valuable resource in an otherwise rather dry environment. The average rainfall in the Texas Panhandle is locally less than 12 inches per year. Often most of these 12 inches comes in one or two precipitation events, and that might include a few relatively large wintertime snowfalls.

Where the breaks do intersect these wet-season groundwater tables, seeps or springs will flow. This water source becomes a magnet for wildlife and livestock. Before the advent of the windmill, and later rural water systems, these seeps and springs were the primary water supply for the plains.

Usually, the vegetation was lusher within breaks that included a seep or spring. This also attracted a wide variety of wildlife and in great abundance. Early inhabitants, such as the American Plains Indian, often made their camps near these seeps and springs. Later the early homesteaders used these water sources to sustain their existence.

The breaks were also about the only shelter from the sun, wind and cold. The breaks became shelter during both the hot summers and the cold winters to wildlife, livestock and often man. In many areas of the Texas Panhandle the only real trees present are found within the breaks, due to the availability of water.

These same features make the breaks a death trap in severe conditions. These erosional features can sometimes extend for many miles, snaking across the plains where the geologic strata are weakest and most susceptible to erosion. Palo Dura Canyon, south of Amarillo, Texas, is an extreme example. It is much deeper and wider than the typical breaks, which can be extensive, often extending for many miles and can be more than a mile in width. A rancher trying to find stray livestock may search for days or weeks without any luck.

Dad told many stories about the breaks. It was an integral part of ranch life on the Texas Panhandle plains where he was foreman to several very large ranches over a period of more than 20 years. These ranches were located near Hereford and Dalhart, Texas.

He often spoke of the peril of crossing a portion of a break on horseback or, even worse, on foot, especially during the spring and summer. Since most of these breaks extend for many miles and sudden thunderstorms are common, it is not unusual for a storm upstream to create a surge of flow down the breaks, a flash flood. This flash flood often comes as a wall of water stretching from one side of the break to the other side, and carrying with it all sorts of debris picked up along the way. All together, this crest can sometimes be as high as 20 feet, given the right upstream conditions, the size of the thunderstorm and the rate of rainfall. In other words, when the conditions are right, a very high flash flood of water and debris can come barreling down one of these breaks without warning. Well, I say without warning. There is a warning, but often when you sense this warning, it is too late to react. Even today, in an automobile or pickup truck, people are sometimes caught by one of these flash floods without warning while crossing a break.

Dad related a story about crossing one of these breaks on horseback one summer day while riding windmill check - a monotonous chore that had to be undertaken on a continuous basis. The windmills were spaced so that widely scattered herds of livestock would have adequate water, making them the lifeblood of the plains. Without the windmills, ranches on the scale of those that flourished during the early 1900s, and still exist today, could not have survived. The break Dad was crossing that day was typically long and winding and extended some 30 or 40 miles roughly north to south and was more than a mile wide where Dad was crossing. He said he was about halfway across the break when he heard a roaring in the distance. His first thought was that he could hear the thunder of a storm. He quickly realized, though, that what he was hearing was closer than a distant thunderstorm - he was hearing the roar of a wall of water surging down the same break he was in the midst of crossing. He immediately began to run his horse to the closest bank. This in itself is an indication of the dire straights he knew himself to be in. Dad always criticized the TV western that showed the cowboy running his horse for any distance. He would always say this was the best way to ruin a horse for life. Dad would say that he would fire a cowboy on the spot if he caught him running his horse. A cowpony cannot endure long outright dashes like the one he was now forcing his horse to take.

As he neared the far bank he saw the surge as it rounded the last bend to his right. He was still several hundred yards from the bank and had to climb 20 to 30 foot with a horse that was nearing its endurance limit. The cowpony, though, became aware of its situation as well. When the crest of the flash flood rounded the bend, Dad said the horse laid its ears back and found extra energy. When he reached the base of the bank that would allow him to exit the break, the horse had all but given out. It began to stumble up the rise and fell to its knees once. By that time the crest was only yards away. Almost to the top, the surge hit them broadside. Dad was knocked from the horse and was forced to try and stay afloat amid the rolling water of the crest and the debris it carried. Luckily he was close to the top of the rise when it hit and was near the top of the surge crest as well. He grabbed hold of the largest log that was close to him and rode the crest until he was close enough to the bank to swim to shore. A sagebrush bush was growing on the bank and hung out over the break just down stream. He pushed off from the log and frantically swam toward the bank but for every foot of progress he made in that direction he was taken many yards down stream. At the last minute he made a lunge for the overhanging bush and caught just enough of the nearest stems to get a hand hold which he quickly lost to the force of the

water. It did, however, swing him around just enough to get him a little nearer the bank. He was then able to struggle on to dry ground.

Dad said he crawled up on the bank and just lay there for a while trying to catch his breath. He had lost his hat and horse, but he was alive. After a few moments he pulled himself to his feet and gazed over the back end of the surge now passing through the break. The water level had dropped significantly, but there were still several feet of water that stretched as far as he could see across the break. His horse was nowhere in sight - it had not made it to the bank. He doubted that the horse survived due to its exhaustive effort to run from the flood in the first place. Dad walked down stream for a ways hoping to find it had also climbing onto the bank, but with no luck. He did not have the luxury of walking far in search of the horse because he knew he had to get to the nearest base camp where supplies and fresh horses were kept. This was going to be a four or five mile hike without water or his hat in the blazing summer heat.

He made it to the line camp and a windmill where he was able to quench his thirst and get a remount. He then rode back to the break to look for his horse. A cowboy is not going to leave his horse without knowing its fate, if possible. Besides his saddle and other tack were still on the horse. He found the horse still in the break and downstream about three miles. The horse didn't make it to the shore and either drowned or died from the exhaustion, trying to swim to shore while being buffeted by floating debris. Dad retrieved his saddle and other gear and returned to the line camp. He said that after that experience

crossing the breaks he would always stop at the rim of the break that he needed to cross and listen for a few moments. He would scan the horizon up stream to see if there was any evidence of a thunderstorm in the headwaters area. He was never caught in this situation again, but was always fearful of crossing the breaks afterward. He said that he was not the only one to suffer such an experience, and that most that were caught within a break during one of these flash floods never made it to shore. He was one of the lucky ones. He attributes this "luck" to a good horse and "the Good Lord looking out for him". I guess a good cowboy always gives his horse equal credit, whether he means to or not.

The breaks were not only a problem due to unexpected flash flooding. During the winter they can be both shelter and a death trap. Dad talked about numerous winter snowfalls that would fill the breaks to the brim with blowing snow. If you didn't know where the banks were located, you could easily walk your horse over the edge and into deep snow that would be difficult to get out of, especially for the horse. Dad always said that a good horse would have more sense than to walk over the edge in this situation and that on several occasions his horse had more sense than he did and refused to walk over the edge

of the snow-filled break.

The worst scenario, however, involves trapped livestock. A herd of cattle would naturally seek shelter wherever possible during a blowing snowstorm. Often, the only shelter on the plains was the breaks. The herd would move into them and huddle against the lee sidewall out of the blowing snow. If the snow began to accumulate they would mill around to keep the snow tramped down. This instinct would often save their lives,

or sometimes only prolong the end. Dad talked about finding herds of cattle by riding the edge of the break and looking for steam rising through a hole in the snow. The cattle would begin to walk in a great circle and the snow outside the path would continue to accumulate until it reached the height of the cattle's backs. If the snow continued to fall and build up, often it would begin to pack over their heads to form a structure around and over their backs. The inside of this structure would glaze over as ice due to the melting from the herd's body heat and the subsequent refreezing. Due to the heat generated by the continuous walking, a vent hole would remain open above their heads. As long as the "roof" of this structure did not collapse and the herd kept moving they were safe. If it collapsed, and there was sufficient snow, they might suffocate from the cave in.

If the rancher could locate the position of the herd, they could break through the drift enough to get food (hav bales) down to them and sustain them until they could reach them with a dozer or other means of removing

the snow. Often, the herd's path would migrate away from the edge of the break and be too far away from the rim for the rancher to reach them. In those cases, the herds often died of starvation or suffocation. In a few instances, the herd survived and was able to free itself as the snow melted around them.

The breaks are a source of water, shelter, and therefore life. However, under the right conditions, they could mean death. All in all, the breaks were an integral part of life on the plains for both man and beast.

## **The Overton / Hulen Family Tales Death And Death In The Bottoms** By Don M. Fisher

As King Cotton greedily devoured the blackland prairie of East Texas, there remained, as there have been in most parts of America, some places that defied taming.

Like the breaks of the Panhandle, the Bottoms of East Texas remained wild and, for the careless or uninitiated, dangerous places.

The Texas lands first settled by the Hulens and Overtons were like an island of prairie rising out of two vast swamplands, or river bottoms.

To the north, Red River Bottoms geographically split Texas from "Indian Territory." Until I was "a good-sized kid," as

our elders would say, I knew Oklahoma by that common and original title.

Barely twenty miles distant as the crow flies, it was a world away: a world of snakes, man-sized catfish and gar, quicksand, and outlaws.

To the south, Cuthand Creek slashed across the miles of cotton rows as it gouged its way wider and wider until it was swallowed by the vast and legendary Sulphur Bottom, more than a hundred miles of seeping flow, clogged by debris "rafts, miles-long log jams packed so tight by the seasonal flooding that the dense forests simply grew over them. It was a pick-up sticks of legbreaking, rotting ground with decay that nourished an astonishing variety of wild and intriguingly dangerous things from blood thirsty insects to sleek and soulless felines. The open sloughs and channels were a muddy soup of alligators, cottonmouths and prehistoric survivors like the gaspergou and jackfish.

The Red was haunted by timber rattlers and even coral snakes. It had more than its share of 'gators and other big predators, but the river had been a highway since Captain Shreve blew up the raft below Shreveport long before the War Between the States, opening the river to navigation.

Red River was wild, but friendly. Sort of like our Uncle Hugh.

Maybe there was a bad side, but it was an easy side to live with once

you learned to stay off of it. But nothing good came out of Sulphur Bottom, so the Sunday School teachers would say.

No one traversed the Sulphur, or wanted to.

The Red could serve up goods for a dozen Texas and Oklahoma settlements.

The Sulphur went nowhere. It just seeped out of countless seasonally dry Northeast Texas creeks, then oozed into the Red just across the Louisiana line.

We never heard of Bigfoot, the current talk of the Bottoms since "The Legend of Boggy Creek" hit the Bhouse movie screens. The real Fouk Monster was dreamed up by a group of Arkansas-Louisiana Bottom dwellers who hoped it would frighten away a group of black families who moved into the area.

Not all monsters live in the Bottoms

Some haunt the heart of hate.

Our monsters were real: panthers we heard scream in the still night distance, bears that would rob a litter from the hog pens of families struggling in the thin soil too close to the Bottoms.

But even more frightening was the unknown.

A mud-caked horse or mule would wander back home after its rider was days overdue. The trail would simply lead into the Bottom and die there.

Quicksand and gator holes could swallow up horse and rider. Wild hogs the size of ponies foraged omnivorously. Red wolves and coyotes prowled the trail of misfortune, leaving barely enough to keep a buzzard alive

Cattle, horses, dogs and men would somehow disappear into the Bottoms.

It was good for two things: squirrel hunting and whiskey.

At its widest part, the Sulphur runs parallel to Cuthand and White Oak Bottoms. Rather than the four or five-mile traverse, the Bottoms spread out more than twenty miles across. Only two paved highways cross it even now, and compared to the early part of the last century, the bottoms are tame as a city park.

It was an ideal place to cook whis-

key. There is still a community on the named after the wagon load of sugar and yeast once delivered weekly to the little grocery store there.

Several times our Cuthand squirrel hunts would be cut short when my dad or granddad would catch the scent of woodsmoke and boiling mash on the heavy fall air.

The Bottoms were no place to come across a still.

These were enterprises of men unafraid of all the teeth and toxins with which nature chose to arm herself. They did business surrounded by places most people dread.

And they were the most dangerous creatures in the Bottoms.

Them old boys fought wars in those Bottoms, killed over territories, customers, deals.

Somehow I never blamed them. There was a well-known family

named Belcher, well-known among the thirsty, that is, living in Cuthand Bottom.

They were honest in their dealings and quick in their judgment. They did not suffer fools lightly.

One of the Belchers was killed by a bootlegger (A bootlegger sells whiskey; a whiskey cook is an artist. The Belchers were artists with an easily offended aesthetic sense.) The killer propped the body against an oak tree and cut off one ear "so I'd know him in hell.'

The bootlegger was sent to prison to be paroled after a few years.

Shortly thereafter they found him in the middle of the road gut shot with a 12-gauge load of tacks.

The sheriff was just beginning his investigation when the wizened old justice of the peace showed up and declared the death a suicide.

Suicide? His middle opened up like a drugstore on Sunday?

"He killed a Belcher and come back to Cuthand Bottom," the old man said. "That was suicide."

To a certain way of thinking, it was merely justice delayed.

That body could have been dragged a couple of hundred yards and no one would have known about it but the hogs and the buzzards. Instead, he was laid out for all to see.

And know.

Now, justice was served.

Such is the product of prohibition.

The only difference between the Daniels of Tennessee and the Belchers of Cuthand Bottom is that Lynchburg possesses a more enlightened electorate.

The "dry county" has killed more people than smallpox.

Make chewing gum illegal and there'll be a dozen Chiclet-related killings the first week.

We seem never to learn that there are places on this earth where humankind is not welcome. We can either leave those places to God's palate or destroy them in our own image.

Texas plans to build a series of lakes along Sulphur Bottom, flooding the last few miles of unconquered freedom to water lawns in Dallas and run Skidoos around in circles over the graves of wild things that will never again scream in the night and disturb our dreamless sleep.

And all we need be afraid of is ourselves.

# Looking For Excitement? Try Feeding Your Arm To A Catfish



For those west of the Mason-Dixon, a Gar is sort of like a barracuda, but with more attitude. To this day, none of us can agree on how big this Gar was. My guess is about 12 feet long. And I'm pretty sure it had the hindquarters of a bull elk clenched between its jaws. Others in our group disagree, and say what I actually stepped on was a swollen bratwurst.

I think I'd know the difference between stepping on a dangerous maneating fish, or a relatively harmless meat by-product. Although, to be fair, I



can't say for sure because my eyes were closed and I was screaming.

In that moment it became clear to everyone in our group, — and anyone living within a two-mile radius — I wasn't going to be bare-handing a giant catfish (or bratwurst) anytime soon.

# Breasts That Aren't A Bust



# Newspaper Downplays Town's Tough Reputation

Ignoring the fresh graves that dotted boothill, the TASCOSA PIONEER had the gall to claim on June 22, 1886, "Our society is not so rough as many have been led to believe.

The inhabitants of the toughest town in Texas surely shook their heads in amused amazement. Either the publicspirited publisher had baked his brains in the noonday sun, or he somehow managed to sleep through the Big Shootout.

Trouble had been brewing in the Panhandle for many years. The uncompromising conflict pitted the big ranchers and their legion of gunslinging rangeriders against small independent cattlemen, assorted squatters, and those cowboys blackballed after an unsuccessful strike in 1883.

A jilted prostitute inadvertently brought it all to a head in March 1886. After losing Lem Woodruff to another lady of the evening, Sally Emory promised the moon and several stars to Ed King, an LS ranch hand, if he would help even the score with her fickle ex-boyfriend.

Recruiting a couple of cohorts from the LS camp, King made a beeline for Woodruff's favorite haunt, where the trio tried to taunt him into a gunfight. Although the insults were so humiliating that he broke down and cried, Woodruff stayed put safe inside the saloon.

A few days later, Sally Emory sent a

note to King asking him to meet her that night. Not about to venture alone into Tascosa, King persuaded Frank Valley, Fred Chilton and John Lang to go along.

The four cowhands passed the early evening at a private party and a hospitable watering hole, where they did not have to worry about watching each other's backs. Then at two o'clock in the morning, they rode the short distance into town

Valley and Chilton headed for a permanent poker game, while King and Lang moseyed on down Main Street. Finding Sally in front of the Exchange Hotel, Lang freed his friend to keep his date by graciously offering to tie up the horses

As the couple strolled past Jenkins and Dunn's saloon, the known hangout of the Woodruff clique, a voice from the pitch-black porch loudly questioned the marital status of King's parents. Ordering Sally to go on without him, he stepped toward the source of the slander

A block away, John Lang heard the tell-tale sound of gunfire and turned to see Ed King fall on his back. He watched horror-stricken as Lem Woodruff emerged from the shadows, placed the barrel of his Winchester on King's throat, and squeezed the trigger.

Sticking his head in the poker parlor, Lang shouted, "They just killed Ed!" Valley and Chilton dropped their cards This Week In Texas History **By Bartee Haile** 

and grabbed their guns, but King was dead by the time the trio reached his side.


Assuming the murderers were waiting for them to storm the entrance of Jenkins and Dunn's, they decided to attack from the rear. But as they turned the corner into the alley, there stood Woodruff with four accomplices.

Lang, Valley, and Chilton opened fire simultaneously before their prey could clear leather. As his associates scrambled for cover, the impact of two slugs knocked Woodruff back inside the barroom.

He kicked the door shut behind him, but Frank Valley emptied his pistol into the thin wood. Pausing to reload, he listened intently for any sound of life. Hearing none, he could not resist taking a peek at Woodruff's corpse.

Valley gently opened the perforated door only to get the biggest and last surprise of his life. A Winchester roared, and Woodruff registered his second kill.

Seconds later, curiosity caused an-other casualty. When cafe owner Jesse



made a mad dash for his horse. Miracle of miracles, he escaped with nothing worse than a bullet hole in his coat

sleeve. A mean and close-knit bunch, the boys at the LS Ranch blamed Tascosa for the slaughter of their saddle partners. In retaliation they plotted the execution of the entire town.

The day after Valley, Chilton, and King were buried, 55 cowboys descended on Tascosa ready to shoot every living soul and to burn the place to the ground. But, as an afterthought, they asked the LS foreman for his blessing.

Certain of his absolute authority, he told the mob to go home. Anyone who dared to take the law into his own hands would be exiled forever from the ranch.

A few hotheads tried to argue the point but were swiftly silenced by the obedient majority. Tascosa was spared, and not a moment too soon.
