WASHINGTON — The Senate reauthorized the Patriot Act with a vote of 96 to 3 last week, against the efforts of Sen. Russell D. Feingold (D-Wis.) to spend more time debating the renewal which was set to expire March 10.

Feingold, the only senator to vote against the original Patriot Act after the attacks of Sept. 11, 2001, was joined by Sens. Robert C. Byrd (D-West Virginia) and James M. Jeffords (I-Vermont) in voting no this round, insisting that the act

Bush Spends \$1.6 Billion On PR Machine

WASHINGTON - Roughly \$1.6 billion of taxpayer money went to public relations campaigns for the Bush administration over a 30-month period, reported the SAN FRANCISCO CHRONICLE last week.

Requested by congressional Democrats, the Government Accountability Office report says that the White House is enlisting the services of private advertising consultants to persuade Americans on such topics as supporting the Iraq war and preventing prescription drug sales from Canada.

The White House refused to comment last week; however, in the past, the Education Department has said PR spending is a perfectly fine method to inform the public.

Spy Program Senate Inquiry Sidelined

WASHINGTON — There will be no Senate investigation into President Bush's domestic spy program, reported the New York Times Thursday.

Sen. Pat Roberts (R -Kan.), chairman of the Senate Intelligence Committee panel, indicated that "such an investigation is currently unwarranted and would be detrimental to this highly classified program.'

A separate House inquiry, however, could develop on its own.

Sen. Roberts added that the Bush administration agreed to pass along more information on the spy program operated by the National Security Agency. The ranking Democrat, John D.

Rockefeller IV of West Virginia, however, has proposed another investigation from the committee. Sen. Roberts said when the panel reconvenes on March 7, the proposal will be reconsidered.

And it might just be reconsidered, too, because two of the eight committee Republicans, Orrin G. Hatch of Utah and Chuck Hagel of Nebraska, want Congress to receive more information from the White House.

One of the bill's new provisions exempts libraries from so-called "national security letters" or subpoenas for business records issued by the FBI in terrorism cases without warrants.

U.S. Company Implants Chips In Workers

AKRON, Ohio — THE FINANCIAL TIMES reported last week that a private video surveillance company became the first known U.S. employer to implant electronic silicon chips in two of

its workers to identify them. The Ohio-based CityWatcher.com said the technology was being tested to control entry into a room that contains video footage for police and governmental agencies.

Viewed as perhaps the next biggest and most controversial industries to emerge, these RFID chips have already been implanted in animals and goods for tracking purposes. These special chips work using cheap radio transmitters that pulse a signal unique to their design.

Critics of identification technology say the chips' existence bring up privacy and civil liberty issues, such as track-ing the user without his knowledge, though a spokesperson for CityWatcher says the company's device does not work like a GPS location system.

The U.S. company that manufactured the chip, VeriChip, stated that its implants were designed for medical purposes only. About 70 people in the United States have had the chip implants, according to the company.



White House Feels

WASHINGTON — A deal that would give a company based in a country tied to known terrorists and 9/11 hijackers operational control of six U.S. ports renewed doubts that the Bush administration has the security interests of the United States in mind.

According to the NEW YORK DAILY NEWS, the White House caved into congressional pressure to investigate the decision of a secretive U.S. panel that approved a \$6.8 billion deal with the United Arab Emirates-owned Dubai Ports World to manage the maritime portals.

tals. "I called the White House and said I have concerns with this and asked to not go ahead with it until there's been a full investigation," Rep. Peter King (R-L.I.), chairman of the House Homeland Security Committee, told the DAILY NEWS.

National Security Council spokesman Frederick Jones defended the decision of the Committee on Foreign Investment in the United States move saying that the panel "rigorously reviewed" DP World. White House spokesman Scott McClellan echoed Jones' defense and directed questions to the Treasury Department which runs the committee.

When asked at a budget hearing Wednesday, Treasury Secretary John Snow, who chairs the secret committee, said he could not discuss any of the panel's considerations.

The Committee on Foreign Investment with help from officials in U.S. intelligence agencies, including the departments of Defense, Justice, Commerce, State, and Homeland Security, reviews foreign companies seeking to purchase or invest in American industry. Its 12 members reportedly found no problems with the sale.

However, critics say that port operations should not be controlled by a company whose home country served as a headquarters for the terrorists who carried out the Sept. 11, 2001, attacks.

"This shouldn't happen. It really boggles the mind," Rachel Ehrenfeld, director of the American Center for Democracy told the NEW YORK SUN, adding that the United Arab Emirates is "a big hub for all kinds of terrorist activities.... We know that terrorist money is being laundered there." The Republican minority leader of the New York City Council, James Oddo, expressed his feelings on the matter more colorfully to the Sun: "On its face, this looks like [expletive] insanity to me."

New Heat On Port Security

The outcry along the eastern seaboard started last Monday when British shareholders approved the DP World's purchase of London-based Peninsular and Oriental Steam Navigation Company which runs commercial operations at shipping terminals in New York, New Jersey, Baltimore, New Orleans, Miami, and Philadelphia.

The DP World/P&O Ports merger is scheduled to be finalized March 2. P&O Ports, the world's fourth largest



ports company, runs Manhattan's West Side cruise ship terminal and Newark's container port, and owns half of the Port of Miami Terminal Operating Company, which is responsible for cargo containers entering the harbor.

While Rep. Vito Fossella (R-NY) called for congressional hearings on the port deal, Rep. Ileana Ros-Lehtinen (R-Fla.), chairman of a subcommittee on the Middle East, urged a "full investigation" into issues involving security.

Middle East, urged a "full investigation" into issues involving security. The Port Authority of New York and New Jersey also reported that it will not only review the deal "to protect its interests" but also encourage the government to explain its decision-making process.

Port security in the U.S. has been a sore spot since 9/11, and an issue raised repeatedly during the 2004 presidential election season.

Sen. Charles Schumer (D-NY) said that outsourcing port operations is not a positive step to ensure national security and urged Secretary of Homeland Security Michael Chertoff to also review the deal.

"Should we be outsourcing our own security?" Schumer said on the Fox News Channel. "We have to have hands-on control of things. And to have United Arab Emirates — I mean, they are a country that's allied with the U.S., but at the same time a whole bunch of the (Sept. 11) hijackers came from the United Arab Emirates."

Schumer added, "I think there ought to be a full and public review before this company is allowed to control security up and down the East Coast. The issue is not the head of the company. I'm sure he's **Continued On Next Page**



been checked out. But how good is their security? How good do they check on their employees? Could people infiltrate this company a lot more easily than they could infiltrate an American company?"

In its defense, DP World points out that its purchase request was approved by all regulatory bodies, right up to receiving no objections from the Bush administration. The company said in a statement that it "intend(s) to maintain and, where appropriate, enhance current security arrangements."

"It is very much business as usual for the P&O terminals" in the United States, the statement added.

The UAE is a key partner against terrorism, according to the State Department, and participated in a U.S.led program to find illegal shipments of nuclear materials in Dubai's own ports last year.

Despite the detection program and the Bush administration's support for the UAE, lawmakers warn that the Emirates were a hub for smuggling nuclear materials to Iran, North Korea, and Libya by Pakistani scientist Abdul Qadeer Khan. In addition, the UAE still recognizes the Taliban as Afghanistan's legitimate government.

According to the director of the Institute for Gulf Affairs, Ali Al-Ahmed, the Emirates have been supporting the insurgency in Iraq by hosting Sunni insurgent supporters and Sunni insurgents

"If they're allowing this to happen in their country — al-Qaida activities and Sunni insurgent in Iraq activities — why shouldn't they allow it in New York, where it's going to be more and more valuable?" Al-Ahmed told the SUN.

The United Arab Emirates have a number of connections to the 9/11 terrorist attacks. For instance, the hijackers entered the U.S. from the UAE where the attacks were planned, and the UAE's banking system was used to transfer money to the hijackers for their operation, according to the FBI.

Sen. Schumer also noted that the Committee on Foreign Investment panel's decision "seems to have been unnecessarily fast-tracked."

Others wonder if the Bush administration stacked Dubai's deck in the approval process when last month it appointed David C. Sanborn of Virginia, a senior DP World executive, as the new administrator of the Maritime Administration of the Transportation Department.

But some analysts are less worried.

"Does this pose a national security risk? I think that's pushing the envelope," Stephen E. Flynn, a maritime security expert at the New York-based Council on Foreign Relations, told AP. "It's not impossible to imagine one could develop an internal conspiracy, but I'd have to assign it a very low probability."

DP World has entered into business agreements in the U.S. before when it purchased CSX World Terminals from Jacksonvillebased CSX Corp. for \$1.4 billion. The merger handed DPW terminals at ports around the world, including some in Venezuela.

Whistleblower: NSA Violates 'Millions of Americans'

WASHINGTON — Former NSA employee Russell Tice testified on Capitol Hill last week that another classified domestic spy program is more encompassing than President Bush's warrantless program that was reported to the public by the NEW YORK TIMES.

Tice told the House Government Reform Subcommittee on National Security, Emerging Threats, and International Relations that more than one "Special Access" surveillance program might be eavesdropping on "millions of Americans."

While Tice could not reveal the contents of the programs to the committee due to classification laws, he said he believes that the government is violating the Constitution and FISA laws. He said he could not tell the inspector general of the NSA because he does not have clearance either.

Rep. Dennis Kucinich (D-Ohio), through a spokesperson, said he wants a hearing on the program, though it would probably have to take place in closed session.

"Congress has a role to play in oversight. The (Bush) administration does not get to decide what Congress can and can not hear," said the spokesperson to United Press International.

Tice, now unemployed, was a National Security Agency intelligence officer stripped of his security clearance from the Defense Intelligence Agency was a spy. An official declared Tice paranoid after he took a psychological examination as ordered by the DIA.

Chertoff: Katrina Response Bumbled

WASHINGTON — Amid hecklers and needling senators, Homeland Security Secretary Michael Chertoff admitted last week that the federal government fumbled its response to the aftermath of Hurricane Katrina's Aug. 29 landing.

Chertoff testified before the Senate Homeland Security and Governmental Affairs Committee the same day a House report — "A Failure of Initiative" — was released, criticizing President Bush for his inept leadership as well as state and local officials for not responding more quickly during the crisis.

Senators from both parties took shots at Chertoff's office for its "Keystone Cop" performance, as Sen. Joe Lieberman (D-Conn.) went so far as to say while noting that the security chief went to bed before the storm hit.

The 520-page House report criticized the lack of urgency involved in the whole matter describing it as "a litany of mistakes, misjudgments, lapses, and absurdities all cascading together, blinding us to what was coming and hobbling any collective effort to respond."

Chertoff passed blame to former FEMA director Michael Brown, who stepped down days after Katrina hit, for his onsite response; however, Brown in testimony before the Senate investigative panel accused Chertoff and White House officials of creating a "cultural clash" between FEMA and the Department of Homeland Security when DHS took over control of the disaster agency in 2003.

The Senate panel will release its conclusions to the disaster response in March.

Mass. Board Orders Wal-Mart To Stock Contraception

BOSTON — The Massachusetts Board of Pharmacy unanimously voted last week to make Wal-Mart stock emergency contraception pills at its pharmacies throughout the state.

The board informed Wal-Mart's lawyers of their order with a letter that stated the world's largest retailer had to have provided written compliance by last Thursday.

A spokesperson for Wal-Mart said the Bentonville, Ark.-based company would comply with the order.

The board's move came two weeks after three women filed a state suit against Wal-Mart for refusing to sell the "morning after" pill in its Massachusetts locations. Wal-Mart sells the pill in Illinois only under state law.

The company has said it decides to sell or not sell quite a few products for "business reasons," though a spokesperson declined to explain further.

Cartoons Bad, 'War On Terror' Worst: Malaysian PM


KUALA LUMPUR — Malaysian Prime Minister Abdullah Badawi called for Muslims and the West to oppose radical religious groups in both societies "hell bent on keeping us apart" last week at an international conference here called "Who Speaks for Islam? Who speaks for the West." However, the current chairman of

the Organisation of Islamic Countries (OIC) added that the cause for anger toward the Danish cartoons depicting Prophet Mohammad as a terrorist was in reality directed to the U.S.-led "war on terror" in Iraq and Afghanistan and the linking of Islam with violence, both of which have strained ties among the cultures.

"We must acknowledge that in the West, principles such as freedom and equality have found concrete expression in the rule of law, public accountability, acceptance of political dissent and respect for popular participation. However, for a lot of Muslims today, this is not the face of the West that they see," Badawai told an audience of 100 academics and policymakers.

"They (Muslims) see the subjugation of Palestine as an indirect concretisation of this hegemony. They see hegemony manifested directly in the attack upon Afghanistan and in the occupation of Iraq," he added.

Leading Malaysian Islamic thinker Chandra Muzaffar told the Inter Press



Service that his country has not experienced such fury over the cartoons because it is "relatively free of the negative consequences of hegemonic trends."

"Muslims here don't feel dispossessed or have the same fear that Islam is under threat as Muslims in other countries like Palestine or Afghanistan and Iraq," he said.

Muzaffar acknowledged Badawi's view that Western hegemony seen in its foreign policies has caused Muslim insecurity.

rity. What Muslims have been witnessing in recent years is the stark consequences of global hegemony reflected in the slaughter of innocent Muslims in Palestine and Iraq, the humiliation of occupation and subjugation, the treachery of double standards and the machinations of exclusion and marginalisation," he said.

Malaysia's deputy prime minister Datuk Seri Najib Tun Razak blamed both Muslims and the West for allowing radical religious group to speak for Muslims.

"The terrorist who straps a bomb to his chest and blows up a shopping mall" has no more right to speak for Islam than a "newspaper editor who sees fit to ridicule a holy prophet who is venerated by more than one billion people around the globe," he said.

China Complicating U.S. Plans For Iran With Oil Field Buy *Congressman Ron Paul Says Iran Sanctions Are About Euros vs. Dollar*

SHANGHAI — Not unlike Iraq which threatened to trade in euros instead of dollars in 2000, Iran and a few other countries are flirting with the same pressure from Washington to keep the dollar as the standard, or else.

With a proposed monetary changeover in Iran approaching a March deadline, a Chinese state-owned energy company has added its own brandy to the mix, by hurrying to complete the \$100 billion purchase of a major oil field in Iran. Not only would the acquistion assist in China's growing thirst for oil, it casts a shadow on U.S. pressure to halt Tehran's nuclear advances.

According to CAIJING magazine, a Chinese delegation plans to visit Iran within weeks to conclude the agree-

ment, clearing China Petrochemical Corp. to develop the Yadavaran oil field in southern Iran. Their hope is to shortcircuit international sanctions against Iran.

In a speech before the U.S. House of Representatives last week, Congressman Ron Paul (R-Texas) warned fellow legislators about the end of dollar hegemony. "...after all these many years of great success, our dollar dominance is coming to an end," Congressman Paul said.

"The dollar/oil relationship has to be maintained to keep the dollar as a preeminent currency. Any attack on this relationship will be forcefully challenged—as it already has been," said Paul.

I felt like I got hit with a baseball bat, but after I squeezed a couple of pellets out of my thighs like so many pimples, (at which, as an adolescent, I was adept) I was fine.

My father was pretty angry about the whole thing.

First, Mr. Hutchison shot toward his cattle. Second, the store clerk shot toward his dog. Third, Dad knew I'd use the whole incident to skip farm work for at least two days.

Worse, he missed the bird.

It would be unfair to say I never forgave Mr. Hutchison for shooting me, but we never met after that day that it didn't come up in the conversation.

And we never hunted together again.

And he wasn't my friend.

Now, I have no idea what kind of vice president of the United States Mr. Hutchison would have been.

By all accounts he was pretty good at selling suits and hats.

So, for the life of me I can't figure out what Dick Cheney's hunting accident has to do with a damned thing. As even an occasional reader of my

As even an occasional reader of my drivel should know by now, anything I have to say about Dick Cheney is tempered by an opinion that he is the political equivalent of fire ants.

They also threaten quail.

But back to the subject at hand, I don't tell him when I'm going hunting, and I don't expect his notice next time he takes the field.

I doubt now I'd go with him, even if asked, but since there's little chance Cheney would invite me if somebody put

So if you just want to piss in his Post Toasties, maybe you could go hunting together. "In November 2000 Saddam Hussein demanded Euros for his oil. His arrogance was a threat to the dollar; his lack of any military might was never a threat. At the first cabinet meeting with the new administration in 2001, as reported by Treasury Secretary Paul O'Neill, the major topic was how we would get rid of Saddam Hussein though there was no evidence whatsoever he posed a threat to us. This deep concern for Saddam Hussein surprised and shocked O'Neill.

"It now is common knowledge that the immediate reaction of the administration after 9/11 revolved around how they could connect Saddam Hussein to the attacks, to justify an invasion and overthrow of his government. Even with no evidence of any connection to 9/11, or evidence of weapons of mass destruction, public and congressional support was generated through distortions and flat out misrepresentation of the facts to justify overthrowing Saddam Hussein," said the congressman.

"There was no public talk of removing Saddam Hussein because of his attack on the integrity of the dollar as a reserve currency by selling oil in Euros. Many believe this was the real reason for our obsession with Iraq. I doubt it was the only reason, but it may well have played a significant role in our motivation to wage war. Within a very short period after the military victory, all Iraqi oil sales were carried out in dollars. The Euro was abandoned," said Paul.

"In 2001, Venezuela's ambassador to Russia spoke of Venezuela switching to the Euro for all their oil sales. Within a year there was a coup attempt against Chavez, reportedly with assistance from our CIA," he added.

Congressman Paul says that now a new attempt is being made against the petrodollar system. He explained that whereby gold previously supported the dollar, now it's black gold.

"Iran, another member of the 'axis of evil,' has announced her plans to initiate an oil bourse in March of this year. Guess what, the oil sales will be priced Euros, not dollars," he said.

'The administration announcement in 2001 that Iran was part of the axis of evil didn't do much to improve the diplomatic relationship between our two countries. Recent threats over nuclear power, while ignoring the fact that they are surrounded by countries with nuclear weapons, doesn't seem to register with those who continue to provoke Iran. With what most Muslims perceive as our war against Islam, and this recent history, there's little wonder why Iran might choose to harm America by undermining the dollar. Iran, like Iraq, has zero capability to attack us. But that didn't stop us from turning Saddam Hussein into a modern day Hitler ready to take over the world. Now Iran, especially since she's made plans for pricing oil in Euros, has been on the receiving end of a propaganda war not unlike that waged against Iraq before our invasion," he said.

Paul continued, "But the truth is that paying the bills for this aggressive intervention is impossible the old fashioned way, with more taxes, more savings, and more production by the American people. Much of the expense of the Persian Gulf War in 1991 was shouldered by many of our willing allies. That's not so today. Now, more than ever, the dollar hegemony— it's dominance as the world reserve currency is required to finance our huge war expenditures. This \$2 trillion never-ending war must be paid for, one way or another. Dollar hegemony provides the vehicle to do just that.

"For the most part the true victims aren't aware of how they pay the bills. The license to create money out of thin air allows the bills to be paid through price inflation. American citizens, as well as average citizens of Japan, China, and other countries, suffer from price inflation, which represents the 'tax" that pays the bills for our military adventures. That is until the fraud is discovered, and the foreign producers decide not to take dollars nor hold them very long in payment for their goods. Everything possible is done to prevent the fraud of the monetary system from being exposed to the masses who suffer from it. If oil markets replace dollars with Euros, it would in time curtail our ability to continue to print, without restraint, the world's reserve currency.

"If this system were workable long term, American citizens would never have to work again. We too could enjoy 'bread and circuses' just as the Romans did, but their gold finally ran out and the inability of Rome to continue to plunder conquered nations brought an end to her empire.

"Once again Congress has bought into the war propaganda against Iran, just as it did against Iraq. Arguments are now made for attacking Iran economically, and militarily if necessary. These arguments are all based on the same false reasons given for the illfated and costly occupation of Iraq.

"There are no other countries that can challenge our military superiority, and therefore they have little choice but to accept the dollars we declare are today's "gold." This is why countries that challenge the system— like Iraq, Iran, and Venezuela— become targets of our plans for regime change."

Paul told fellow congressmen, "It seems that the people and Congress are easily persuaded by the jingoism of the preemptive war promoters. It's only after the cost in human life and dollars are tallied up that the people object to unwise militarism.

"The strange thing is that the failure in Iraq is now apparent to a large majority of American people, yet they and Congress are acquiescing to the call for a needless and dangerous confrontation with Iran.

"But then again, our failure to find Osama bin Laden and destroy his network did not dissuade us from taking on the Iraqis in a war totally unrelated to 9/11.

"Using force to compel people to accept money without real value can only work in the short run. It ultimately leads to economic dislocation, both domestic and international, and always ends with a price to be paid.

"The economic law that honest exchange demands only things of real value as currency cannot be repealed. The chaos that one day will ensue from our 35-year experiment with worldwide fiat money will require a return to money of real value. We will know that day is approaching when oil-producing countries demand gold, or its equivalent, for their oil rather than dollars or Euros. The sooner the better."







In the first place, in 1865 the population of Texas was scattered over an area almost as large as all the other "cotton states" of the Confederacy. Texas contributed 75,000 troops to the Confederacy of which less that 20,000 remained in the state to deal with both Yankee and Indian conflicts.

Southeast Texas was a multimillion cre thick, tangled mass of vegetation known as the "Big Thicket."

Texas had a 3,000-mile land and sea frontier with not near enough military available for its defenses. But, what it had was hell-bent and determined to protect its own from jeopardy. Miraculously, the Civil War was fought around Texas' edges and not in it.

were under Federal Army and Naval siege at times... from whence Union plans were to invade the state.


This never happened, owing to the heroic ef-forts of the Texas Confederate Army commanded by General John Bankhead Magruder and others of "like mettle" who repelled the Union

invaders on each and every occasion. From Sabine Pass, 800 miles to the northwest, Confederate war lord John Roberts Baylor captured what is now southern New Mexico and southeast Arizona.

Union Colonel Kit Carson was whipped soundly in the Texas Panhandle at Val Verde in 1864...no more Federal invasions were attempted from New Mexico.

The Confederate Navy was com-manded by Major Leon Smith, a former artilleryman and steamboat captain who had a brother that was a member of Lincoln's Cabinet in Washington...his name was Caleb Blood Smith. The South's Navy was feebly armed —on paper really no match for the Union gunboats and steamers. Major Smith lashed cotton bales to two small steamers used to carry mail.

Five Union steam gunboats were in Galveston Harbor inflicting heavy fire on General Magruder's men on the

scription hid out for all of the Civil War. These abstrusive, crass ne'er-do-wells were com-monly known as "Jayhawkers." Efforts to ex-tradite these lawless renegades were never

island. Major Smith showed his grit by ramming the Yankee gunboat

"Harriet Lane." The Yankees' fierce gunboats were not paying that much notice to the small cottonclads. Smith's sharpshooters, from be-hind the cotton bales, cleared the Goliath's decks, thereby capturing the ship. History records that the other four Union

gunboats participating in the bombardment and, according to Major Leon Smith, "behaved in a very unsportsman like fashion...steaming away from Galveston with truce flags flying. Such were the deeds of valor that kept invasionary Union forces out of the state.

In April of 1865, Union soldiers tried to ambush a Confederate outpost near Brownsville on the Rio Grande River. The Emperor Maximilian of Mexico had stationed troops on the border that alerted the Confederates that the Yankees were coming. The Rebels from the advantage of a selected rise shelled the Federal troops with their 12 pounders...before sending in the Cavalry to complete the rout...the Yankees broke ranks and ran, to the delight of the Texas Confederates. By virtue of some eastern newspapers, the Southern troops knew the war was already over.

Smugly, Colonel Rip Ford stated on the occasion, "Some of them damn Yankees could outrun our horses"...thus revealing the feelings and individualism that was primary to those Confederate Texans that we call ancestors.

The Reconstruction period after the war was humiliating to most ... General Phil Sheridan, the military dictator of the Southwest during Reconstruction, said in 1865 that he believed most Texans to be incorrigible rebels. He declared: "There is a very unwholesome state of affairs in Texas ... the Governor and the people

generally are disposed to be ugly." David S. Stanley, a Federal general, told a **Congressional Committee on Reconstruction** that "Texas is worse than any other Southern state because she has never been whipped."

In the summer of 1865, the land swarmed with armed and confused men under the "over rule" of Gen. Sheridan. He removed several Texas Governors from office "as impediments to Re-construction." Oligarchy prevailed, giving rise to an atmosphere where most any man could mask his reputation earned by past deeds against the North.

General Albert Pike retired as Indian Commissioner and returned to his ranch which was between Meridian and Iredell in Bosque County.

Pike also served 32 years as Grand Commander of the Supreme Grand Council of Scottish Rite Masons in the Southern Jurisdiction of the United States

General Pike on several occasions spoke of John Wilkes Booth frequenting this area of Central Texas.

Pike said that, to his surprise, once he happened upon Booth in a Fort Worth bar and that he had met Booth prior to that in Washington, D.C. some years earlier and had been in his presence numerous times. It seems that Johnnie Booth was also a Mason.

Barnard's Mill was built in 1860 by Charles Barnard on the north bank of the Paluxy River, a few miles before that copious stream entered the Brazos River

In January 1860, there were maybe 30 families residing in the territory between Bosque and Hood Counties that is now Somervell County. The small hamlet of Barnard's Mill changed its name in the early 1870s to Glen Rose. There were almost no roads in the territory, only wagon trails leading to where-ever early trade demanded.

Men relied on 'lynch law' in the territory where organized courts did not yet have authority. Those were the years between 1855 and 1875, when Somervell County was formed. The Indians remained a threat until the early 1870s.

Somervell County history gives detailed narration of a man living in its midst that was in fact John Wilkes Booth, alias, John St. Helen, as also revealed Hood County's history. It seems that James Fairly, formerly the

County Judge in Glen Rose, was host to many gatherings. He entertained among his numerous guests a "brilliant conversationalist," a man of mystery who called himself John St. Helen. Those present were enthralled with his rhetoric ... he was an enigma that locals enjoyed; however, a real puzzlement. Who was he?

Legend has it for most of this last century and a half, that this man of charm and mystery was none other than John Wilkes Booth, the assassinator of President Lincoln and that he had not met the "Grim Reaper" in that fiery barn in Virginia as claimed. John St. Helen had lived among the early

Paluxy Valley folk for a time unrecognized where he operated a small store on the grounds of Barnard's Mill on the Paluxy River.

One frequent patron of St. Helen's store, Frank McCoy, not schooled in the theatre, found him to be "halfmad" with his spontaneous orations, but pleasing to the ear. However, McCoy's description of St. Helen presents a picture of a person that matched that of Johnnie Booth, the actor.


St. Helen, abruptly one night, rode away from his little store at Barnard's Mill, never to return. This incident of hasty departure, according to Frank McCoy, was prompted by the arrival of Cliff Scott. Scott was a young resolute United States Marshall, who had come to claim the Mill operator's attractive sister, Annie Jordan.

Apparently, St. Helen traveled only 16 miles that night to Granbury in Hood County, where his cousin Fannie Booth Rhea lived.

Mrs. Ed Aiken saw St. Helen (Booth) and recalled her impressions of the man at the time. He was unlike other local men of Granbury and it was easy to fixate and rivet his image in her memory. He was very hand-some and a dark-complexioned man of about 35 or 40, who limped as he walked, favoring his left leg. Mrs. **Continued On Next Page**

Congressmen Butt Heads With President Over War

Jeff : McLemore, a feisty freshman congressman from Texas, butted heads with Woodrow Wilson on Feb. 17, 1916, over the president's about-face toward the European war.

Though surprised by the violent eruption of ancient antagonisms in 1914, most Americans took only a passing interest in the distant conflict. Above all, they wanted no part of the foreign feud, a consensus which produced the presidential pronouncement that the United States "must be neutral in fact as well as name."

Anti-war sentiment was particularly strong in the Lone Star State, according to a prominent Democrat. In a letter to Col. Edward M. House, a fellow Texan and Wilson's key advisor, he reported, "an

Aiken got to know Fannie Booth well. She said that Fannie told her that she had first met St. Helen several years earlier when he had come to see her father ... a blood relative.

Fannie received St. Helen as a proper cousin should. While staying with Fannie, St. Helen made her pledge to him that she would not reveal his true identity as being that of the infamous John Wilkes Booth ... nor did she ever tell anyone.

As fate would have it, while in Granbury and working as a bartender, St. Helen became gravely ill with pneumonia. Fearing that he was about to grasp his last breath, he asked the tavern owner, where he worked, to ride to Dallas and fetch a priest. At his bedside, in the presence of the churchman and several others, he asked for Benediction, and then confessed that he truly was John Wilkes Booth.

Again, Johnnie Booth had escaped the "Pale Horse" of death sent by the "Prince of Darkness." He, somehow, recovered completely and vanished from Granbury.

Cousin Fannie Booth was quizzed many times as to where he had gone ... her reply was always the same, "Out West."

Do you find it hard to believe that John Wilkes Booth, the assassin of President Abraham Lincoln, could have dwelt among our grandfathers' fathers for nigh-on to three decades?

Then, let me remind you of Greatgranddad's mind-set about the Civil War:

In Texas alone in 1865 and 1866, just after the war, there were 500 indictments for the murders of disloyal men to the South ... yet not a conviction was had.

On March 30, 1870, Texas was re dmitted to the Union by President Ulysses S. Grant. Indeed, this was the same Gen. Grant who was upset with and turned down Lincoln's invitation to Ford's Theatre that fatal night.

Today, the sky has resumed its brilliant hue of blue and the stars twinkle ever so celestially. But, as yet, on certain dark nights, if you really listen with all your being, there seems to come the thunder of hoof-beats of the "Gray Phantoms" as they parade "The Stars and Bars" through the hallowed halls of Texas and Confederate history ... with no regrets. overwhelming desire for peace, not perhaps at any price, but at most prices, which is altogether unprecedented in the history of this country."

The plot thickened in May 1915, when William Jennings Bryan resigned as secretary of state in protest of Wilson's tilt toward the Allies after the German sinking of the "Lusitania." In autumn appearances in Dallas and Houston during a coast-to-coast speaking tour, the threetime candidate for the White House warned against the dire danger of militarism.

Wilson's November 1915 announcement of a preparedness plan, widely interpreted as a prelude to U.S. participation in the war, galvanized his Texas critics. A coalition of clergy, farmers, prohibitionists and pacifists countered with a campaign against the military build-up.

Long an advocate of replacing the expensive standing army with a citizen militia, Oscar Callaway denounced the increase in defense spending as wasteful warmongering. The West Texas congressman from Comanche declared in January 1916, "Europe is on fire all right, but there is about 3,000 miles between us and the conflagration."

THE DALLAS MORNING NEWS tried to drum up support for the embattled administration by posing the question, "Are you for or against the president in his stand for preparedness?" The newspaper claimed that 20,000 readers responded to the "poll" and gave Wilson a 20-1 vote of confidence.

A new crisis surfaced on Feb. 15, 1916, when Wilson hinted that Germany would be held responsible for American lives lost in submarine attacks on Allied shipping. Two days later, Jeff: McLemore introduced in the house of representatives his so-called "warning resolution" advising U.S. citizens to avoid vessels subject to sinking by the Germans.

The Austin magazine editor, who used a colon to abbreviate his middle name, emerged overnight as the symbolic spokesman of the nationwide movement to stop the steady slide toward war. Spurning appeals to party patriotism, McLemore insisted the president was not above reproach merely because he was a Democrat.

Wilson mustered sufficient support to table the warning resolution in the house and a similar measure in the senate. Nevertheless, half of the Lone Star delegation put their careers on the line by siding with their controversial colleague.

In addition to Oscar Callaway, praised by his hometown paper for an "absolute lack of fear of criticism," others that dared to break party discipline included Cyclone Davis and James Luther Slayden. The former was a fiery populist recently readmitted to the Democratic fold, while the latter was a past president of the American Peace Society and an 11-term incumbent from San Antonio.

"He kept us out of war" was the ironic slogan of Woodrow Wilson's reelection campaign and the key to his narrow victory in November 1916. McLemore and Slayden survived administration-sponsored challenges in the Democratic primary, but Callaway and Davis went down to defeat.

Five months later, President Wilson requested a declaration of war against Germany. McLemore stood his ground and sealed his fate by casting a "nay" vote.




"I am not yet ready to vote absolutism to any president," explained the plainspoken politician, "nor will I ever vote to abrogate the Monroe Doctrine by forming any alliance with the warring nations of the Old World."

Slayden, however, decided to go along in order to maintain his "usefulness in Congress." The war, he rationalized, was "an accomplished fact." If Slayden thought his late conversion would patch things up with the party hierarchy, he was sadly mistaken. An election eve statement from the White House, which questioned his loyalty to the president, forced the congressman to abandon his bid for a twelfth term.

The state legislature removed the remaining thorn from Woodrow Wilson's side by redistricting Jeff : McLemore's at-large seat out of existence. No quitter, he entered the Democratic primary in a Gulf Coast district but finished a poor third.

The pro-war purge was complete.

I know it sounds weird, but I think that's what Goat Boy would have sug-


gested. "Goat Boy" is the late comedian Bill Hicks.


Go back to bed. Alone, that is.

IRS's New Dungeons & Taxes

Virtual characters, virtual items, virtual money and, now, virtual taxes.

The Internal Revenue Service may soon be taxing game components that don't exist outside an imaginary computer-generated game world.

Trading game components for the Massively Multiplayer online role-playing games such as EverQuest, Ultima Online, Star Wars Galaxies, City of He-roes and World of Warcraft, are now being threatened with taxation.

Players buy the games, then participate online with thousands of other purchasers

The player selects or creates a character such as a warrior or wizard, then starts on a quest doing battle with other players or game-generated enemies. The character can "earn" advantages, or game components, such as imaginary weapons, potions and other "devices that give enable the player to compete more successfully.

These components can be traded for other game pieces, or "bought" with 'game money.

But these massive multiplayer online games, often called MMOs, have now become a new source of real income.

"On April 15, 2004, I will truthfully report to the IRS that my primary source of income is the sale of imaginary goods-and that I earn more from it, on a monthly basis, than I have ever earned as a professional writer," wrote Julian Dibbel, in "Legal Affairs," an online magazine dedicated to issues of law

Dibbel said he made a total of \$11,000 on eBay selling imaginary goods that his

character had won, \$3,900 of which was in the final, most profitable month. All on a game called Ultima Online.

'It's ridiculous; it's just a game," said Levi Barner, a long time MMO gamer, "It's a private transaction between two people. The IRS is just trying to get people's money. And how are they going to track down every single sale?

To play these online games, some kind of connection to the internet is required. CD's to download the game can be purchased at almost any computer or video game store, along with a game card for those who don't want to give your credit card number out over the internet.

Almost all MMOs require a monthly

fee, ranging from \$10 to \$15. "Why the sudden interest? That's what I want to know," said an online trader. who refused to give their real name out of IRS fear.

"I have done this for about 5 years now, and it's getting me through college. I worked at a game store, but that wasn't enough. I'm making more money now than I did working there. Why does the IRS want to tax money that doesn't really exist?

EverQuest, an online game with 450,000 subscribers, has playable characters that range from Wood Elves, a race

of humanoids that live in trees, to Vah Shir, a cat-like race from the moon. In the virtual world, the kind of imaginary economic activity can be measured in real-world terms like "gross domestic product.

"Eh, it's not going to change the game really," said Ben Borom, another long term gamer, "It's still going to be a game, and soon it will fall and a different game will take its place.'

But just how much do these items and accounts cost?

Try \$650 to \$1300 for a high level character on any given game. Even \$35 to \$40 for large amounts of currency. This leads up to a possible \$880 million exchanging hands, according to e-Bay pricing totals.

Getting fair prices on these virtual currency/dollar exchanges can prove challenging, since there is no reliable data to get a set value.

"I have looked at this data acquisition issue for some time and...keep hitting a brick wall," said Dan Hunter, an assistant professor of legal studies and business ethics at the Wharton School of the University of Pennsylvania.

These transactions take place in the real world and the online world. An advertisement of the product is sold on an online auction, such as eBay, and when the real cash money is received, the players will meet back up in the game to exchange the money.

There are now even online companies, such as IGE or a Chinese website called GameUSD, that will sell online currency, acting like a "middle man" to sell to other players.

Gamers expressed worry about just how far this will go, taxes now, then insurance claims next week.
