

WASHINGTON — Bipartisanship began to take root at a Senate Armed Service Committee hearing last week when Army Gen. Bantz Craddock testified that China is training more and more Latin Americans in military techniques.

tary operations in Latin America, said for the first time, the Chinese are taking advantage of a U.S. law that stops countries from receiving U.S. military training if they allow U.S. citizens overseas immunity from the International Criminal

Since 12 Latin American countries have rejected granting such immunities to the United States, they are not only now candidates for sanctions but they are also opening their doors to Chinese military training and aid.

### 'Islamophobia' Spreading: Survey

found that more Americans than ever since 9/11 think that Islam teaches violence against non-Muslims. With this news, however, more U.S. citizens who are Muslim are reaching out to their communities to promote the value of peace within the Islamic faith.

A Washington Post-ABC News poll showed that 58 percent of 1,000 people interviewed by phone last week believe that Islam has more violent followers than any other religion. Thirty-two percent currently believe mainstream Islam encourages violence against

To account for the current state of "Islamophobia" in the United States, analysts point to the recent media coverage: the U.S./U.A.E. port controversy; the secretarian violence in Iraq; the election of Hamas by the Palestinians; and protests against cartoons of the prophet Muhammad.

Muslim civil rights groups, however, argue that anti-Muslim sentiments have not wavered in the United States since 2001, largely due to the fact that politicians and talking heads in the media continue to demonize their culture.

Still, Muslims remain vigilant, promoting open houses at area mosques, such as the one at the Plano Masjid in Plano, Texas, on Saturday, April 1, from 1:30 – 4:30 p.m.

### **Senate Prevents Default On U.S. Treasury Notes**

WASHINGTON — By a 52-48 vote, the Senate Thursday prevented the first-ever default on U.S. Treasury notes by increasing the national debt ceiling by \$781 billion to almost \$9 trillion. The bill awaits President Bush's signature.

With this measure, the U.S. government can cover the costs for the war in Iraq, Medicare, and other programs without increasing taxes. Later in the day, the House okayed another \$91 billion to pay for the war in Iraq and more aid to victims of hurricanes.

Democrats criticized President Bush of fiscal abuse because this is the fourth time the debt limit would be increased since he came into office when the government had record surpluses. The Republican who spoke in favor of the bill said it was needed to cover the war on terror in a post-9/11 world.

By a 55-44 vote, Republicans, however, killed an amendment to the bill that would have required a study be performed on the economic dangers of the U.S. debt in foreign hands, one-fourth of which is currently allocated to them.

### **U.S. Keeps Preemption Policy: Report**

WASHINGTON — Days before the third anniversary of the U.S.-led invasion of Iraq, the Bush administration announced that its policy of preventative first strikes against would-be enemy states remains fully active when diplomacy is exhausted.

The report entitled "The National Security Strategy of the United States" not only reiterated the hardline defensive stance the U.S. government would take in foreign affairs but also could be taken as a warning to states such as Iran with whom President Bush currently suspects of having a nuclear weapons program and a part to play in destabilizing Iraq.

Since President Bush during his 2002 State of the Union address named Iran, North Korea, and Iraq the "Axis of Evil" and presented the doctrine of preemptive war, which had already been a longstanding U.S. policy tactic, tensions flared up with Iran only to rise with the March 2003 U.S. invasion of Iraq.

At the time in 2003, President Bush called for the invasion on claims that Iraq had intent to use "weapons of mass destruction" on the United States. These claims have since been discounted because no such illegal, unaccounted weapons have been found there. Other claims the Bush administration used to trumpet for war, such as those that Iraqi leader Saddam Hussein and terrorist leader Osama bin Ladin are allies, have also been proved false.

The 2006 report outlines the Bush administration's strategy in dealing with the international community, specifically targeting countries that the president's feels threatens the values of democracy, freedom, and human rights -North Korea, Zimbabwe, Syria, China, Russian, and the Palestinian government controlled by Hamas.

Law requires the Bush administration to release one NSS report each year; however, the last NSS report was published in 2002.

### Mad Cow Case Found In Alabama

WASHINGTON — The third case of mad cow disease in the United States has been found in Alabama, according to the Agriculture Department last Monday.

A government laboratory in Ames, Iowa, confirmed the finding: a beef cow about 10 years of age that hadn't entered the food supply, said a department offi-

The cow had apparently spent a year at an Alabama farm. The department plans to investigate further into the animal's history.

Two other cases of mad cow disease have been found, one in Washington state in 2003 and another in Texas last June.

U.S. lawmakers originally approved the measure out of fear that the ICC might prosecute American citizens under political motivations, though the court was sponsored by the United Nations four years ago to bring war criminals to justice. In 2003, roughly 771 military personnel were trained by U.S. authorities stationed in the current sanctioned countries, said Craddock.

Called for the elimination of the law came from both U.S. political parties on the Senate committee. While Sen. Hillary Clinton (D- NY) referred to the Chinese actions as "one of the most serious problems we face," Sen. John McCain (R-Ariz.) suggested the amendment be repealed through a emergency spending

bill already in consideration, Craddock added that Venezuelan President Hugo Chavez was not helping the United States' situation either by exporting his "extreme populist movement" to countries such as Peru and Nicaragua. both of which will have presidential elections later this year.

Chavez's oil-rich country has steadily strengthened economic ties among his Latin American neighbors. Last week, Brazil and Venezuela brokered a \$3 billion sale of Brazilian oil tankers to Chavez's state-run oil company. Venezuela has also bought \$2.5 billion of Argentina's debt, a move that replaced financing from the International Monetary Fund to the dismay of free-market advocates.

Chavez has also opened relationships with the leader Communist Cuba Fidel Castro and newly elected Bolivian President Evo Morales, and shown solidarity to Iran's civil nuclear power aspirations, all of which have not seemed to lose Chavez much support at home and in South America.

### **Congress OKs** \$1 Billion More In Energy Aid

WASHINGTON — By a 287-128 vote, the House last Thursday approved an extra \$1 billion in federal aid to cover the rising energy costs for Americans with low income. The total cost spent on the Low Income Home Energy Assistance Program, which the Senate passed the week prior, is more than \$3 billion for this year. President Bush is expected to sign the bill.



FRANKFORT, Germany — F. William Engdahl has eyed Big Oil's effects on geopolitics for over 30 years and hasn't looked back.

Since the first oil shock and world grain crisis in the early 1970s, he has covered the GATT Uruguay Round trade talks, EU food policies, the grain cartel, IMF policy, Third World debt issues, hedge funds and the Asia crisis.

The native Texan/current resident of Germany has also authored a best-selling book on the subject called A Century of War: Anglo-American Oil Politics and the New World Order published by Pluto

While reporting, Engdahl wears his economist hat he received as a graduate study in comparative economics at the University of Stockholm. He also earned a degree in politics from Princeton University and worked as an economist and journalist in New York and in Europe.

Engdahl has contributed regularly to a number of publications including Japan's Nihon Keizai Shimbun, Foresight magazine; Grant's Investor. com, Euro-PEAN BANKER AND BUSINESS BANKER INTER-NATIONAL.

THE LONE STAR ICONOCLAST'S Nathan Diebenow recently phoned Engdahl in Germany to discuss the effects of Iran's possible oil bourse on the U.S. dollar hegemony, Russian technology as a discredit to the peak oil controversy, and the impact of the so-called "color revolutions" on China and Russia.

ICONOCLAST: How did you get started focusing on oil and geopolitics?

F. WILLIAM ENGDAHL: That's something that is hard to give a short answer to. Basically, I've been looking at the world in sense of politics, geopolitics, international politics for 30 years or so. I started as a journalist in New York during the first oil shocks. I got very intrigued then by the enormous power of Big Oil suddenly. Then it was called Exxon, Mobile, the Seven Sisters — just overwhelmed all other corporations in terms of annual cash through-put. Oil was king in those days, 1973, '74, and '75.

but my education background is in economics and politics. I think I have a little sense of history, again looking at these things. I got curious and then started digging. I guess I'm a habitual digger. I'm always unsatisfied with the surface of stories. I look behind the facade or try to dig deeper to find out where something comes from. That's been with me in my whole life.

ICONOCLAST: One thing that was digging at me was how petrodollars, the fusion of the U.S. dollar to the price of oil,

That kind of caught my attention, if you put it that way. I've been looking at the world ever since, slowly building up a sense of history, a sense of process, where they came from and where they seem to be going. That's the short an-

ICONOCLAST: So your education base is journalism?

ENGDAHL: No, no, no. Not at all. I never studied journalism. God forbid.

ICONOCLAST: (laughs) ENGDAHL: I hope I'm not insulting

anyone. ĬCONOCLAST: No, no. (laughs)

ENGDAHL: Okay. No, I just started writing. I pieced together things that I saw. I did interviews. I kind of self-taught,

relates to international politics. It seems like this cycle of violence in the Middle East is starting up again but this time between Iran and the United States. With regard to the U.S.-led invasion of Iraq, you theorized that invasion happened in part because Saddam was threatening to change from the petro-dollar "the enemy's currency," as he put it, to the petro-euro

ENGDAHL: I wouldn't call it a petroeuro. He made a deal with the president of France and the BMP Party to sell the "oil for food" oil in euros in 2000. That was an irritation, I think, for the U.S. Treasury and the hegemony of the dollar, but little more than an irritation until a lot of other nations, for example, Iran, some of the

OPEC member countries, Venezuela, and even Russia began to talk about, "Well, it's much more logical to price oil in euros because most of our trade goes to European countries.

So that was I think an aspect, but only an aspect, of the decision to go to war against Saddam Hussein. I think it was a relatively minor, even though I three years ago thought it perhaps was a major, factor, but in retrospect, it was a factor but relatively minor factor. The real point in all this, and the reason I think you have an administration in Washington with the former CEO of Halliburton geophysical resources Dick Cheney and several other people steeped in the oil business is, this administration unlike the Clinton administration, sees its major agenda item as securing with military means if necessary all the major oil fields of the world. It's a big order, but they seem to be doing it.

ICONOCLAST: So the petro-dollar is

only one little aspect of it?

ENGDAHL: I think so. That's my conviction. I think it could have been a factor, but wasn't the factor as some people have claimed it was. The reason I say that, you can look back to the year 2000 even before the pricing in petro-euro, if you want to call it that, took place, and you had a report in September 2000 from the Project of New American Century which included Dick Cheney, Don Rumsfeld, Jeb Bush, and vice president of McDonald/Douglas, and several of the neo-conservatives who are close to the current administration. They called for a pre-emptive war against Saddam Hussein and a military taking of Iraq,

even if there was no military threat or weapons of mass destruction. That was in 2000 of September, months before the pricing of oil in euros by Iraq.

ICONOCLAST: Okay, so Project already had a plan in place.

ENGDAHL: To understand this you have to step back and look at how people like Cheney view the projection of the supply and demand of global petroleum over the next 20 years. Back in 1999 at a speech at the Institute of Petroleum in London, a bunch of oil industry good old boys, Cheney as CEO of Halliburton outlined the prospect by I think 2020 the

world is going to need given the fact that oil fields like the North Sea, Alaska, and certain fields in Mexico and elsewhere, are depleting at a very dramatic rate now, they have reached a so-called aging phase that

the world will need 50 million barrels of new oil discoveries online by 2020.

Right now we have a world production of 84 million barrels a day, so where is the world going to find 50 million new barrels? But Cheney was optimistic. He said, "Well, we know where the oil is. There's only one place in the world where it exists in such abundance. It's so easy to tap and that is the countries in the Middle East. There's only one problem with those countries, however. All the oil companies are in state-owned hands.'

Cheney didn't elaborate, but he means that the state-controlled oil in Iraq, the state controlled oil in Iran, Saudi Arabia, and elsewhere between now and 2020 has to be put in the hands of private interests. For sure he was thinking of Exxon/Mobile, Chevron, Texaco, and a few of his chums in Houston there in the oil trade. ICONOCLAST: Looking back, the

Bush administration was already thinking about resorting to violence to take over the Middle Eastern oil.

ENGDAHL: I think they were thinking about taking it over, but I don't know if from the get-go that violence was uppermost on the agenda. Perhaps they thought they could cut a deal with Saddam Hussein. I just don't know. I'm not privy to that. But the idea of taking direct military control of the Middle East – I mean, this has been inching in that direction since the 1970s, and as soon as the Bush administration came in, Paul O'Neil, the former Treasury Secretary under Bush who was fired because he simply spoke his mind — Bush is a team player as you probably know in Crawford,

ICONOCLAST: Oh, yeah. (laughs) ENGDAHL: Paul O'Neil has said in his memoirs after he left office that almost from the first day he sat on a meeting in early 2001, something like March or April, Bush, Cheney, and other the Cabinet were talking about how we can get Saddam Hussein, so that tells me that this is a long-term project.

I think the way to understand this (is to ask) why does Big Oil suddenly need to militarily control Iraq, Iran, and some of these Middle East oil sources? And the answer to that, if you look at a map, and I urge your readers to do that—look at a map of Eurasia. Eurasia is the term for the continental landmass which goes from France all the way on the Atlantic Coast to Vladivostok, Russia on the Pacific Coast. It includes China, Russia, Azerbaijan, and all the oil rich countries in Central Asia and the Caspian Sea. It also includes the countries in the Middle East.

Several of the Washington strategists and presidential advisors openly said the number one policy of the United States is to prevent the emergence of any global super-power combination that could conceivably threaten American hegemony, so the emergence of China over the next five-10 years is right now considered within the administration, as far as I can see, the number one geopolitical threat — not Iran, but China.

I think that close on that is the reckoning about Russia because Russia has number one — oil, it has resources, it has raw materials, which western Europe China, to ally with Germany, to ally with France and to create a counterweight to this unbridled U.S. power.

I, as an American, feel more than uncomfortable. I think it's obscene the fact that one country, even though it's my own country, literally dictates life and death over virtually a 130 nations on this planet simply according to whims over some people in Washington who have a very dubious record of personal morality, to say the least.

ICONOCLAST: (laughs)

ENGDAHL: And aren't very good bird hunters either.

ICONOCLAST: (laughs) Oooooh! o Saddam Hussein was a pushover compared with Well, I did want to Iran. Iran is impenetrable by ground forces. It's very ask you about the mountainous. The Iranians have prepared them-Iranian oil bourse. Why do you say selves very well for this situation, and I think it would that it may or may be the beginning of the end of the United States as not go through?

ENGDAHL Well, let's see. It may not

through and it may be a success. But I think it's more a technical factor in terms of Iran selling most of its oil to places like China and Europe where the currency is the euro so they can sell their oil for Chinese yuan. The Chinese provide Iran with a lot of equipment. They provide Iran with military defense material so that would make sense. Why lock yourself in the American dollar to sell your oil and then reexchange it for euros or for Chinese yuan? Why not deal directly and you'll avoid the currency risk because some people think the dollar is highly, highly overpriced and highly vulnerable to crash in the next month.

ICONOCLAST: In the next month! ENGDAHL: There are certain aspects

of the Iranian oil bourse that technically could work. I think also the Iranians see this as a pin prick irritation to the Americans to simply start pricing oil in euros It's kind of a no-no since the 1973 oil shock. Washington has always insisted that OPEC countries sell only in dollars. It's not much of a problem as it was then. Today the prompt is more of the recycling of Chinese trade surpluses into the dollar and into the U.S. Treasury bond mar-

ICONOCLAST: So this bourse could only be a minor irritation to the U.S. economy

ENGĎAHL: Yeah, I don't see it as a major—the crucial question is there's one major reserve currency in the world still today and that is the American dollar, even though the dollar is no longer backed by gold. The reason that has been possible to keep despite the hollowing out of the industrial economy in the United States in the last 20-25 years and despite the fact that the debts and the trade deficits and the federal budget deficits are stratospheric in dimension over the past five years especially — all those things would speak for the collapse of the dollar as a worthless paper currency — why hasn't it collapsed? Simply because the United States has allowed countries like Japan and China to import without restriction in order that they recycle those trade dollars. These aren't petro-dollars. These are trade dollars — hundreds of billions of dollars a year into American treasury bonds.

What does that do? That makes the interest rate on treasury bonds, which are the bench mark of the entire domestic economy in the United States, far lower than it would have been would the Chinese, Japanese and other trade partners were not doing that. They do it partly because they are afraid that if the dollar collapses, their exports will be overpriced and they won't be able to make the trade. So it's a devil's circle and it's a very conscience one. Washington has realized this since 1971 when Nixon closed the gold window and slammed it shut in the New York Fed and said, "We no longer give gold for our paper dollars." France, Germany, and several other countries were asking for gold and they were simply left on a lurch.

I developed that in some length in a book I wrote called "The Century of War." It's available through the University of Michigan Press in the U.S. and Pluto Press in Britain. If people are interested, order that at any bookstore and learn more about how that worked.

ICONOCLAST: You made a statement about why do we give nuclear technology to India but we're upset that Iran is getting it. I see a similarity in the sense that, why does the United State choose to violently invade Iraq and allegedly help stage a coup against Hugo Chavez in Venezuela on the one hand but help fund these non-violent so-called "color revolutions" like in the Ukraine? Why use violence in one area and why use nonviolence in the other, you think?

ENGDAHL: I think that quite simply it's whatever works. The thing against Chavez failed dramatically because Chavez I think has a fairly strong popular base and that's something that is difficult to uproot.

The color revolutions in Ukraine, Georgia, and Serbia and so forth were backed by the U.S. State Department, the National Endowment for Democracy, Freedom House, which is an organization headed up by former head of the Central Intelligence Agency James Woolsey. These were effectively the kind of destablizations that the ČIA did directly in the '50s and the '60s but now are done by private agencies like the Soros Foundation and the National Endowment for Democracy.

The goal was to put in hand-picked puppets to be, for example, Mikheil Saakashvili in Georgia. The country Georgia in the Caucasus lies on the critical pipeline route going from the Caspian Sea into Turkey which is a NATO country and is very close to Washington, so if they didn't have somebody who was in their pocket in Georgia, their whole pipeline route would have been threatened. So James Baker went to Georgia and prepared that color revolution personally, and the one with Ukraine - Ukraine is the cross roads of almost all the natural gas pipelines going from Siberia into Western Europe, so if Washington controls Ukraine, then it has the potential to simply choke off the lifeline of the Russian economy.

This is part of an encirclement of Russia which has been going on since the end of the Cold War really in very incremental steps, and to my mind, it's a highly dangerous geopolitical game that Washington is engaged in because the Russian Tiger does still have nuclear teeth. They have a few cavities, but they're still nuclear teeth.

ICONOCLAST: With your knowledge of the Big Oil industry, where do you stand on this argument about "peak oil?" Are we past the peak? Have we yet to hit it?

ENGDAHL: It's a very complicated question. I recently wrote an article for a German newspaper, "Confessions of an Ex-Peak Oil Believer." And I was very taken by the peak oil thesis, but I ran across several of its advocates back in 2003 or so. I've met Golden Campbell and most of the people who advocate this thesis. I increasingly began to have doubts with the way it was being argued that Continued On Next Page

does India play in all of this?

ENGDAHL: Well, about one year ago. the Bush administration turned to India as a strategic partner and a counterweight against the growing power of China in Asia, and they simply said, "We want to get a foothold in Asia and India is our best bet." So the United States is trying to play, if you will, kind of a British geopolitics or a balance of power politics against China in Asia by offering carrots to India. Ironically, they are assisting India in exactly the same kind of civilian nuclear program that Iran is trying to build, and that doesn't enter into the calculus. So you have to ask why some countries with nuclear potentials are considered black sheep and why others are considered allies. It's kind of a funny calculus.

ICONOCLAST: Going back to Iran, so are we bullying Iran because of its supposed nuclear energy aspirations or is it mainly having to do with oil or is it mainly about Israel?

ENGDAHL: Well, I think all of the above, if this were a multiple choice test. ICONOCLAST: (laughs)

ENGDAHL: The Iran situation is far more complex than Iraq was by orders of magnitude for the simple reason that it's three years after the attack on Iraq, and it's very clear to Iran back in March 2003 exactly just what nastiness the U.S. is capable of. Number two, Iran has quietly been building its defenses because the President of the United States made a State of the Union address in January 2002 where he said Iran, Iraq, and North Korea are the "Axis of Evil," whatever that means.

So Iran knew it was on the target list and that, by the way, was well before Iran decided to make an oil bourse which may or may not go ahead this spring. But going back to the main point — the complication — Iran would be a crucial chess piece in a great game of the new version of the British great game in central Asia from the last century. Iran would be a major coup in the march to encircling Russia and controlling the potentials of Russia to ally with Iran, to ally with

everything, well, it goes back to peak oil; the world is running out of oil; we suddenly have to prepare for catastrophe, starvation and whatever.

But there's a much more interesting reason I'm an ex-peak oil believer, and that is, I think the idea that petroleum is a fossil fuel, the idea that petroleum is a

biologically based material which was formed hundreds of millions of years ago under pressures of rock on top of dinosaurs, plankton and algae — to have a trillion barrels of oil produced in the last, you're going to have to have quite a few dinosaurs packed belly-to-belly nose-to-

nose 10 deep or a hundred deep to make that kind of biological matter.

But the Russians have developed ac-

tually during the Cold War - it was a national emergency to get energy independence — and their geologists said, let's look at where oil comes from in a very scientific way. After several years of research and experiments, actually testing their theory, they came to the conclusion that petroleum is formed deep, deep, deep under the earth's mantle under granite and not close to the surface as you find it in Saudi Arabia and places like that. It has come close to the sur-

face of those countries. That's not the origin of it, and they tested the hypothesis and drilled very deep into this granite and through the granite and found oil, lo and behold. What they found was oil that didn't run dry. It kept being created, so to speak, deep in the earth. It's like a huge oven that has enormously hot temperatures and enormously high pressures, and through that, you create petroleum not too much unlike how diamonds are created. Then through shifts of tectonic plates and so forth on the earth's surface, the oil can seep up close to the top.

American geologists for the last 100 years have been lucky because they have been able to access cheap easy oil. Since 1945, they have controlled Saudi Arabia. The royal Saudi house is very dependent on U.S. military support, and as long as they have cheap and easy oil, they didn't have to worry about it. Now, what's happening is that they don't have the technology to drill these deep wells, and the Russians do, so the wells that they do have, many of them are beginning to deplete, and production rates are declining. That's very real. The Russians maintain that can be corrected if you know how to do it. They claim they've done it and that's why Russia today is the second largest oil producer next to Saudi Arabia. That's an impressive record.

I began to have doubts about the Peak Oil thesis. I came to the conclusion that it, in effect, helps Big Oil, Exxon/Mobile, etc. slowly raise the prices to levels where they're making obscene profits now on a quarterly basis, if you look at their quarterly and annual reports over the last two years. They are able to say, "It's because we're running out of oil."

So the Peak Oil question is a complex one. I do think these fields are depleting and there are technologies that have been developed to ream these wells out or to do off-set wells. That's been done in many cases, but the Russians are kind

of the world experts on this, and the U.S. geologists don't have the slightest idea on how to think in those terms. In that sense, Russia has a strategic asset in terms of energy that the West lacks. We probably would be well advised to have a more cooperative policy toward learning some of these things.

ICONOCLAST: So what I gather from what you're saying is that there is some sort of natural petroleum creation pro-

cess that is in place—
ENGDAHL: Yeah, and the
Russians found again and
again — they thought it had
peaked out, that when they
reduced the production rate,
suddenly the well was topped
up again from deep, deep underground.

IČONOCLAST: Can they account for how much is down there?

ENGDAHL: It seems to be quite a lot. The Russians even found places like Vietnam which were deemed barren by western geologists, so the Vietnamese are very

thankful to the Russians helping them get some energy independence. Of course, they tried to do this in India in the 1980s and the U.S. State Department and intelligence agencies sabotaged and bribed various Indian officials to shut the program down because that would have made India far too independent.

ICONOCLAST: So we're not into any end of the world scenario because of Peak Oil?

ENGDAHL: No, I don't think so. It's a question of the right technology and the right investment in future technology as well as we can do a lot to use far less oil in automobile engines and so forth. In Europe, diesel engine cars are the most commonly bought car because they can get 50-60 miles to the gallon, and there's no reason why we can't do that in the U.S. It's just politics. Oil companies just love to sell all of that, and the refining companies — that's a whole other scandal. They've shut down perfectly good, brand new refineries in order to jack the price of gasoline and refined products as high as they've had.

ICONOCLAST: Where's that going on? ENGDAHL: In the U.S. and in Europe. Also there have been documented cases of Shell oil Company doing that and several of the other refiners. In California, Shell did that also with a new refinery that was very state of the art, modern refinery, and they shut it down and refused to sell it. People wanted to buy it, so that's kind of suspicious. The journalists who got some internal documents of these companies about a year or so ago put them on the Internet. They're out there for people to read.

ICONOCLAST: So how do you think this Iran thing is going to play out?

ENGDAHL: Oh, if I had the answer to that, I'd be a rich man.

ICONOCLAST: (laughs)

ENGDAHL: Frankly, this is just a gut feeling. The Bush administration has got-

ten into a very, very nasty pickle with their bravado against Iran, going back to the Axis of Evil 2002 State of the Union address, and once you start making those kinds of threats, if you don't deliver on them, you are perceived as being a paper tiger as the Chinese said years ago. Well, at this point, were the United States

to bomb Iran — I mean, it's unquestionable that they could wield enormous physical damage with the arsenal of air power the U.S. has and even with mininukes which Rumsfeld and others have

hinted at, but what would that bring?

As Iran has said, and I'm sure that they are not just making bravado, they would unleash a holy war the likes of which the world has never seen. I mean, this character Osama bin Ladin hiding in the caves of Tora Bora. I think he's chump change compared to what could be done against oil installations that are the lifeblood of the U.S. economy and the world economy. So keep in mind, the Iranian government is a Shia brand of Islam. The Saudis are Sunni, Wahabbi Sunnis. The Iranians have very close ties to the Shias who are now the dominant political faction in the Iraqi parliament, but also to the fact that the largest oil installation in Saudi Arabia in the area of Ras Tanura, where all the oil is loaded up on super tankers and heads out to Japan, to China, to the U.S. and elsewhere, the work is done by Shia Islam workers in Saudi Arabia, and were they to be activated by Tehran as a retaliation for the nuclear bombing of Iran, that could simply shut down the world's oil flows then big time.


Iran has strategic military ties with Russia. Russians are building the nuclear reactor in Bushehr, Iran. They see it as a commercial reactor and some thing that is bringing a lot of good hard currency dollars to the Russian economy, and also Russia is delivering missiles and other technologies so that Iran can defend itself. So Saddam Hussein was a pushover compared with Iran. Iran is impenetrable by ground forces. It's very mountainous. The Iranians have prepared themselves very well for this situation, and I think it would be the beginning of the end of the United States as a nation if they were insane enough to do this.

ICONOCLAST: (laughs)

ENGDAHL: No, really. I'm quite serious. So for that reason, I mean, there are some what I consider insane things going in government in recent years, but I somehow think they have to pull short of launching a full scale nuclear war and I don't think they can have Israel as a proxy to it because as a Russian general said a few days ago in Moscow, "Well, if the U.S. launched a bomb strike against Iran, that would immediately solve the Palestinian problem, the Iraqi problem, the Iranian problem, and the Israeli problem because they would no longer exist."

ICONOCLAST: Wow!

ENGDAHL: That was the Russian view of it. I think it is an immensely dangerous thing. The leveler-heads in Washington know that, so maybe there will be some scandals against the Cheney/Bush administration that will stop short of them going to war. I just don't know. It's going to be a fascinating and a very dangerous six or nine months before the November U.S. mid-term elections.



PAMPA — In the wake of a devastating fires that are sweeping the Texas Panhandle, Texas Farm Bureau is asking members in other parts of the state to step forward to help fellow farmers and ranchers in need.

As of Monday morning, seven people had died and more than 700,000 acres were consumed, according to reports from the Texas Forest Service.

"We know for sure that at least 25 structures that were insured through Farm Bureau have been lost," said farmer Billy Bob Brown, Farm Bureau's state district director for the area.

News reports said the wall of flames — fueled at times by as much as 55-mile-an-hour winds — literally burned livestock where they stood in some places. The flames came so quickly they simply weren't able to make a run for it. Firemen continue to battle the blaze as north

winds feed the flames.

"There's just incredible devastation everywhere for the people living up here," said Brandon Wheeler, agency manager in the Gray-Roberts County Farm Bureau office

Much of current ranch grazing is lost, Wheeler said, and so are many of the cattle. For those that remain, hay supplies are nonexistent. In an effort to help the many farmers and ranchers living in the Northern Panhandle, Wheeler has opened his office doors to accept donations of all sorts, including hay, fence posts and wire, not to mention personal items and monetary contributions for families, as many lost homes and barns in the wildfires as well.

# **Brazos River Authority, TCEQ Fly The Rivers**

AUSTIN — A project documenting the status of two major rivers in the state will kickoff next week with the first run of aerial videography through the Brazos River watershed.

A jointly funded effort by the Texas Commission on Environmental Quality (TCEQ), the Brazos River Authority (BRA) and the Environmental Protection Agency (EPA), the project will entail a helicopter fly-over of the lower two-thirds of the Brazos as well as all of the North Bosque River. The Brazos River portion will originate at the confluence of the Salt and Double Mountain Forks (located in eastern Stonewall County near Aspermont) and proceed southward to the Gulf Coast.

"The purpose of the documented flights is to obtain a photographic record of the riparian habitat zones along the rivers and lakes," said John Ellis, PhD. Strategic Planning Manager for the BRA and project manager for the program

"The resulting record will aid both the BRA and TCEQ in their oversight and protection of the water resources of the state." Brazos Helicopters of Bruceville, Texas will perform the aerial videography.

The initial phase of the project is expected to cost \$220,000, with the final products available in the fall of 2006. Additional flights will take place in the future, covering the John Graves Scenic River portion of the Brazos (located in Palo Pinto and Parker counties). Texas State Senate Bill 1354, authored by State Senator Craig Estes of Wichita Falls and Representative Jim Keffer of Eastland, authorizes biannual documentation of the status of the John Graves Scenic River portion of the Brazos River.

## **Edwards Introduces H.R. 4949 To Block Tricare Fee Increases**

WASHINGTON, DC — U.S. Representative Chet Edwards (TX17) today introduced HR 4949, the *Military Retirees' Healthcare Protection Act*. Edwards' bill would block the Administration's proposal to double and triple health care premiums for about three million enlisted and officer retirees under Tricare, the military's health insurance system, and require the Administration to request future increases through Congress. For the first time, the provision was included in the Administration's annual budget proposal, which immediately caused serious concern among military retirees across the country.

"I believe that keeping our promise of quality, affordable health care for military retirees is the right thing to do and the smart thing to do. It is right because our nation has a moral obligation to keep our promises to those who have kept their promise to defend our nation. It is the smart thing to do because we cannot attract the best and brightest to fight our war on terrorism in the years ahead if they see us breaking faith with those who served in years past. To win the war on

terrorism, we must keep faith with our warriors and stop this military retiree tax," said Edwards, ranking member of the Appropriations Subcommittee on Military Quality of Life and Veterans Affairs.

Thirteen associations representing military retirees support H.R. 4949, authored by Edwards and Representative Walter Jones (NC03), the lead cosponsor of the *Military Retirees' Healthcare Protection Act*.

"I would like to thank Congressman Walter Jones for his leadership on this important issue," said Edwards. "We believe the Constitution purposely gave the Congress the power to declare war and to pass appropriations bills, so we think it is reasonable that Congress has a say in approving appropriations for health care programs for those who fight our wars."

Vice Admiral Norb Ryan, Jr., USN-Ret, President of the Military Officers Association of America, said, "We appreciate the strong stand that Rep. Chet Edwards is taking to make the point that the richest country on earth can afford both military weapons and health care, and doesn't have to stick the troops with that bill. Defense leaders pushing to triple or quadruple health fees for military retirees seem to forget that career servicemembers already paid their premiums — and paid them up-front, through two or three decades of service and sacrifice. Those who think military people have some great health care deal need to ask themselves why people aren't lined up around the block to join. It's because they don't want to pay that heavy premium.

Edwards' legislation will do two main things. First, it will stop the Administration's proposed tax on military retirees by requiring congressional action in four areas: enrollment fees for retired members and survivors in TRICARE Prime; pharmacy co-payments; enrollment fees for the new TRICARE Reserve Select program for our Guard and Reserve families; and co-payments for inpatient care. Second, it will require congressional approval for any future increases in military retiree health care costs.

Specifics of the Administration's Tricare budget proposal:

• Enrollment fees (now \$230 for individuals/\$460 for families) would be tripled for retired officers to \$750/\$1500 (individual/family) by Oct. 2008. Enlisted retirees under 65 would see enrollment fees nearly double by October 2008 to \$450/\$900 (individual/family).

• First-ever enrollment fees for Tricare would start for officers at \$150/\$300(individual/family) and rise to \$300/\$600(individual/family) in 2008. Enlisted retirees would pay \$100/\$200(individual/family) next October, rising to \$200/\$400(individual/family) in 2008.

• Annual deductibles under Tricare for retired officers, now \$150/\$300 (individual/family), would double to \$300/\$600(individual/family) in 2008. Enlisted retirees would see their Standard deductible rise to \$200/400(individual/family) in Oct. 2008.

"U.S. claims to institute democracy in Iraq and liberate Iraqis is being held up for ridicule around the world as Iraq teeters at the edge of a civil war," said Dallas Peace Center member Hadi Jawad.

"This pursuit of a military solution in Iraq indicates an unwillingness to seek negotiated political answers to a crisis that can easily spill across Iraq's borders and engulf the entire region in flames. The U.S. military planners in Iraq must forego their penchant for violence and stop immediately all actions that imperil the civilian population of Iraq," Jawad added



doubtedly maimed for life. It took Karl Rove, Dick Cheney, Donald Rumsfeld, Condoleezza Rice, Paul Wolfowitz, and King George XLIII a mere three years to accomplish these massive slaughterhouse totals.

## Christmas Day Shootout In A Small Texas Town

Two enterprising thieves returned to the scene of their crime on March 14, 1876, but a Winchester volley put them permanently out of business before they could load a couple of butchered beeves.

Like most Texas counties after the Civil War, Bastrop was crawling with desperadoes of every description. The rolling prairie around McDade due east of Austin was especially thick with thieves, who pillaged the countryside with impunity

Since there was not enough law to take into their own hands, the upright element became a law unto themselves. The vigilantes served notice on the criminal class in January 1875 by decorating a tree with a pair of their cohorts.

The rustlers retaliated by bushwhacking an old man that had dared to testify against them in court. For the rest of the year, war raged on the range as both sides periodically picked off members of the opposition.

The four Olive brothers swore to shoot on sight any stranger caught coveting their cattle. Finding two freshly skinned carcasses, they patiently waited for the culprits to come back for their prizes. After gunning down Turk Turner and James Crow, the Olives wrapped the dead rustlers in the hides and left them on the prairie as a grisly warning.

Led by Crow's son, a frequent visitor to the state penitentiary, a band of bad men swooped down on the Olive ranch on the night of Aug. 1, 1876. Wounding two of the brothers and several hired hands, they looted the place before burning it to

"Crime is holding high carnival in this state," a law-abiding resident complained to The Galveston News in early 1877. "Here in Bastrop County, under the very shadow of the capitol, there have been ten persons killed in the last few months. There have been more men killed in Texas in the last year than she lost during the late war."

To save themselves a long ride in the sweltering summer heat, the vigilantes came up with an ingenious plan to reduce their most-wanted list by four. Betting their prey could not pass up a party, they persuaded a popular fiddler to hold a dance.

The shindig was in full swing, when the host suddenly stopped the music. As he read off the names of the partygoers whose presence was requested outside, hooded figures blocked the exits.

Borrowing a fan from his partner, one of the doomed men joked about spending a hot night in jail. But a buddy, who failed to see the humor of their predicament, brooded, "You won't need no fan where we're going."

Resigned to their fate, the quartet offered no resistance. The masked mob marched them at gunpoint to a giant oak and hanged all four from a single sturdy branch

The mass lynching convinced most bandits to move on, and Bastrop County basked in the glow of the first peace in a generation. Although their ropes and revolvers gathered dust, the nightriders stood ready at a moment's notice to dispense their rough brand of justice.

The shocking slaying of a deputy sheriff brought the plainclothes posse out of retirement in December 1883. Two hundred angry citizens assembled at McDade's one and only church and drew up a new hit list.

The revived vigilantes struck on Christmas Eve. Eighty stormed the local saloon to seize Thad and Wright McLemore and also took along an innoThis Week In Texas History

cent bystander, who recognized a familiar face behind one of the masks. Moments later the trio was hanged without

benefit of mistletoe.

A youth assigned the chore of cutting down the bodies vividly remembered the ghastly spectacle 60 years later. "The sight of them with their twisted faces and the nooses hanging at different angles about the victims' necks was about the most gruesome thing I have ever witnessed."

The next day, friends and foes of the dead McLemores celebrated Christmas with a blazing gun-battle on the dirt streets of McDade. The three Beatty boys supported by numerous kinsmen shot it out with half of the town.

Realizing his brothers were done for, Heywood Beatty turned and walked away. Spun around by a shotgun blast, he fire a few more rounds before resuming his agonizing journey.

Bullet after bullet slammed into Beatty knocking him to his knees or flat on his face. The shooting stopped each time he went down only to started up again, when he staggered to his feet.

No one gave the order to cease firing. Partly out of respect for a man who refused to die and partly from stunned disbelief, the marksmen lowered their weapons.

Bleeding from 17 separate wounds, Heywood Beatty walked the five miles to the family farm and collapsed in his mother's arms. He eventually recovered and lived to see the Second World War, which must have seemed relatively tame compared to his Christmas Day ordeal.

## Intelligent Design No Excuse for Faulty Product

Unable to shore up the absurd claims of creation "science" with empirical evidence, anti-Darwinists raring to inject creationism into America's science curriculum have devised a new slogan: Intelligent Design."

Intelligent Design (ID) is the untested assertion that the universe, the living things that populate it and the ceaseless upheavals they endure are the result of an all-knowing, albeit paranormal, cause or agent, not a freehand process such as natural selection (evolution).

Most ID advocates publicly state that they are searching for evidence of sentient intent in nature, without regard to who or what the designer might be. Taken to its incongruous extreme, ID could one day be called on to explain that things fall not because gravity acts upon them, but because a higher intelligence consciously and deliberately pushes them down. Planes crash, they will argue, and buildings collapse and empires rise and topple because these events are preordained by some inscrutable force. The more vicious among them will insist that these misfortunes are in fact the result of wrathful retribution. A large array of phenomena are already similarly blamed – from war and hunger and disease to earthquakes, cyclones and tsu-- damned be the laws of science

or mankind's unholy predilections.

Intelligence is defined as "mental acuteness," "the skilled use of reason and application of knowledge" and "the ability to think abstractly" (including the capacity to envision the consequences of

Thus, ID presupposes two reciprocal attributes: The existence of a gifted (if unknowable) draftsman and an exceptional blueprint from which a useful and efficient prototype can be rendered. Such inquiry-stifling premise unavoidably raises questions that, so far, ID has been unable to answer:

What is smart about a creature that kills for pleasure and insists on procreating itself into extinction? What mental acuteness is displayed by corruptible beings who cling to rival and inflexible doctrines? What common sense is at play among mortals addicted to greed and violence? Why are we susceptible to pain and defenseless against the fury of disasters that ID insists are wrought against us "for mysterious reasons" by some capricious supernatural force? What knowledge is skillfully harnessed by entities powerless or brutishly unwilling to learn from their mistakes?

\* Conversely, what measure of intelligence can be ascribed to a "maker" who inflicts or tolerates atrocities for "the good that comes from them"? What cunning and irreducible absolute orchestrates without apparent aim — or turns a blind eye to — the paroxysms that convulse his realm?

What abstract reasoning inspires a creator to remain unmoved by sorrow and calamity and the ceaseless suffering of his own progeny? What justifies such dispassion? What superior wisdom endows itself with ostensible kindness and unkindness and allows itself to be per-



ceived as possessing equal amounts of benevolence and evil, munificence and heartlessness, genius and folly, as circumstances dictate?

What intelligent designer arms himself with an ego, gives himself a name by which others will know him in silent awe while their sobs are never heard as they weep and suffer and die forgotten because pain, by some outlandish verdict, is the pathway to salvation? What supreme entity is this, whose ear is inattentive and whose breast is unfaithful to the throngs who call on him and seek his succor?

What Alpha and Omega unleashes scourges that enfeeble, jeopardize and often destroy the masterwork?

What cruel despot decrees that his subjects will speak words not their own, that they will blindly obey the injunctions of his self-anointed envoys, tremble at

their admonitions, mouth off supplications and jeremiads and recite words of indebtedness and veneration, all repeated ad nauseam, day after day, to a God who never shows his face, never bares his heart, never sheds a tear, never says he's sorry, a God who grants life and, with it, the fear of death?

But God upon whom we turn for comfort, whose indulgence we seek for our offenses and whose wrath we invoke against our enemies, turns a stone visage to human misery and a deaf ear to our most heart-rending cries.

Until irrevocable proof of "Intelligent Design" is put forth, the concept will more likely be viewed as a clever stratagem cooked up by a new generation of Elmer Gantrys who hijack and exploit hopelessly bewildered spirits and subvert them with falsehoods that only blind belief can ever legitimize. ID is not just an alternate theory explaining the advent of God's most defective creation. It is a dangerous eccentricity concocted to exact faith by psychological extortion.

As for me, I am never more certain of my origins than when I look into the soulful eyes of a great ape. I find comfort and a sense of innocence — long since lost in this genesis. It is when I look at myself and examine my fellow Homo sapiens that I worry about the future of the human race. This is one faulty product that can never be recalled.

I live just east of Cranfills Gap in Texas. I am writing to voice my opposition to the National Animal Identification System and Texas HB1361. I just learned of this a few days ago. I waited a few days to write to you because I was so enraged it would have been impossible for me to keep a civil tone. I believe that if this passes, in any form, it would be one of the greatest violations of our freedom in recent memory. Forgive me if I ramble, but this is wrong in so many ways that it is difficult to focus.

First, the most obvious abridgement is our right to privacy. I do not think it is any of the government's business that I raise livestock. The thought of premise registrations smacks of something that happened behind the Iron Curtain. Worse than that thought is the proposed R.F. Identification tags that are the ultimate goal of the NAIS. What is next? Placing R.F. Identification tags in every citizen so their actions can be tracked to reduce

Secondly, I believe that this proposal is yet another mechanism by which big business can squeeze out small business. My wife and I have worked hard and sacrificed a lot to get our piece of the "American Dream." For us that dream is 45 acres of rocky, rugged land that is not good for anything but raising livestock. We try to raise enough meat for our family's needs and sometimes we sell a few head of livestock. We are not interested in securing overseas export business. I cannot help but notice that the "big boys" will be able to register groups of livestock while small farmers like myself will be expected to register every individual animal. If this is not another example of big business writing law, then I do not know what is!

Finally, this proposal ignores the fact that while Mad Cow disease is a relatively small problem, that small problem is almost solely caused by big producers. Big producers that feed cows-cow in feed lots. Why not introduce legislation to ban some of the abhorrent feeding practices of the big producers. Such as Bone Meal!?!! Our animals are grass fed with very little grain. No, I am not some green freak. My wife and I both grew up in Central Texas. We have been around agriculture and the small farmer our whole lives. This legislation threatens not only our way of life but countless others also.

In summary, this legislation is yet another attempt at eroding the freedom that made the U.S.A. and Texas what they are today. Ignoring the financial conse quences, which the proponents of this bill will say are small — citing the low registration fees (which will most certainly increase); this legislation is wrong in principle. Just because technology makes something possible does not make it right. I wish that you could see what is in my heart. Words are poor conveyors of my emotions when I feel that my liberty is being taken away from me. For the first time. I know what our forefathers must have felt during the Boston Tea Party and the fight for the Alamo. I have never felt my right to self determination so threatened. I believe so strongly in this that I will exercise my right under the Second Amendment. I beg you to stand and fight with the courage of our forefathers, and defeat this bill.

All Texans should hold their freedoms more dear, after all two wars of independence were fought for them.

Thank you for your consideration, John Hamby, Cranfills Gap, Texas Dear Editor:

At the direction of the Texas Legislature, the Texas Animal Health Commission is trying to implement a Texas Animal Identification System, the first step of which is mandating premises registration with global positioning satellite (GPS) identification of all farms and ranches and requiring bi-annual fees.

This is only the first step. The next step is individual animal identification via radio-frequency identification chips and required reporting within 24 hours of every animal's movement off the farm for any reason (a trip to the vet, to a show, to auction, or to private sale) to a central recording database. The current position is that such central recording organization be privatized, ostensibly to avoid loopholes in Freedom of Information Act requirements. However, a private database will also permit bureaucrats and elected officials to deny responsibility when producers' private data is leaked, hacked, or otherwise compromised.

This program is NOT about animal health or food safety. It is CORPORATE WELFARE for big producers who wish to export to Japan, the European Union, and other countries by assuring them that the USA has "disease-free" livestock, poultry, and fish. By requiring all producers to participate in this sham program, big exporters will be able to shift the cost of "proving" their animals' good health onto small producers and the American taxpayer, the latter through the creation of new bureaucracies at state and federal levels. Producers wishing to export should be allowed to set up their own testing facilities at their own expense and prove to their buyers that their products are safe.

Organic growers will be especially negatively impacted through increased costs. Amish and other religious groups will be unable to comply, since using modern electronic tools are not permitted by their religions. For goat producers, specific markets will be lost; some ethnic group buyers require goats that are "unblemished" by even so much as an eartag. The use of electronic implants will effectively kill off that market.

The USA has the safest, most abundant, and cheapest supply of food in the world. We do not have serious or imminently-serious animal health or food safety problems. Policies currently in place catch the occasional problem Newcastle's Disease in chickens, BSE in and take the affected animals out of the food supply. Further, the diseases being focused upon are not zoonotic — they are not transmissable to humans but they DO have economic impacts upon producers. Illnesses like Avian Flu are carried by wild birds which are impossible to control and are not addressed by TAIS/NAIS.

Animal health issues are more likely to appear in crowded and dirty conditions that are more likely to be found in feedlots, slaughterhouses, and restaurants than on farms and ranches of individual livestock producers. The usage of animal by-products in animal feed has been banned in the USA, making the likelihood of BSE-like diseases even more less likely to appear. Taxpayer funds would be better spent instituting improved inspections procedures at slaughter houses, restaurants, and especially at points of entry where livestock enter the USA from other countries.

The current TAIS is a one-size-fits-all program. The same RFID chips would be used in all animals, whether they are cattle, horses, goats, or smaller animals, making the costs proportionately higher for producers of smaller species. Flocks (turkeys, chickens) would be permitted to use flock numbers. In a flock of 100 or 1000 chickens, who could possibly identify individual birds if they were replaced? The distinct likelihood that wild animals and birds will carry disease isn't even addressed. NAIS is not well thought out and has loopholes that are rife for

TAIS is an invasion of privacy and violation of private property rights. As a goat producer, I will be told at every step what I must do with my animals in order to sell them. TAIS is the agricultural equivalent of the US Supreme Court's Kelo decision that virtually abolished private property

TAIS does nothing to address the

safety of imported food that Texans eat. The real threat to food safety is imported meat, fruits, and vegetables grown in foreign countries under conditions unknown to and uninspected by American officials. These products are allowed into the USA without a blink of the regulatory eye.

TAIS will unnecessarily increase the cost of food to consumers because producers cannot absorb \$15.00 (materials and labor) or more per animal without increasing prices for their products.

The proposed system simply will not work. It assumes that any health problem occurs at the animal's original point of origin. What about contamination and sickness that may well have occurred somewhere along the animal's route to eventual consumption? There will be no way to accurately determine origination of illness or contamination.

The people pushing this program are the large livestock and poultry producers and the companies that make the RFID

chips.

The Texas Animal Health Commission has had its budget cut by the Texas Legislature and has been told that it can make up lost funds by charging premises identification fees.

The current voluntary programs in place for identifying health issues in cattle, goats, and other livestock are working. Recent identification of

## **National Animal ID System Continues To Ignite Controversy**

CLIFTON — Claiming the need to safegard animal health, the United States Department of Agriculture (USDA) continues to push toward the implementation of the National Animal Identification System (NAIS) despite significant opposition to the use of electronic animal identification. The excessive regulations being examined threaten privacy and the overall existence of the

American small farm.

In April 2004, the USDA announced the framework for implementing the NAIS as a tracking system that will be used in all states and that will operate under national standards. When fully operational, the system will be capable of tracing a sick animal or group of animals back to the herd or premises that is the most likely source of infection. It will also be able to trace potentially exposed animals that were moved out from that herd or premises

Three main components are involved in the NAIS system, one of which is the premises ID program. Those owning livestock of any sort — cattle, sheep, swine, poultry, deer, elk, horses, mules, asses, goats, exotic livestock, llamas, alpacas, domestic fowl, poultry, exotic fowl — are currently encouraged to register for their 'unique" Premises Identification Num-

The Premise Identification defines a geographic site, such as ranches, farms, feedlots, livestock markets, slaughter establishments, rendering or carcass collection points, veterinary clinics, livestock show, fair or exhibition sites, quarantine facilities, laboratories, ports of entry, or any other facilities where animals are handled. The premises number is a unique 7-character code, issued by the TAHC or USDA.

The proposed plan does not distinguish between large corporate factory farms and the smallest family producer, hobby farmer, or the "grandmother with a few

backyard laying hens."

The second component is the animal identification device, a tag of sorts with a unique 15-digit electronic number. This device is intended to remain with the animal for its life, and if lost can be replaced. The seven-character premises identification and the 15-digit animal identification device number will correlate only in records.

In the NAIS, some species, such as commercially produced swine or poultry, may be identified by group/lot numbers, provided the animals are held and managed as a group throughout the pre-har-

vest production process.

The final component of the national plan is the recording and reporting of animal movement, sales, comingling, or slaughters. According to information provided by the TAHC, "when implemented, the system will enable efficient tracing of animals for the disease eradi-

Following the adoption of House Bill 1361, the Texas Animal Health Commission is authorized to determine when premises identification will be required and to assess and collect fees for premises registration. The proposal now is the required premise registration by July 1, 2006, with the submission of the \$20

two-year registration fee, payable every

24 months thereafter.
"Although the TAHC commissioners always urge voluntary compliance with agency regulations, the proposals include penalties for noncompliance," as stated in the "Premises Identification Proposed Regulations of the TAHC.

In response to the "infringement of the fifth amendment rights," organizations and websites have been established with the sole purpose of preventing the "three Ts

tagging, tracking, and taxing."
One such group, Stop Animal ID indicates — "StopAnimalID.org is the online manifestation of a grass roots refusal to submit to the latest grasping for control of what was once a government of We The People, but has now become a government of Them, The Agri-Conglomerates. This website is a means for like-minded individuals to band together and discover they are not alone in opposing this abuse of privacy and property rights

According to informaton provided by the National Center for Animal Health Programs (NCAHP), "livestock identification in the United States has been documented in large animal production industries dating back to the late 1800s and early 1900s. Cattle ranchers, to indicate ownership and deter theft, first used hot iron branding. Swine producers for registration and record keeping purposes used ear notches

for individual animal identification. These two methods are rapidly losing popularity due to concerns about humane treatment of animals and a decrease in product

"APHIS and its predecessor agencies began using ear tags, back tags, tattoos and face brands in the early 1960s. These identification methods were required by statutory regulations and successfully used to trace the movements of diseased animals during disease outbreaks and eradication programs. With this long history of contact with the field, APHIS has led the way in the development of national identification systems. The agency continues to place a high priority on livestock identification and database development.'

"Current methods of livestock identification include but are not limited to ear

tags, back tags, neck chains, tail tags, freeze brands, tattoos, paint marks, and leg bands. Electronic identification methods including bar codes and/or radio frequency identification (RFID) transponders are becoming increasingly useful tools in herd management programs. As these new technologies develop and become compatible with one another, they may prove to be cost-effective tools to increase the efficiency of production. Similarly, regulatory agencies may benefit from these systems through increased accuracy and efficiency of tracing the movement of livestock.'

"The current primary driving forces behind the development of livestock identification systems are based on recognized industry needs. They include disease control and eradication, disease surveillance and monitoring, emergency response to foreign animal diseases, regionalization, global trade, livestock production efficiency, consumer concerns over food safety, and emergency management programs.

"The Secretary of Agriculture has the statutory authority and responsibility to determine that when "any State, Territory, or the District of Columbia are affected with any contagious, infectious, or communicable disease of livestock or poultry for which, in his opinion, a quarantine should be established" notice will be given and a rule will be issued and included in the Code of Federal Regulations (CFR). Thus, the CFR contains all the rules governing the movement and handling of animals in interstate commerce for the purposes of controlling or eliminating disease in livestock."

Whether viewed as an unconstitutional infringement of rights, the necessary protection of the national "herd," the inducement of adherance to existing regulations, a moneymaker, or the detriment of the small family farm, the NAIS system is on track to becoming compulsory. Should the USDA find a way to tax evenly, eliminate human error, and maintain strict information protection, the program could be as effective as the eartag and other popular

Without adequate solutions to those major difficulties, the smaller producers are sure to feel the strain first.

In information provided on the American Heartland website, Kevin Starr comments, 'Part of what it is to be an American can be defined by the virtues and successes of the small farmer.'
