

# **Justices Overturn Bush's Military Tribunals**

WASHINGTON — In the biggest tests to the powers of a U.S. president since World War II, the Supreme Court ruled by a 5-3 vote last Thursday that President George W. Bush's military war crimes trials for Guantanamo Bay detainees were unconstitutional and illegal under the Geneva Convention. Guantanamo prisoner Salim

Ahmed Hamdan, a former driver for Osama bin Laden, brought the case before the court. Hamdan was one of 10 detainees facing charges under the president's tribunal created after the attacks on Sept. 11, 2001.

Justice Anthony M. Kennedy aligned himself with the court's liberal members against the White House. Chief Justice John Roberts recused himself after having backed the U.S. government as an appeals court judge in a case against Hamdan.

Thursday's ruling covered only the military tribunals, not

the operational existence of the military prison at Guantanamo Bay, Cuba itself. It also failed to call for the release of the prisoners there.

"Nobody gets a 'get out of jail free' card," said White House spokesman Tony Snow.

**Dan Rather Leaves CBS News** 

President Bush, while promising to take the ruling "very seriously," he alluded to seeking approval from Congress to okay the tribunals. Sen. Lindsey Graham said that the Senate is working to bring a vote on new tribunal plans by September.

Rather, 74, is said to be considering to do a weekly show at HDNet. Katie Couric will sit in the anchor's seat the "CBS Evening News" in September. Rather replaced Walter Cronkite in 1981.

The graduate of Sam Houston State University exited as CBS anchor after his story on President George W. Bush's military service aired during the run-up to the 2004 presidential election. The documents Rather used as sources for the story were later found to be inauthentic.

**Deeper Story** 

Investigative reporter Greg Palast has repeatedly rallied to Rather's side, saying most recently last week that "all the poor man did was repeat a story we put on BBC Television a year earlier."

Both stories reported that Bush's father, George H.W. Bush, used his influence to get him in the Texas Air National Guard away from the Vietnam War. However, Palast noted that Rather's "60 Minutes" piece

never mentioned that the Bush clan rewarded Texas Lt. Governor Ben Barnes and others for their services.

"We ran that full story — from the evidence of the fix to the evidence of the lucrative pay-backs — on the world's biggest network, BBC, and we've never retracted a comma of it. Nor, by the way, has the White House denied our accusations despite our repeated offers to respond," Palast wrote in his new book *Armed Madhouse*.

After serving in public office, Barnes helped a company he lobbied for called GTech receive a contract to operate the Texas lottery, according to Palast. When the contract fell through in a scandal, it was soon revived with no other bids to stop it during George W. Bush's term at

Texas governor. The chairwoman of the lottery board then was Harriet Miers, the same woman now-President George W. Bush nominated for U.S. Supreme Court in 2005.

"We don't know if Miers gave the overpriced GTech its contract back to help the governor keep his Air Guard secret a secret or simply because she liked GTech's record of high costs and corruption," wrote Palast.

**Special Privilege** 

To Palast, Rather's demise at CBS is "a cautionary tale of how news is made in the USA—and unmade—and topics permissible during an election."

Still, Palast added, "The story that cannot be reported is not about George Bush's special treatment but about the special treatment of the specially privileged."

## 'Corrie' To Play In New York In October

NEW YORK CITY — After months of controversy surrounding its content, the one-woman play "My Name Is Rachel Corrie" will premiere on a New York City stage this October.

The London Royal Court Theatre production was pulled from a New York theatre's schedule last March, though during its 2005 run in London, it was nominated for an Olivier Award.

The play was constructed from the written works of a 23-year-old human rights activist who died as a result of trying to prevent an Israeli bulldozer from leveling a

Palestinian home in the Gaza Strip in March 2003.

An Israel investigation found Rachel Corrie's death accidental, but her motivations are still a point for debate.

In a statement released last week, Director Alan Rickman said that he and his production team wanted to to present "a balanced portrait" of the late activist.

"The activist part of her life is absolutely matched by the imaginative part of her life. I've no doubt at all that had she lived, there would have been novels and plays pouring out of her," he said.

"My dad," voiced Roger, another film student, "says democracy is dead, and our civil justice system and lawyers are being neutered by corporations that want to get away with mur-der without having to pay damages. My dad's an attorney he knows."

"That's right," said Lorenzo.
"My father is making a movie about corporations stealing the planet from under our feet by using frames. It'll blow people's minds. My dad worked with Fellini. He saw people in Italy change after City Of Women came out."

"That's the craziest thing I ever heard!" jumped in Ms. Barb, participating in the discussion while pouring tea.

## **Bio: Aldo Vidali**

Production is under way on Deflating the Elephant, a film based on George Lakoff's bestseller "Don't

Think Of An Elephant."
Producing the film is Aldo Vidali, and Italian documentary film director who lives in Northern California and teaches at the Fellini-Antonioni Acting Studio.

Vidali, an outspoken champion of individual rights, embarked on the film to illustrate how conservatives are using frames to negatively sway public opinion and to encourage the public to make a stand against tyranny while the opportunity re-

The film is styled in the tradition of famed Italian director, the late Federico Fellini, with whom Vidali collaborated on films years

Born in Ixelles, Belgium, Vidali was educated in Rome, Italy.

He and his family joined the Resistance Movement against fascist and Nazi forces during World War II. When he was only 13 years old, he was captured by the Nazis during the Fosse Ardeatine Nazi dragnet in Rome, but was released shortly thereafter because of his age. At the time, his family members were sheltering several Jewish refugees in their apartment to prevent their deportation to death camps in Ger-

At age 18, Vidali explored the tropical wilderness of

#### Universal Declaration of Human Rights

Preamble

Whereas recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world.

Whereas disregard and contempt for human rights have resulted in barbarous acts which have outraged the conscience of mankind, and the advent of a world in which human beings shall enjoy freedom of speech and belief and freedom from fear and want has been proclaimed as the highest aspiration of the common people,

Whereas it is essential, if man is not to be compelled to have recourse, as a last resort, to rebellion against tyranny and oppression, that human rights should be protected by the rule of law,

Whereas it is essential to promote the development of friendly relations between nations,

Whereas the peoples of the United Nations have in the Charter reaffirmed their faith in fundamental human rights, in the dignity and worth of the human person and in the equal rights of men and women and have determined to promote social progress and better standards of life in larger freedom,

Whereas Member States have pledged themselves to achieve, in cooperation with the United Nations, the promotion of universal respect for and observance of human rights and fundamental freedoms.

Whereas a common understanding of these rights and freedoms is of the greatest importance for the full realization of this pledge,

Now, therefore,

The General Assembly,

Proclaims this Universal Declaration of Human Rights as a common standard of achievement for all peoples and all nations, to the end that every individual and every organ of society,

keeping this Declaration constantly in mind, shall strive by teaching and education to promote respect for these rights and freedoms and by progressive measures, national and international, to secure their universal and effective recognition and observance, both among the peoples of Member States themselves and among the peoples of territories under their jurisdiction.

#### Article 1

All human beings are born free and equal in dignity and rights. They are endowed with reason and conscience and should act towards one another in a spirit of brotherhood.

#### **Article 2**

Everyone is entitled to all the rights and freedoms set forth in this Declaration, without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status.

Furthermore, no distinction shall be made on the basis of the political, jurisdictional or international status of the country or territory to which a person belongs, whether it be independent, trust, non-self-governing or under any other limitation of sovereignty.

#### Article 3

Everyone has the right to life, liberty and security of person.

#### Article 4

No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms.

## Article 5

No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment.

#### Årticle 6

Everyone has the right to recognition everywhere as a person before the law.

#### Article 7

All are equal before the law and are entitled without any discrimination to equal protection of the law. All are entitled to equal protection against any discrimination in violation of this Declaration and against any incitement to such discrimination.

#### **Article 8**

Everyone has the right to an effective remedy by the competent national tribunals for acts violating the fundamental rights granted him by the constitution or by

## **Article 9**

No one shall be subjected to arbitrary arrest, detention or exile.

#### **Article 10**

Everyone is entitled in full equality to a fair and public hearing by an independent and impartial tribunal, in the determination of his rights and obligations and of any criminal charge against him.

#### **Article 11**

1. Everyone charged with a penal offence has the right to be presumed innocent until proved guilty according to law in a public trial at which he has had all the guarantees necessary for his defence.

2. No one shall be held guilty of any penal offence on account of any act or omission which did not constitute a penal offence, under national or international law, at the time when it was committed. Nor shall a heavier penalty be imposed than the one that was applicable at the time the penal offence was committed.

#### **Article 12**

No one shall be subjected to arbitrary interference with his privacy, family, home or correspondence, nor to attacks upon his honour and reputation. Everyone has the right to the protection of the law against such interference or attacks.

#### **Article 13**

- 1. Everyone has the right to freedom of movement and residence within the borders of each State.
- 2. Everyone has the right to leave any country, including his own, and to return to his country

## **Article 14**

- 1. Everyone has the right to seek and to enjoy in other countries asylum from persecution.
- 2. This right may not be invoked in the case of prosecutions genuinely arising from non-political crimes or from acts contrary to the purposes and principles of the United Nations.

#### **Article 15**

- 1. Everyone has the right to a nationality.
- 2. No one shall be arbitrarily deprived of his nationality nor denied the right to change his nationality.

#### **Article 16**

1. Men and women of full age, without any limitation due to race, nationality or religion, have the right to marry

and to found a family. They are entitled to equal rights as to marriage, during marriage and at its dissolution.

2. Marriage shall be entered into only with the free and full consent of the intending spouses.

3. The family is the natural and fundamental group unit of society and is entitled to protection by society and the State.

#### **Article 17**

- 1. Everyone has the right to own property alone as well as in association with others.
- 2. No one shall be arbitrarily deprived of his property

#### **Årticle 18**

Everyone has the right to freedom of thought, conscience and religion; this right includes freedom to change his religion or belief, and freedom, either alone or in community with others and in public or private, to manifest his religion or belief in teaching, practice, worship and observance.

#### **Article 19**

Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers.

#### **Article 20**

1. Everyone has the right to freedom of peaceful assembly and association.

2. No one may be compelled to belong to an association.

#### **Article 21**

1. Everyone has the right to take part in the government of his country, directly or through freely chosen representatives.

2. Everyone has the right to equal access to public service in his country

vice in his country.

3. The will of the people shall be the basis of the authority of government; this will shall be expressed in periodic and genuine elections which shall be by universal and equal suffrage and shall be held by secret vote or by equivalent free voting procedures.

#### Article 22

Everyone, as a member of society, has the right to social security and is entitled to realization, through national effort and international co-operation and in accordance with the organization and resources of each

State, of the economic, social and cultural rights indispensable for his dignity and the free development of his personality.

## Article 23

1. Everyone has the right to work, to free choice of employment, to just and favourable conditions of work and to protection against unemployment.

2. Everyone, without any discrimination, has the right to equal pay for equal work.

- 3. Everyone who works has the right to just and favourable remuneration ensuring for himself and his family an existence worthy of human dignity, and supplemented, if necessary, by other means of social protection
- 4. Everyone has the right to form and to join trade unions for the protection of his interests.

#### **Article 24**

Everyone has the right to rest and leisure, including reasonable limitation of working hours and periodic holidays with pay.

## Article 25

- 1. Everyone has the right to a standard of living adequate for the health and well-being of himself and of his family, including food, clothing, housing and medical care and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond his control.
- 2. Motherhood and childhood are entitled to special care and assistance. All children, whether born in or out of wedlock, shall enjoy the same social protection.

#### Article 26

- 1. Everyone has the right to education. Education shall be free, at least in the elementary and fundamental stages. Elementary education shall be compulsory. Technical and professional education shall be made generally available and higher education shall be equally accessible to all on the basis of merit.
- 2. Education shall be directed to the full development of the human personality and to the strengthening of respect for human rights and fundamental freedoms. It shall promote understanding, tolerance and friendship

among all nations, racial or religious groups, and shall further the activities of the United Nations for the maintenance of peace.

3. Parents have a prior right to choose the kind of education that shall be given to their children.

## **Article 27**

1. Everyone has the right freely to participate in the cultural life of the community, to enjoy the arts and to share in scientific advancement and its benefits.

2. Everyone has the right to the protection of the moral and material interests resulting from any scientific, literary or artistic production of which he is the author.

#### **Article 28**

Everyone is entitled to a social and international order in which the rights and freedoms set forth in this Declaration can be fully realized.

#### **Article 29**

1. Everyone has duties to the community in which alone the free and full development of his personality is possible.

2. In the exercise of his rights and freedoms, everyone shall be subject only to such limitations as are determined by law solely for the purpose of securing due recognition and respect for the rights and freedoms of others and of meeting the just requirements of morality, public order and the general welfare in a democratic society.

3. These rights and freedoms may in no case be exercised contrary to the purposes and principles of the United Nations.

#### **Article 30**


Nothing in this Declaration may be interpreted as implying for any State, group or person any right to engage in any activity or to perform any act aimed at the destruction of any of the rights and freedoms set forth herein.

Few clearly perceive how dangerous the world situation is becoming.

Inhuman money controls mass media and deliberately broadcasts as many frivolous distractions as possible to keep people from noticing the fascist beast closing in on millions of unsuspecting victims. Current diabolical schemers make Hitler and Stalin look like dilettantes. Their skills at diverting atten-

tion by frequently sounding terror-lurking-under-every-bush alarms have been honed to perfection. A movie can expose them with scandalous evidence.

As a boy, I experienced arrogant Italian Fascism and the evil of rightwing fanatical religionism. In December 2000, when America was flagrantly betrayed by five black-robed hypocrites, shivers of horror went down my spine. Our grassroots organization immediately net-published a large front-page headline: "DAY OF INFAMY - Fascist Coup in the United States!" which was printed over a photo of marching Nazi SS troopers.



Friends objected that to use the word "fascist" was an exaggeration. Now, six year later, most are as outraged as we were then and have been ever since.

In 2004, a second national election was stolen by the same fascist cabal and American democracy *de facto* ceased to exist, except in the deluded minds of sleeping TV network audiences.

That year, University of California Berkeley Professor George Lakoff's book, Don't Think of an Elephant, appeared and was an instant bestseller. What it revealed is how linguistic frames influence social conditions.

Reading Don't Think of an Elephant was a stunning clarification for me of how evil ideas throughout history are framed to allow "the few" to control and oppress "the many." Indeed, ideas projected through invisible linguistic frames can transform the mind

form the mind.

Lakoff's scientific explanations brought back memories of working with Federico Fellini and learning from him how cinematic images change society. For example, after Fellini's Casanova and City of Women, I had watched downcast Italian males leaving theaters, stunned. Exaggerated Italian machismo was crushed by these great films and never fully recovered.

Fellini's demolition of century-old prejudices and Lakoff's linguistic art of framing suggested to me a potential cinematic cure for America.

It was my good fortune to share Federico's thoughts about dreams and metaphysical ques-





tions while he was conceiving his mysterious story, The Voyage of G. Mastorna. This work contains some of his visions and speculations about the human state in this world and after death. During that unforgettable experience, Fellini explained how cinematic images liberate, dissolve fear, and open our lives to perceiving the subtlest aspects of the world. That "sceneggiatura"— The Voyage of G. Mastorna. — is now known as the most famous neverfilmed-screenplay in the history of cinema.

Fellini's insight on the magic of light gives us a glimpse of the profundity of his art. He said: What is light? If cinema is

images, light is its evident essence. In cinema, light is idea, sentiment, color, profundity, atmosphere, style, narrative, poetic expression. Light is the magic power that adds, cancels, softens, suggests, exalts, alludes, underscores, and renders the fantastic credible and acceptable, or, on the contrary, creates transparencies through which the gray daily reality be-comes rich, fairytale like. With a single reflector and a pair of lights an opaque face, with as much expressiveness as a bare knee, appears intelligent, mysterious, fascinating; an open, benevolent, peaceful face becomes sinister, menacing, frightening.

The poorest scene — squalid, shabby — can with light reveal enchanting or ominous aspects...barely moving a 5000



Mixing Fellini's cinematic secrets with Lakoff's scientific brilliance is like mixing *nitro* and *glycerine* — which makes up dynamite. Liars and thieves are in for a big surprise.


The neo-crooks have been fanning the flames of a still unexplained 9/11 tragedy into a fabulously profitable perennial frame: "war-on-terror." What should have been an international police hunt by civilized nations has turned into a deadly, trillion-dollar con job. In reality, there is no war. The phony "war" frame provides a legalistic and pseudo-moral justification for flag waving, criminal wars of aggression, and the dismantling of our Constitution. The 9/11 Commission colluded with Bush and Cheney so that the inseparable twins were conveniently questioned together to avoid contradictions — behind closed doors, and not under oath for fear of future indictments for obstructing justice. The questioners were all tail-wagging administration's lap dogs.

Lights and cameras will capture the criminal activities of the national security organizations that colonize the world with prisons, torture chambers, and concentration camps. The horrors of so-called rendition (criminal kidnapping with torture outsourcing) and the deployment of massive domestic electronic spying networks that outrageously violate the Constitutional rights of American citizens and intrude even on their attorney-client privilege will be

What was once a country of laws is now a country run by a self-declared fundamentalist despot claiming the privilege to violate any law he chooses. In his book: Gangs of America [download a copy at http://www.gangsofamerica.com], Ted Nace reveals the impostrous way the U.S. was taken over by big business. Historically, it was the battle between democracy and corporations that started the American Revolution. The Boston Tea Party was an action to block the British East India Company, the most powerful corporation that ever existed, from monopolizing the American commodities markets, starting with tea. The American Revolution was a pragmatic economic rebellion against an overbearing corporation and an oppressive government thoroughly intertwined with it.

The East India Company had planned to replace independent local merchants with a company-owned distribution system, i.e., an early version of what we now call "vertical integration," like, for example, oil companies owning wells, refineries, and gas stations.

Boston pamphleteers — we had a free press then — laid out the scenario in detail, warning that if the British were to succeed in bringing the tea distribution system under sole control of the East India Company, they would inevitably repeat the same scheme for other imported commodities. Sound familiar? Think of the WTO.

The East India Company, if

once they get Footing in this (once) happy country, will leave no Stone unturned to become your Masters. They are an opulent Body, and Money or Credit is not wanting amongst them. They have a designing, depraved, and despotic Ministry to assist and support them. They themselves are well versed In TYRANNY, PLUNDER, OPPRESSION and BLOODSHED. Whole Provinces labouring under the Distresses of Oppression, Slavery, Famine, and the Sword, are familiar to them. Thus they have enriched themselves, cthus they are become the most powerful

Trading Company in the Universe. Excerpt from a broadside signed "A Mechanic," Philadelphia, December 4, 1773.

Imagine a private company so unaccountable that it conducts its own criminal trials and runs its own jails; so dominant it possesses a 250,000 man army, twice the size of Britain's, to fight company wars; and so predatory that for more than two centuries it squeezes the economy of the richest country in the world until observers report that some regions have been "bled white." A third of Parliament owns stock in it, and a tax on its tea constitutes 10% of the government's revenues. Even the King is dependent on periodic "loans" from the company!

When the cargo ship Dartmouth arrived in Boston Harbor on the night of December 16, 1773, approximately 150 men assembled at the home of the Boston Gazette and Country Journal's founder. They came from many backgrounds: some were apprentices, some tradesmen, some wealthy owners of businesses. By dawn, the entire shipment of tea had been destroyed. The American Revolution would soon be under way.

One glaring example in a long record of uncontrolled corporate evil was unleashed against this country in 1936:

[C]onsider this unpunished

crime, committed by the leadership of General Motors, together with Standard Oil of California, Firestone Tire and Rubber Company, B. F. Phillips Petroleum, and Mac Manufacturing.

In 1936, the five companies formed National City Lines, a holding company that proceeded to buy electric trolley lines and tear up the tracks in cities across the nation. Each time it destroyed a local trolley system, National City would license the rights to operate a new system to a local franchisee, under the stipulation that the system convert to diesel-powered General Motors buses.

By 1949, more than 100 electric transit systems in 45 systems had been torn up and converted. In April of that year, a federal jury convicted GM and the other firms of conspiracy to commit anti-trust violations. But the judge set the fine for each company at \$5,000. Seven executives were fined one dollar each. After the conviction, the companies went back to purchasing transit systems, removing electric trolley lines, and replacing them with buses. Gangs of America, Introduction p. 7.

As Atlanta mayor and former United Nations ambassador Andrew Young once observed, "Nothing is illegal if 100 businessmen decide to do it."

In 1882-83, Judge Stephen Field's Ninth Circuit Court, with twisted judicial sophistry, established the personhood of corporations in *Santa Clara County v. Southern Pacific*. This self-evident absurdity has proven to be a menace to democracy and humanity.

Judge Field's tortuous legalese behind the creation of immortal, frankensteinian corporations coincided with the view of Professor John Norton Pomeroy, namely: "The truth cannot be evaded that, for the purpose of protecting rights, the property of all business and trading corporations IS the property of the individual corporators. A state act depriving a business corporation of its property without due process of law, does in fact *deprive the in*dividual corporators of their property. In this sense, and within the scope of these grand safeguards of private rights, there is no real distinction between artificial persons or corporations, and natural persons.'

Ted Nace explains why an understanding of this is critical: As simple as this false argu-

ment sounds, it was a signifi-Continued On Next Page

cant departure from established legal doctrine, which had always made a distinction between corporate property and individual property. The most crucial distinction is that owning shares in a company allows a person to own property without being subject to the sort of accountability to the community that normally attends the ownership of property [emphasis added]. For that reason, courts had never assumed that shareholders in a corporation should expect equal rights; on the contrary, the enjoyment by corporate shareholders of privileges such as limited liability justified applying special restrictions to corporations and their owners. Gangs of

America, p. 118.

It is self-evident that giving legal personhood to a corporation, while enjoying all other rights, also creates the right to do wrong and escape responsibility. In the 2006 California primaries, the residents of Humboldt County said enough is enough and successfully challenged corporate personhood [see insert].

Citizens 1, Corporations 0
In states across the country
Tuesday, primary elections
named candidates for Congress,
governorships and other important offices. But the most interesting, and perhaps significant,
election did not involve an individual. Rather, it was about an
idea.

In Northern California's Humboldt County, voters decided by a 55-45 margin that corporations do not have the same rights — based on the supposed "personhood" of the combines — as citizens when it comes to participating in local political campaigns.

Until Tuesday in Humboldt County, corporations were able to claim citizenship rights, as they do elsewhere in the United States. In the context of electoral politics, corporations that were not headquartered in the county took advantage of the same rules that allowed individuals who are not residents to make campaign contributions in order to influence local cam-

paigns

But, with the passage of Measure T, an initiative referendum that was placed on the ballot by Humboldt County residents, voters have signaled that they want out-of-town corporations barred from meddling in local elections.

Measure T was backed by the county's Green and Democratic parties, as well as labor unions and many elected officials in a region where politics are so progressive that the Greens — whose 2004 presidential candidate, David Cobb, is a resident of the county and a active promoter of the challenges to corporate power mounted by Democracy Unlimited of Humboldt County and the national Liberty Tree Foundation — are a major force in local politics.

The "Yes on T" campaign was rooted in regard for the American experiment, from its slogan "Vote Yes for Local Control of Our Democracy," to the references to Tuesday's election as a modern-day "Boston Tea Party," to the quote from Thomas Jefferson that was highlighted in election materials: "I hope we shall crush in its birth the aristocracy of our monied corporations which dare already to challenge our government to a trial by strength, and bid defiance to the laws of our country."

Just as Jefferson and his contemporaries were angered by dominance of the affairs of the American colonies by King George III and the British business combines that exploited the natural and human resources of what would become the United States — and wary of the machinations of those who would establish an American economic royalism — so

Humboldt County residents were angered by the attempts of outside corporate interests to dominate local politics.


Wal-Mart spent \$250,000 on a 1999 attempt to change the city of Eureka's zoning laws in order to clear the way for one of the retail giant's big-box stores. Five years later, MAXXAM Inc., a forest products company, got upset with the efforts of local District Attorney Paul Gallegos to enforce regulations on its operations in the county and spent \$300,000 on a faked-up campaign to recall him from office. The same year saw outside corporations that were interested in exploiting the county's abundant natural resources meddling in its local election campaigns.

That was the last straw for a lot of Humboldt County residents. They organized to put Measure T on the ballot, declaring, "Our Founding Fathers never intended corporations to have this kind of power."

"Every person has the right to sign petition recalls and to contribute money to political campaigns. Measure T will not affect these individual rights," explained Kaitlin Sopoci-Belknap, a resident of Eureka who was one of the leaders of the Yes on T campaign. "But individuals hold these political rights by virtue of their status as humans in a democracy and, simply put, a corporation is not a person."

Despite the logic of that assessment, the electoral battle in Humboldt County was a heated one, and Measure T's passage will not end it. Now, the corporate campaign will move to the courts. So this is only a start. But what a monumental start it is!

lutely right when she portrayed Tuesday's vote as nothing less than the beginning of "the process of reclaiming our county" from the "tyranny" of concentrated economic and political nower

Surely Tom Paine would have agreed. It was Paine who suggested to the revolutionaries of 1776, as they dared challenge the most powerful empire on the planet, that: "We have it in our power to begin the world over again. A situation similar to the present hath not happened since the days of Noah until now. The birthday of the new world is at hand, and a race of men, perhaps as numerous as all Europe contains, are to receive their portion of freedom from the events of a few months.'

It is time to renew the American experiment, to rebuild its battered institutions on the solid foundation of empowered citizens and regulated corporations. Let us hope that the spirit of '76 prevailed Tuesday in Humboldt County will spread until that day when American democracy is guided by the will of the people rather than the campaign contribution checks of the corporations that are the rampaging "empires" of our age.

Expanding on the danger of corporate personhood, the movie screen will explode with images of corporate abuse against individuals and society.

# THE NEAR FUTURE IN LIGHT OF HISTORY

America won its greatest victory against Italian fascists, German Nazis, and Japanese imperialists while fighting for democracy under the leadership of liberal President Franklin Delano Roosevelt. After WWII, humanity renewed its hope in the flowering of a great civilization founded on the principles of the Universal Declaration of Human Rights: a world in which nuclear holocausts like Hiroshima and Nagasaki would never again happen; where war, death-camps, fascist oppression, and gulags, would forever be mere memories of past insanity; where international law would settle disputes and people everywhere would become self-governing; where victorious nations would cease selling instruments of death and instead spread the profitable tools of healthcare, economic prosperity, and environmental conservation.

However, the realization of this hope, this beautiful dream, never did come to pass. Bloodshed and destruction quickly resumed and continue to this day: Korea, Vietnam, Palestine, Nicaragua, Guatemala, Iran, East Timor, Africa, Cambodia, Chile, Argentina, Bosnia, and Iraq. Why did all members of the UN including the U.S. fail so miserably? Because of the perennial Oids!

# THE ODIOUS OIDS - WHO ARE THEY?

Thomas Paine said: "He who dares not offend cannot be honest." So, we are going to tell you about the Oids, and then insult them with every name in the book. Read on.

#### Christianoids

the Brazilian interior selling Coleman lamps and stoves to primative villages as a way to earn college tuition.

He came to the United States to study geology at the Colorado School of Mines in 1950 and later prospected in the Mexican states of Sonora and Durango. After selling his interest in his Mexican mineral discoveries, he returned to Europe to do documentary film work.

It was here that he collaborated with director Fellini on a project entitled The Stange Voyage of Mr. Mastorna and learned directing and cinema acting during the Fellini creations of 8-1/2 and Boccaccio 70. He had a brief professional relationship with Luchino Visconti. Vidali also dealt with government and entertainment industry VIPs such as President Johnson, Jack Valenti, John Mecum, and Peter

His documentary works originated a new genre, superimposing fiction on real-life documentary backgrounds. Straw Hat and the Crown, shown on the Italian R.A.I. Television Network, received recognition even from the Vatican for its subtle moral theme set off by contrasting a fairy tale on a background of real life events. In 1963, Vidali went to Africa

as Second Unit Director of the feature documentary *Good-bye Africa*, a Rizzoli Production. He covered South Africa, Southwest Africa, Mozambique, Kenya, Zanzibar, Congo, and Angola. This exposed him to a wide range of human beings, both as a film director as well as the liaison officer between the South African government and the Italian film unit.

Back in the U.S. in 1965, Aldo wrote and directed Sunset at Dawn, a predictive environmental film essay on the worsening ecological crisis, followed by Trail to the Stars, a film view of the NASA space program contrasted with America's pioneering past. These were followed by a series of minor commercial works.

In 1978, Vidali participated in the environmental-political campaign in Kauai, Hawaii, to save the island's pristine shorelines at Nukoli'i from yet another tourist development.

A champion of the environment, Vidali later challenged Republican Interior Secretary James Watt, when Watt opened vast sections of Federal lands to exploitation. Vidali developed a plan to preserve the wilderness by rushing to the Denali region of Alaska, forming the Alaska Capital Corporation (ALCOR), and leasing thousands of acres of federal oil lands.

Explained Vidali, "The Watt Administration had assumed that small entrepreneurs could not afford to drill in the Arctic, thus leaving the course clear for major players. ALCOR deliberately proceeded to subdivide the leases into impractical 40-acre parcels, which would oblige major oil companies to buy out each and every one from far too many owners before they could move in and drill. One single holdout lease could stall exploration for years.'

Vidali hired and trained agents to successfully distribute tiny oil lease parcels across the nation. This maneuver caught the oil industry by surprise, and by the time they pressed the government to impose a minimum parcel size of 2,500 acres, it was too late. Big Oil tried to make the law retroactive. Vidali blocked that illegal attempt by notifying all leaseholders to demand their rights against this undemocratic scheme of Big Oil. This tactic was successful, and thus prevented major exploitation of the Denali for 10 years.

Vidali returned to the mainland in late 2000 where his family created a film with students under the UNECO label entitled Life & Liberty in the Balance, protesting the court appointed Bush administration. Vidali is currently in pre-production of a full feature documentary: Toward a Global Open Society, a dialogue between great contemporary minds and the American people. This film addresses the urgent need of all citizens to participate directly in dialogue and action to restore their Constitutional Republic.

Reviving the motion picture work developed under Fellini's guidance, Vidali is now teaching and preparing productions dedicated to promoting the restoration of American Democracy, defense of the Bill of Rights, and openly denouncing the neo-fascist "Patriot" Act and the neo-con imperialistic scheme against America.

Vidali currently lives with his wife and two sons on California's Central Coast. He volunteers as Chairman of UNECO, a nonprofit environmental and humanitarian corporation, and is active in the United Defenders of Liberty Movement.

He speaks English, Italian, Spanish, French, and Portuguese, and is a public lecturer on social, educational, and environmental subjects.

# George Lakoff Discusses 'Tort Reform'

Restrictions on tort lawsuits and other kinds of lawsuits are issues near and dear to conservative hearts. The following interview with Rockridge Senior Fellow George Lakoff explores various aspects of "tort reform," including the manner in which conservatives have framed the discussion, the problem with the progressive response so far, and ideas for more effective progressive framing of the debate.


**Q:** Professor Lakoff, why have conservatives made such a major issue of "tort reform" and "lawsuit abuse"?

Lakoff: For two main reasons. The conservative worldview includes the fundamental belief that business is only about profits. They believe that anything that interferes with the opportunity to maximize profits, including the range of protections that are so important for society, should be eliminated or at least severely restricted. And of course, lawsuits to compensate for injuries and to punish those who knowingly caused them are some of those socially important protection mechanisms that can diminish profits.

So, the right wing is attempting to destroy this system by promoting legislation to eliminate punitive damages and cap compensatory damages to relatively small sums. This legislation benefits business both by minimizing the risk of any single suit and by creating a disincentive for lawyers to take cases. Lawyers have to spend their own money to search for evidence of harm, to put together a case, and to prosecute the trial. Their compensation, if any, is a percentage of the "recovery" — the compensa-tory and punitive damages. Though the lawyers' fees sound high, most of those fees go to support the system. If damages are capped or eliminated, the system will break down for lack of funding.

The attack on tort suits also amounts to an attack on those lawyers who represent injured parties. Those lawyers have historically supported progressive causes and candidates. Not to put too fine a point on it, conservatives want to dry up the flow of contributions from trial lawyers by squeezing their source of income.

**Q:** How have conservatives mounted their attack?

Lakoff: They have very cleverly framed the public discussion and have repeated these frames so often and for so long that they have become ingrained in the public's mind, which means that those frames have become realized physically in the brains of many members of the public.

**Q:** What are some of those frames?

Lakoff: To begin, the very phrase "tort reform" evokes a frame. In two words, it communicates that something is the matter with the tort system. which requires reform or correction. In this respect, the phrase is similar to another effective conservative phrase, "tax relief." Once the public accepts these phrases, they have bought into the idea that they need to be relieved from the affliction of taxes and that they need to fix the tort system. The debate then turns to the question of how and how much. At that point, progressives can't win the debate; the best we can do is limit the losses.

**Q:** What other frames have the conservatives employed?

Lakoff: They repeat the phrases "lawsuit abuse" and "frivolous lawsuits." They refer to "greedy" and "out of control" lawyers. These words suggest that the speaker is a good, honorable, hard-working, God-fearing person. Opposition to abuse

communicates reverence. Being against something frivolous is to be prudent and serious. Opposition to things out-of-control implies being orderly and law abiding.

Let's take another expression that they often use: "litigation lottery." In order to meaningfully use a word like "lottery you need a frame. That frame has in it everything about a lottery. It's gambling. It says you're not making money by being an honest, hard working person going to work every day. You're trying to make money just by gambling. That sets up a contrast between the kinds of people who are diligent, careful and frugal and those who want something for nothing and perhaps are willing to cheat to get

Once they've twisted the discussion to the point where people accept that lawsuits are bad things, the "tort reformers" take it another step. They say that the "frivolous lawsuits" are the cause of the high costs of health care and health insurance. Because people have accepted the frames, they are willing – even in the face of contrary evidence – to believe these statements.

**Q:** How have the conservatives been able to come up with such effective frames and messaging?

Lakoff: That's easy. Time and

money. Extremely well-funded conservative think tanks have been tackling these issues for the last 40 years. They have become quite expert at figuring out how to frame messages that appeal to persuadable voters.

Q: Have consumer advocates, trial lawyers, and other progressives had much success responding to these conservative frames?

Lakoff: No. Despite spending great sums of money, they have had very little success, as we've seen with all the new tort reform legislation at both the state and federal levels. And more legislation is in the pipeline.

**Q:** To what do you attribute this lack of success?

Lakoff: The primary reason is that the progressive groups you mention have fought the fight on the "tort reformers" turf, that is they have merely offered facts to rebut the conservatives' frames, leaving the frames intact. They've tried to show that lawsuits aren't frivolous, that lawyers aren't greedy, that plaintiffs are genuinely aggrieved. It's like Nixon saying, "I am not a crook," which made everyone think of Nixon as a crook. As I said before, once you go down that road you've already lost the fight. It's only a question of how badly.

Q: What's the alternative? Lakoff: First, we have to recognize that when the right wing says "tort reform," what they really mean is destruction of the civil justice system. Just what is the civil justice system? Most people have a frame for the criminal justice system, but not the for the civil justice system. Since a corporation isn't literally a person, it can't be put in jail for performing harmful or murderous acts. When corporations engage in practices that harm or kill people, the only way through the legal system to punish them and give them an incentive to stop their harmful practices is to sue them and make them pay.

In the civil justice system, the trial is in the form of a lawsuit. The victims of harm are the plaintiffs and the defendants are typically corporations. The roles of police and prosecutors are played by the plaintiffs' lawyers. The victims come to lawyers (the only police). The lawyers search for evidence of harmful corporate behavior. The plaintiffs' lawyers act as prosecutors. The punishments are of two kinds: compensatory damages (compensating victims for harm); and punitive damages (punishing corporations that do

Since a billion-dollar corporation cannot be imprisoned, only very large compensatory and punitive damages can provide sufficient disincentives from doing harm. Given the current climate of less and less regulation of business and increasingly lax or underfunded enforcement of what regulations remain, the civil justice system is rapidly becoming society's only line of defense. Without it, the unscrupulous can and will run roughshod over the American people, maiming people, making them seriously ill, and sometimes killing them — all in the name of profit. Limiting profits is the only deterrence in many cases. Bear in mind that conservative voters believe in deterrence. It's a basis for their support of the death penalty, for example.

Conservatives also believe in the concept of being responsible and accountable. It relates to their strict father family model for society and government that I've written

what do progressives do?

Lakoff: What we have to do is create and communicate our own major frames, frames that communicate this fundamental role of lawsuits and trial lawyers in protecting the public. These frames must be communicated through narratives that people understand and resonate to. There are two key components here. The first is the notion of protection. The second is the idea that it is the public that is protected rather than certain individuals being compensated for injuries.

**Q:** Why is that important?

Lakoff: Because as a general rule, people don't readily identify with victims. They tend to think that those victims somehow haven't taken care of themselves properly. So the more effective frame is the bigger picture of societal protection.

Q: How would that work?

Lakoff: Let me back up slightly. Progressives must understand that the business of America is business. Most people are involved with business. Most people are honest and want to do the right thing. Trust is an essential component of a healthy, functioning business economy. But there are dishonest, unscrupulous business people that undermine that trust. We must emphasize that the marketplace itself is under threat from those bad actors. Lawyers are necessary to bring the suits that ferret out those who undermine trust and threaten the health of the marketplace.

**Q:** What other frames do you think would be effective?

Lakoff: Plaintiffs are and should be portrayed as courageous souls. After having suffered harm at the hands of the defendant, they must stand up to the rigors of the justice system, including intense cross-examination and personal attacks, and must display the great patience to withstand the delays of the process. They do it not just for themselves, but for the public as well.

I should emphasize that though I feel strongly about these ideas, none have yet been researched and tested. That's something that we at Rockridge have on our plate.

Q: How do you communicate these points?

Lakoff: We must create narratives that reclaim the moral high ground: unscrupulous businesses against lawyers—the police and prosecutors—who protect the public. An important image is the open door to the courthouse. Conservatives want to slam the courthouse door shut. We want to keep it open. That concept encompasses everything from preserving the laws that protect the public, to the right of juries to impose fair damage awards that won't be taken away by judges, to the right of plaintiffs to be able to contract with their lawyers without government interference.

**Q:** Are word choices important as well? **Lakoff:** Of course. I'll give you a couple

of examples. I've already mentioned the phrase "tort reform." This plays so well into the conservative frame. Progressives should not repeat this phrase. They should point out over and over that conservatives are trying to

It was the great Clarence Darrow who asserted "the trouble with law is lawyers," and many people seem to have taken that admonition to heart.

Trial lawyers have attained a rather unenviable status in the public's eye. People who re-

serve judgment about rabid dogs or members of the New York Yankees appear eager to spew vitriol about attorneys, blaming them for everything from soaring medical costs to the heartbreak of psoriasis.

It's an odd position. Trial lawyers, after all, usually represent small people with big problems, whether it's an injury resulting from time spent on the operating table or utilizing a simple, though defective, home ap-

pliance. Without a trial lawyer guiding them through the civil justice system, consumers and patients would suffer in silence, be dismissed as frivolous and giant corporations would escape being held accountable for gross negligence.

Recall for a moment the experience of Erin Brockovich, who in 1993, working as a legal assistant for a California law firm, discovered that a Pacific Gas & Electric plant near the small desert town of Hinkley was leaching chromium 6, a rust inhibitor considered a human carcinogen, into the village water supply. Brockovich lined up about 650 plaintiffs and the firm filed suit, claiming the infestation led to an untold number of health problems, including breast cancer, Hodgkin's disease, miscarriages and spinal deterioration.

In 1996 PG&E settled the case, forced into paying for health care costs and damage they'd done the residents. Brockovich was hailed as a hero, and well she should have been. But this is the just one example of the type of incidents trial lawyers are endeavoring to bring to the public's attention everyday.

Trial lawyers are, or at least should be, secure in the knowledge that they are on the right side of both the issues and history. They are the ones pressing the case against interests who have a financial stake in making America less safe. Ironically, and sadly, that's why they are held in such disregard.

It should surprise no one that powerful interests have taken a passionate dislike to trial lawyers, precisely because they are using the civil justice system to hold them responsible for



the civil justice system suddenly curled up into a big ball and died. They're already holding a

straight flush, ace high, and razing the courthouse would leave them sitting with all the chips.

So the big corporations are using their collective power and billions and billions of dollars to disparage trial lawyers, accusing them of destroying the American way of life by undermining the economy and driving kindly, old, country docs from their practice. The campaign has proved as relentless and destructive as Sherman's

March to the Sea, resulting in a general loathing of trial lawyers and what they stand for

And they have potent allies sounding the same theme. President Bush has founded a cottage industry attacking trial lawyers, taking the opportunity on scores of occasions to assert that "junk lawsuits" filed by trial attorneys are responsible for lost jobs and high healthcare costs. Administration talking points appear to travel from U.S. Chamber of Commerce President Tom Donohue's lips to the president's ear.

The U.S. Chamber, the nation's largest lobbying outfit, an organization with access to a bottomless money pit and an agenda focused on further enriching the titans of multi-national corporations, is pummeling trial lawyers to get at consumers and workers who, through no fault of their own, face ruin as a result of a defective product or piece of equipment.

Like the schoolyard bully it is, the Chamber is pulling out all the stops to assure Big Business won't be held accountable for the faulty, often dangerous, sometimes deadly, merchandise corporations push on the market. They're achieving this end through strategies with technical names like "tort reform." Whatever titles the Chamber chooses to use, you can be sure it's all to the detriment of the American consumer and worker.

Trial lawyers have historically taken a reasoned approach to deflect the incessant slander, repelling efforts to destroy the nation's civil justice system by noting that the number of doctors is rising while the incidence of malpractice suits is falling. That it's been trial lawyers holding pharmaceutical giant

destroy our precious system of justice. Another example is "trial lawyers." It's a label that conservatives have been vilifying for a long time. It would take a lot of effort to try to revive any positive connotations. More importantly, it doesn't communicate the frames that I've discussed. By contrast, "public protection attorneys" communicates the right frames and avoids the negative connotations. But this can't be used until the idea of the civil justice system and protection is first in place in the public mind.

Remember that it's not just a matter of words. It is a matter of conveying a complex truth to the public, a truth in the form of a high-level complex frame. This cannot be done just by describing it once. The civil justice system has to be described over and over, and portrayed in the arts and the media. Words are important, but ideas come first.

This is not a matter of one ad campaign. It must become part of the system of progressive ideas, part of the framework progressives use to think about public issues.

**Q:** Where do we go from here?

Lakoff: That's what Rockridge is all about. We are in the process of writing a Progressive Manual that will offer a fresh, reframed approach to the whole range progressive values and issues. The issues we've talked about today will be included in our section about public protection. With help from the progressive community, we'll be able to do our work quickly and well, and generate a product that will help reshape the political dialogue for the long term. We are running a marathon here, not a sprint.

Defense of the civil justice system is not just a trial lawyers' issue. It is an issue for all progressives, just as "tort reform" is an issue for conservatives in general. The trial lawyers should not be standing alone here. They should be supported by the environmental community, the labor community, the antipoverty community, and every other progressive in America. Trial lawyers are not just defending their clients; they are defending all of us by making the civil justice system possible.

# Lawyers Fight For The Public

Merck accountable for marketing the pain-killer Vioxx long after it was determined to have a dangerous health impact

But there's no denying that the U.S. Chamber of Commerce and others of its ilk are winning the public relations war. Using its billions to spread lies aimed at destroying the civil justice system, corporate CEOs have trial lawyers on the ropes.

Well, to quote the great 20th Century philosopher, Popeye the Sailorman, "That's all I can stands, I can't stands no more!" The time is long past due for trial lawyers to switch tactics and counter-attack with the sort of zeal that, to this point, has been reserved for those who would endeavor to destroy the very system lawyers are sworn to uphold. The defensive crouch trial lawyers have assumed has to be replaced by a full frontal assault on those using deception and fraud to hurt America.

Trial lawyers have the facts on their side. Studies firmly establish that malpractice insurance rates are attributable to poor investments, not large claims. The number of lawsuits is declining, along with payouts and there are more doctors practicing than at any time in history. Not exactly the crisis foes of the civil justice system describe.

And there simply is no logical explanation for imposing an arbitrary, one-size-fits-all cap on non-economic damages in cases where a company's gross negligence leads to an individual's massive injury. Ask a worker if the loss of an arm, or ask a mother who has lost her daughter, whether such limits should be placed on their grief.

But that's not sufficient. It needs to be pointed out that it's corporate CEOs and the insurance industry that benefit from destroying the civil justice system to the detriment of the public at large. The American people are being sold a bill of goods so corporations and insurance firms can further enrich themselves and not be held accountable for their instances of gross negligence.

CEOs don't want to be held

responsible but they sure want to pick the pockets of an innocent public.

There's a lesson to be learned from people like Carlene Lewis, who died much too young this month at age 51 from ovarian cancer. Lewis was a trial lawyer in Houston who, in the fall of 2000, grew concerned about the health implications of Vioxx, a painkiller manufactured by Merck. It seems the mother of a friend started taking Vioxx and lost her job after falling ill. Merck wanted to settle, but Lewis invested precious hours and money into research to determine the extent of the problem.

It turned out to be massive. Merck's own memos prove the company knew Vioxx had heart risks as early as 1997. Those risks were confirmed by a clinical trial in 2000. Yet Merck continued to rake in billions of dollars by aggressively marketing the drug, even inventing a game called "Dodgeball" to teach drug representatives how to evade doctors' tough questions about the drug's safety.

FDA scientist David Graham told Congress that Vioxx contributed to the death of as many as 55,000 Americans.

Through the efforts of Lewis and attorneys like her, America is a safer place and the wrongdoers are being held accountable. Remember that next time someone bad mouths a trial lawyer.

It's true that Darrow warned that the trouble with the law is lawyers, but he also said, "As long as the world shall last there will be wrongs, and if no man objected and no man rebelled, those wrongs would last forever."

profits for big corporations.

It isn't that premium costs go up when a big corporation loses a lawsuit. Profits in the hands of the higher echelon CEOs perhaps go down some. Lawsuits are the tools that force wolves to do what's right.

For example, we know the case where a woman had a stroke. Her insurance company intervened immediately after learning of the stroke and ordered medical personnel to stop the therapy, because the company didn't want to pay for it. So therapy was stopped. When the family finally discovered that this had happened during the all-important first days after the stroke when regaining function is critical, a lawsuit was launched and eventually some retribution occurred. The insurance company didn't think anyone would notice and even then thought nobody would fight it. Insurance companies might call it tort. The family deemed the actions by the insurance company as those of a demon. Lawyers made the difference.

And what about this?

You have to buy insurance if you have a mortgage on your home or if you drive a car, so you buy insurance — which is forced gambling, against yourself.

Lightning hits your home, blowing out a number of appliances and causing other damage. Your deductible is \$200, but damage amounts to \$1,000. You are encouraged by the insurance company not to file a claim, for if you do, your rates will go up, if you can find anyone to insure you at all in the future, which could affect your ability to adhere to the conditions of your mortgage loan. So, what do you

do? You pay the entire cost of repair out of pocket.

Multiply this scenario by tens of thousands and ask what is this type of maneuver adding to the insurance companies' profit line?

You are being forced to buy something that is useless, which succinctly defines today's neo-con corporatism. Stealing from the little guy and giving to the rich.

Without lawyers, things like this, or bad meds allowed to continually flood the marketplace, will go unchecked. They win. You lose.

When caps are placed on lawsuits, this undermines the capability of our citizens not only to regain what they might have lost, but to even be able to find representation, for the paperwork and legal maneuvering through the justice system is expensive.

So by denying attorneys the ability to utilize the judicial system, tort laws are actually removing individual rights of the common citizen, cutting recourse dead in its tracks.

We are advancing to a day when the majority of the assets of the United States will be owned or controlled by a few big companies, corporations that define our government, dictate our laws, ramrod our courts, and put into action military conflicts that result in monetary profits for the stockholders as they control our everyday lives. They will know everything about us, they will be able to track us, and they will hasten to dampen any and all attempts at rebellion.

Gore listed five recent studies that supported his position.

Of the more than a million people who have watched the movie since May, none of them have included President George W. Bush and the chiefs of the Environmental Protection Agency and NASA.

# **Net Neutrality Could Be** Revived On Senate Floor

WASHINGTON — The U.S. Senate Commerce Committee last Wednesday threw out a "network neutrality" provision to a larger telecommunications bill in a tie vote. An amendment to keep Internet service providers from discriminating against traffic from content providers could still be made on the Senate floor before a vote.

When that vote would be, no one knows, but Sen. Ron Wyden (D-Ore.) said in a statement that he could use a parliamentary procedure to stop a vote until a net neutrality proposal is included.

Net neutrality advocates found a silver-lining to the split vote, noting that members of their grassroots efforts would have more time to contact their senators over the issue. There is still cause for concern since the House passed its own version of the telecom overhaul without a net neutrality provision last month.

# 17th Caravan To Cuba Stops At Crawford Peace House Saturday

CRAWFORD — On the way to the U.S. border with Mexico where they will defy U.S. restrictions on travel and aid to Cuba, the 17th Pastors for Peace Friendshipment Caravan visited the Crawford Peace House on Saturday, July 1. The following day, hundreds of volunteers from the U.S. and seven other countries are slated to cross the U.S. border into Mexico with the humanitarian aid they have collected for the people of Cuba.

The caravan was welcomed during the afternoon in the Peace House garden, and sent off with the support and good wishes of local activists, along with contributions of a bicycle and goods. The gathering was open to anyone wishing to attend.

The contingent coming through Crawford was headed by Rev. Luis Barrios, who is the associate priest at St. Mary's Episcopal Church in West Harlem and associate professor of psychology and ethnic studies at John Jay College of Criminal Justice-City University of New York. He is also writes weekly column for a Spanishlanguage newspaper.

"We look forward to the Pastors for Peace caravan each summer," said Kay Lucas, a board member of the Crawford Peace House. "The blockade on aid to Cuba is contrary to the humanitarian character of Americans and we hope it will soon be ended."

The blockade policy was responsible for last summer's seizure of computers from the Friendshipment by border officials. They were only released in May and this victory was celebrated at the Peace House

event.

Late last year, the United Nations General Assembly voted 182-4 to end the blockade, but the Bush administration instead continues to seek ways to tighten it. The policy on Cuba

relations leaves the U.S. isolated in the world community.

The 17th Friendshipment is traveling to Cuba via school buses, trucks, and cars on 13 different routes and along the way has visited more than 120 US and Canadian cities. It is collecting medical and educational supplies from groups across the U.S. and Canada, refusing U.S. Treasury Department licenses, as a collective challenge to the blockade and travel ban.

Pastors for Peace has used hunger strikes and mass mobilizations to successfully challenge the U.S. governments past attempts to confiscate vehicles and humanitarian aid crossing the Mexican border on its way to Cuba. Since 1992, IFCO/Pastors for Peace has delivered more than 2,350 tons of urgently needed assistance to the Cuban people without seeking a U.S. Treasury license.

Accompanying the caravan were Alisa Geiser and Nichole Paquet who, through a grant from the University of Colorado at Boulder and some private funding, were documenting the trip.

"We're here to document the group and travel with them all the way to Cuba," said Geiser. "It's been an amazing opportunity so far and it's only getting better. The people we've met along the way have been amazing — the communities we've seen, have been embraced by, have been incredible little pieces of America we didn't even know existed."

For Paquet, this was her second trip to Cuba.

Brianna Harris, one of the coordinators of the Friendshipment caravan commented in Crawford, "This year our focus in on collecting humanitarian aid for children with special needs, so a lot of the aid we're collecting from across the United States will go to children who are blind, deaf, or learning disabled, going to support what Cuba does for those children."

# By Dawn's Early Light

The handwritten manuscript left by George Royalty Hopson entitled *By Dawns Early Light*, is an account of his feelings and thoughts around the time of the surrender of Japan at the end of World War II. The manuscript is courtesy of Rex C. Hopson, nephew of George R. Hopson.

George Royalty Hopson, 1912 - 1984, the son of Meridian Shoe Shop owners during the 1920s and 1930s, Rueben H. and Lydia Hopson, graduated from Meridian College and Howard Payne College of Brownwood. He served in the U.S. Navy during World War II and in the Navy Reserve until 1971.

Hopson was both a Baptist minister and a weather man in San Angelo. He was also considered a writer and a genealogist. In the 1960s, her served on the San Angelo City Council.

According to the information contained in *Bosque County Armed Forces Veterans — Volume 1*, George R. Hopson served as a weather observer in WWII.

Aerographers Mate/2c George Royalty Hopson, the sone of Mr. and Mrs. R.H. Hopson, was born Sept. 12, 1912, in Coryell County, Texas. He lived in Meridian from 1916 until 1933, and received his public school education in Bosque County. He attended Howard Payne College as a ministerial student and pastored several churches in west Texas. He was married to Opal Williams July 13, 1934, in Houston.

He then went into professional Boy Scout work, becoming a field executive in Del Rio before entering the U.S. Navy in 1944. He attended the naval aerographer school Lakehurst, New Jersey where he trained as a weather observer. Discharged from active service in 1945, Hopson remained in the Naval Reserve until retiring in 1971. While in the reserve he was a senior chief aerographer's mate. Her served during World War II with Atlantic Fleet Central in Norfolk, Virginia.

Hopson came to San Angelo in 1947 when the weather service put in its station at Mathis Field after serving in a similar capacity in Del Rio. He was employed at the National Weather Service office here until his retirement in 1971.

Hopson entered his first campaign for public office in 1968 and was elected a city commissioner and later was elected mayor pro-tem of San Angelo. He was a former president of the Knights of the Round Table.

He authored a book called "Some Very Fine Folks." At the time of his death he was a deacon of the First Baptist Church and a teacher of the Goodfellow Bible Class.

George R. Hopson was buried with military graveside rites in Fairmount Cemetery, San Angelo in 1976. Survivors at that time were his wife, a daughter, Daphne A. Hodges, and a grandson

#### By Dawns Early Light

I have for years been intrigued by a phenomena I observed among servicemen while I was in the Navy during World War II. As military men, it would likely be expected that they would have a little more patriotism than the average person. Indeed they may have, and if so, then I am certainly at a loss to explain the tendency of service men to avoid paying simple respect to the flag.

I am referring primarily to the color ceremonies in the early morning and the late afternoon on military bases and stations, including ships. When the flag is being raised in the morning or lowered in the late afternoon, all outside activity momentarily stops. Men in uniform who are not under cover, meaning those outside of buildings and shelters of any kind, on hearing the bugle or band must face the flag and salute as long as the music continues. If the flag is not in sight, the salute is made anyway, facing in the direction of the music. With the last note, the salute is dropped and the carry on is assumed.

This little ceremony is really a rather pretty and meaningful thing but for some reason, most service men avoid it when possible to do so. I have often observed sailors to suddenly break for an open door or quickly jump bugler put horn to his mouth, rather than to stand the sixty second ceremony. Lest I sound too critical of my shipmates, let me confess that on occasion I have been guilty of doing the same thing myself. That makes the act even more difficult to explain because I cannot explain why I did it. Observing this ritual is not at all unpleasant and the time involved is so short that one could not use loss of time as an excuse. In fact, few people are in that much of a hurry even on a wartime base.

I have already confessed my occasional guilt in the violation of their patriotic etiquette, but a thing happened that made me double ashamed of myself and all other service men who neglect any opportunity to pay tribute to our national emblem.

Within a few days after the A-Bomb was dropped on Hiroshima, I was transferred from the Atlantic Fleet Weather Central in Norfolk, Virginia to the Recovery Station on Hampton Boulevard. In Norfolk for further transfer to Bermuda Navy weather station. While I was in the receiving station, Japan sued for peace and in a few days, V-J Day came when the war was over. I was still on that station on V-J Day.

Since the war had been winding down to a close for several weeks, many men were in the process of being transferred and the receiving station had men everywhere they could be bedded down. To keep these men even moderately occupied, every conceivable task was dreamed up. They even had men standing guard over the garbage.

The signing of the treaty by President Truman took place late in the afternoon. I was standing guard duty in the records building where all transfers were finally made and issued. What I was guarding was never told to me but it was really pleasant duty. I had the run of the complete large and open office with access to the coffee and refreshment bar. A very pleasantly dispositioned lieutenant had a radio on his desk and several of us were gathered at his desk that fateful afternoon to follow the momentous happenings of history as they took place.

The radio announcer, with an emotionally charged voice and almost in breathless whisper, described the president as he left the White House on foot to walk to the nearby State Department building, carrying a large manila envelope. After he en-

tered the State Department building the announcer nervously tried to say something that would keep his unseen audience listening until the president should reappear. The announcer need not have feared the loss of his audience if they were all like the group around the desk in Norfolk. We hung on every word with no thought of trying to start a conversation of our own. Traffic was moving at its normal later afternoon rush down Hampton Boulevard as Navy base personnel left their job for the day. Many people were traveling in the other direction toward the Newport

The air seemed charged with excitement in the office where we were and I am sure we all wondered how any other people knew what was going on, as we did. It was almost as if we were waiting for the announcement of the winner of the big prize. In this case the prize was indeed great and we knew who the winner was going to be, but tension mounted by the moment.

Suddenly the voice of the announcer quickened and even changed pitch as he said that the president had come out of the State Department and was smiling as he was approached by a group of newsmen. He then switched the microphone to one of the news announcers who asked the president if he had any announcement to make concerning a peace treaty with Japan. In a pleasant but solemn voice he said, "Yes, I am glad to say that Japan has accepted and signed our terms of unconditional surrender and the war is ended.'

We immediately had our answer as to how many people might be aware of what was happening, for it seemed that every car on Hampton Boulevard started blowing its horn. Indeed, I dare say every car on every street in Norfolk was wildly blowing its horn. In the office, enlisted men were embracing WAVE officers and men alike, rank, rate, and sex had suddenly been forgotten when we realized the fighting, killing, expense, broken homes, and wartime inconveniences were soon to be ended. Our party was soon over because it was closing time, but the celebration went on all night in most of the USA.

My guard tour in that office ended at 6 p.m. and twelve hours later I went on another two-hour watch standing guard over the loading dock for incoming personnel. Those buses that brought men into the station during the night would drop the men at the barracks, then bring their luggage to the unloading platform, where it would be picked up by the men in the morning. This was one bit of good duty that did make a little sense, however, there never was much of a tendency among Navy men to steal another man's gear, and since the war was over, more military gear was the last thing anyone wanted.

As I arrived at my post at 6 a.m., it was just getting daylight. I sat down on a stack of sea-bags on that otherwise deserted platform that was covered by a sheet-iron awning. Once in a while a sailor would walk by, so I had nothing to do but sit and think about what had happened the day before and how it would affect the days ahead. The end of the war had been a dream, but now the dream was a reality and I felt the urgency to make some plans for the future, but felt a complete loss as to when I might start. While I was thinking such thoughts, time was passing rapidly. I heard the familiar sound of a marching cadence being chanted by a Marine non-com. Glancing at my watch I saw it only a few minutes before 8 a.m., the time for raising the flag. The flagpole was less than a hundred yards, and in plain view from where I sat. The Marine drum and bugle corps with the folded colors stopped in front of the flag pole, and the color guard made preparations by snapping lanyard into the grommets on the flag. All but one of the color guard stepped back and the drum and bugle corps came to attention.

There I was sitting peacefully "under cover" where no salute nor standing at attention was expected of me — but suddenly the thought hit me, "What if my country had been the loser in the war?" But thank God we won and by His grace our flag was going to fly proudly and victoriously again today. As if propelled by a catapult, I left my comfortable seat and jumped to the ground in the bright early morning sunshine and at the sound of the first note of the bugle, I was standing rigidly at attention and had thrown the snappiest salute I had ever made. I saw our star spangled banner start up the mast, but long before it reached the top, it faded from view because I could not see it through my tears of joy and thankfulness.

I had some idea of how Francis Scott Key must have felt.

# ACLU Of Texas Files Lawsuit Over Restrictions On Protesters Outside President's Ranch

# Plaintiffs Include Cindy Sheehan, Daniel Ellsberg, Ann Wright

WACO — The American Civil Liberties Union of Texas last week asked a district judge to block McLennan County officials from enforcing orders aimed at restricting anti-war protesters outside President Bush's ranch in Crawford, saying the orders violate free speech rights and exceed the officials' authority.

"This suit is not about the president or politics. It is not even about the war," said Will Harrell, Executive Director of the ACLU of Texas. "It is about the County Commissioners' decision to overstep their own authority in an effort to unlawfully restrict the protected activities of a group of protesters and the media by limiting their access to space, restroom fa-

cilities, and shelter from the elements."

The ACLU is representing Cindy Sheehan, whose son Casey was killed in Iraq on April 4, 2004, and became a leading voice against the war after going to Crawford last summer in the hopes of meeting with President Bush. She was joined by thousand of activists from across the country at "Camp Casey I," including plaintiff Daniel Ellsberg, author of the Pentagon Papers, and plaintiff Ann Wright, a Colonel with the U.S. Army Reserve and former Deputy Chief of Mission at the U.S. Embassy in Afghanistan, who resigned from the State Department in protest of the invasion of Iraq in 2003.

The challenged orders are aimed at shutting down Camp Casey I. The orders specifically prohibit stopping and parking vehicles on specific roads in McLennan County, and "residing, erecting shelters or erecting sewage receptacles on the right of way of public roads." The effect of the orders, the ACLU said, was to force protesters to stand in direct sun at all times in a location where temperatures in August regularly top 100 degrees, and drive or walk 10 roundtrip miles each time they needed to use the bathroom, or face arrest and possible crimi-

"The County Commissioners do not have any legal authority to restrict access to roads beyond that delegated to them by the state, but that is exactly what they did here. The Commissioners also created a criminal penalty for a violation of a state civil law, which is an action only the legislature can take," said David Broiles, a cooperating attorney and state board member of the ACLU of Texas. "In its zeal to shut down the protests, the county simply ignored the statutory restrictions on its authority and the relevant legal definitions in the Texas Transportation and Natural Resources Codes."

Lisa Graybill, Legal Director of the ACLU of Texas, added: "As recent U.S. Supreme Court decisions confirm, no governmental body — be it local, state, or federal — is entitled to simply ignore the limits on its own

authority. And when it does so in order to squelch a message it doesn't agree with, as the county did in this case, it violates the most fundamental promise of the First Amendment."

McLennan County Commissioners passed the two ordinances last September, prohibiting parking within four miles of President Bush's property and restricted the erection of portable restrooms and camping activities alongside the county roads.

The county has taken the position that the ordinances do not restrict free speech and the local Sheriff's office has made 26 arrests related to the ordinances, some in November 2005 and some in April 2006.

# Burned-Out Adventurer Takes Own Life

Dazed, depressed, and at the end of his rope, Samuel W. Jordan wandered the streets of New Orleans on June 22, 1841, looking for a place to die.

Like many volunteers who arrived too late to fight for Lone Star independence, Jordan found life in the peacetime military too tame for his tastes. Resigning his commission as a captain in the Texas Army, he took part in the Rio Grande campaign which gave birth to the short-lived republic of the same name.

Federalist leader Antonio Canales appealed to Texans in 1839 to join the struggle to liberate the northern provinces of Mexico from the dictatorial rule of the centralists, the same enemy they had defeated three years earlier at San Jacinto. To sweeten the deal, Canales offered the Anglo-Americans a fair share of the spoils, \$25 a month and a half league of land.

A hundred and twenty-eight Texans under the command of Samuel Jordan and Reuben Ross answered the call. They crossed the border north of Reynosa, linked up with 400 federalists and on Oct. 3, 1839, routed the overconfident centralists at the Battle of Alcantro.

Eager to sever the compromising connection with his foreign friends, Canales furloughed the Texans, who went home in a huff. He created the Republic of the Rio Grande in January 1840 only to be driven into exile two months later by a centralist counterattack.

With the exception of Reuben Ross, who had died in a December duel, the Texas troops rallied around the charismatic Canales. Three hundred Mexicans, 80 Indians, and 140 Anglos led by Jordan mustered at San Patricio in June. In a matter of weeks, the Republic force numbered nearly 1,900 men.

Mariano Arista, the centralist general that had crushed Canales in March, slipped across the Rio Grande in late August with 1,100 seasoned soldiers and four artillery pieces. Worried about his unprotected rear, he doubled back to Matamoros to await the federalist advance.

Meanwhile, Canales sent Jordan and 90 Texans on a risky reconnaissance behind enemy lines. Soon after entering Mexican territory, Jordan received revised orders directing him deep into the dangerous interior. The mysterious way Juan N. Molano materialized with the change of plans aroused the suspicion of the rank and file but not the trusting commander.

At Molano's urging and over the strong objections of his men, Jordan proceeded to Ciudad Victoria 200 miles south of Matamoros. Soon after reaching their destination came word that Gen. Arista was closing in for the kill. But before the deadly trap could be sprung, the Texans departed for Saltillo 180 miles to the northwest.

During the long march, Molano clandestinely corresponded with their pursuer. The secret exchange ended with the snake in the grass accepting Arista's surrender terms, which included betrayal of the Texans.

Four miles from Saltillo, the federalists were met by a superior centralist contingent. The traitor Molano rode forward with a white flag ostensibly for a truce talk and vanished from sight.

Moments later a federalist colonel switched sides shouting, "Viva the supreme government! Death to the Texans!" At that prearranged signal, the bulk of the Mexican troops abandoned their Anglo allies.

The Texans dismounted and took cover behind a stone wall. Repeated attempts to storm their defenses were repelled by small-arms and rifle fire. By dusk, however, they were running out of ammunition and precious time.

This Week In Texas History

With a blood-curdling yell, the Texans charged the centralists on foot and broke through their lines. Before the frightened foes could regroup, they jumped on their waiting horses and galloped away.

The Texans fought their way to the border losing only four comrades on the remarkable cross-country escape. The Republic of the Rio Grande quickly collapsed, and Antonio Canales followed the example of his unscrupulous subordinates by making peace with the victorious central government.

Sam Jordan must have lost his mind in the angry aftermath of the misadventure. In a bizarre incident on Dec. 10, 1840, he took a swing at Sam Houston with an ax handle, but a bystander blocked the potentially lethal blow.

Jordan spent the next six months in New Orleans preparing for a private invasion of Yucatan. When the ship sailed without him in June 1841, he sank into a suicidal depression

At a corner pharmacy, he bought a bottle of laudanum, a common but potent pain-killer of the day that was 10 percent opium in an alcohol-water solution. Returning to his dingy rented room, he gulped down the deadly mixture, closed his eyes, and drifted into oblivion.

## New York Times Stands Firm Against GOP Attacks

NEW YORK CITY — The New York Times stood firm last week against attacks to its patriotism from the White House and other GOP operatives for revealing the U.S. government's surveillance of global banking transactions.

The Times editorial titled "Patriotism and the Press" said its report had not endangered national security by aiding terrorists since people who threat the United States would already suspect such programs. Regardless, the source of the story was a 2002 U.N. report made available to the public.

The editorial was a response to accusations leveled by President George W. Bush as well as the GOP chairman of the House Committee on Homeland Security Peter King, the later of whom called for the Times to be prosecuted under the Espionage Act.

The newspaper added that the Bush White House is following a pattern developed since Sept. 11, 2001 of working around governmental checks to his office powers by claiming security concerns.

"It has created powerful new tools of surveillance and refused, almost as a matter of principle, to use normal procedures that would acknowledge that either Congress or the courts have an oversight role," the editorial said.

It was 230 years ago this date, adopted by Congress on July 4, 1776, a singular document notating the birth of what was to become the

was to become the greatest Nation this orb would ever host.

The Unanimous Declaration of the Thirteen United

States of America *The Declaration of* 

Independence
One hell of a docu-

ment.
"We hold these

truths to be self-evident, that all men are

created equal, that they are endowed by their Creator with certain inalienable rights, that among these are life, liberty, and the pursuit of happiness."

Right there, in the very opening sentence, our Nation's founders decided this would be a haven where the individual could live free, go about daily business unencumbered within common law, and not be bothered by governmental dictates as to style of life and personal choices.

"That to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed."

Governments deriving their powers from the governed, hmmm. I suppose Inquisitor General Alberto Gonzales would call that notion "quaint." Could somebody please tell me one instance when King George XLIII actually performed an official duty on the good faith bidding of the American people?

# **High Court Paves Way For More Frequent Redistricting Maps**

WASHINGTON — The U.S. Supreme Court paved the way for more frequent congressional redistricting in a 7-2 decision last Wednesday. The ruling ends assumptions of Texas Democrats who argued that such redistricting attempts be made once a decade by state lawmakers.

Though the U.S. Constitution states that congressional district lines should change every 10 years to meet population shifts, the nation's highest court allowed the line changes at the whim of any state political party that holds the most power.

It remains to be seen whether the majority parties in other states would act on the high court's decision. In any case, state legislatures around the country could hear the uproar of their minority parties as it was with the Texas Democrats in both state Houses who fled the state to block passage of redistricting legislation benefitting the GOP in 2003. That year,

Texas Gov. Rick Perry called three special sessions to vote on the maps.

Another high court ruling Wednesday upheld all but District 23 of the 2003 Texas congressional redistricting map forged by former House Majority Leader Tom DeLay to solidify Republican control of Congress. The redrawn 23rd Congressional District failed to protect the voting rights of some 100,000 Latinos in south and west Texas, according to the 5-4 ruling.

A federal panel will hear oral arguments to change this vast district on Aug. 3 in Austin. On July 14, the proposed maps are due in court. These lines might swing votes in favor for El Pasoan Rick BolaZos, 56, a Democrat challenger to Republican incumbent Henry Bonilla for representation of District 23. However, the high court's decision left no timetable for the lower courts or the state to redrawn the district boundaries.

Many climate scientists insist that the two land masses that weigh in the most on global climate and weather patterns are Greenland and Antarctica. The Greenland Ice Shelf is two miles thick, and so broad that it could cover the entirety of Mexico and have a Texas-sized serving of cold cubes on spare tap. Should the ice here disappear, claims Glaciologist Jay Zwally, worldwide sea level would rise by 21 feet, drastically alter ocean currents causing droughts and freezes in places unexpected, and fuel the ever-increasing strength of hurricanes and tornados.

On June 25, the L.A. TIMES reported the Greenland Ice Shelf is melting twice as fast as it was five years ago. Thinking this headline sounded a bit cryptic, I hunkered down for a long, complicated read. Turns out researchers have found the glacier ice to be something of a record of Earth's ever-changing climate. Here, they discovered particles of snow that fell over a quarter of a million years ago, perfectly preserved. They analyzed carbon samples by drilling deep within the ice, which led them to conclude there have been 20 abrupt changes in global climate over the last 110,000 years. Temperature averages varied nearly 15 degrees in a single decade, at one point. Obviously, that could not have been due to human activity.

Then, in March of this year, Zwally and his team found that the ice sheet had actually *grown* very slightly between 1992 and 2002. But the good news did not last for long. By 2005, the scientists had documented losses of 52 cubic miles of ice per year. The amount of fresh water being dumped into the ocean had tripled since 1995. They found

the average winter temperature in Greenland had risen 10 degrees since 1991, causing strange melting incidents as late in the year as December. Then the bottom fell out; almost literally.

Zwally's team documented the shelf's three largest glaciers' speed of withdraw. According to their report, the Kangerlussaq and Jakobshavn Glaciers have doubled their pace since 2002. The Helheim Glacier pulls back half a football field every day. Twelve major glacial outlets drain the ice shelf of melted water that endangers the structure as a whole, in the same way rivers drain watersheds. If the glaciers continue to pull back this quickly, in a decade – two at most – the entire ice sheet will "suddenly collapse" into the ocean. Greenland will go back to being three large islands, and Waco, Texas will be beachfront prop-

Sure, several of the top 10 "hottest years" on record have taken place within the last five, but what does this mean? Yes, the air quality in Dallas gets so bad on some days even I dare not venture out into the soup. And it is indeed true that America and her corporations are the top polluters in the world. But does this really affect world climate?

Weighed on my scales of logic,

Stephen Hawking and the National Academy of Science are a ton and a half heavier than a "researcher" on Exxon-Mobil's payroll. I believe it was Upton Sinclair who wrote, "It is difficult to get a man to understand something when his salary depends upon him not understanding"

So, what can be done about this? It is actually pretty simple on a personal level. Until alternative, carbon-neutral fuels are available to a mass market, try to carpool to work. A good resource is eRideShare.com. Get your car tested for emissions and consider buying a catalytic muffler to help control your carbon output. Think about switching electric providers to a green alternative. In Texas, such a provider is available: Green Mountain Energy. It is the same price as TXU, and they operate on green energy credits from wind farms and hydroelectric plants. Buy some energy-saver light bulbs: not only will it put some extra dollars in your account come bill time, but they last over five years so you don't have to buy new ones as frequently.

Also, keep your air-vent filters clean and changed, as your air conditioner has to work extra hard when there is a mass of dirt and grime blocking its passage. You'll breathe a little better, too. Keep your thermostat at least four degrees higher in the summer and four degrees lower in the winter. Insulate your home and make sure your windows are calked. Plant a tree in your yard. Buy fresh food instead of frozen goods, and shop it at your local farmer's market instead of Wal-Mart. Try to use clotheslines instead of dryers. And unplug that power strip when you're not using it.

These are very simple steps you can take as just one person to help reduce your impact on Global Warming. It is not too late to help turn the tide back to our favor, and it does not necessarily require the type of "political will" Mr. Al Gore calls for (though some would be helpful). All that is being asked of you is a slight pause for additional thought. This is not "environmental extremism," it is simple logic that can help us all look forward to a more stable future. Change is within our grasp, and living in fear of the Great Greenland Shelf Collapse does not have to be our predetermined next decade. You can do it, and we can all help. It is easy.

# Angry? Don't Beat Yourself Up Over It

Hello and welcome to another edition of our special in-depth medical feature *Health Yak*, which has been recognized by the U.S. Surgeon General as "extremely topical," meaning that you should not attempt to ingest any portion of this column without first consulting your doctor.

Today we will be discussing a study that suggests as many as 16 million Americans — or roughly the number of people who never receive their appetizers during an average season of Hell's Kitchen — suffer from periodic outbursts of anger.

## Betsy Ross Would Be So Proud

You can always tell when the President's popularity is getting dangerously low or when an election is coming up. That's when those in power — and those who would like to be in power — shamelessly start pandering to the American public. That's when they try to imply that they're more patriotic than the other guys. So, they trot out issues like sex and violence on TV, illegal immigration, and Énglish as America's official language. This is the third cut that Texas Seniors have had in a month ouch!

Last week, the state said it would cut the amount of money it pays hospitals to treat Medicaid patients by eight percent.

The month before it announced the new Call Centers that would require the elderly

and handicapped to call a phone number in a telephone boiler room to get food stamps, a provider, and other help. The state had fired 2,300 experienced case workers that used to do these services in person. It was when news hit the fan that in a pilot program here in Texas that the company in charge of the call centers was providing terrible service, with old folks waiting 20-30 minutes on the phone then getting their call disconnected, and files gettting lost. The state rehired some laid off case workers and put off the call centers for now anyway.

Now the state has a SUR-PRISE for the elderly of Bexar, Comal, and surrounding counties.

Elderly and handicapped people that get Medicaid could be placed from Medicaid into an HMO for their health care. The names of the HMO's look to be Community First, Molina, and Superior. Our senior adults look to loose their freedom of choice in doctor selection and end up using the doctors and facilities that the HMO decides that they should use. Though it is rumor, it has been said they may be forced into the HMO's by the state to save money.

Who will help the sicest, and people with language problems?

Now that 2,300 experienced state Case workers have been fired, and community resources are cut back, and disappearing, we wonder just who will be there to help Senior Adults that may have dementia, or unable to follow complex instructions. We question who might be there for the senior citizen who is unable to hold 20 minutes on the phone to get needed health care, or worse, what if no phone is in the home. 

# **Unspoken Injustice**

On June 11, longtime WASHINGTON POST Writers Group columnist Neal Peirce keyed an article titled "Violent Sex Crimes: Free the Children." The subject of this article is none other than Christopher Largen, cofounder of Building BLOCK and a key interview subject in LSI's series. Since Peirce is syndicated through The Post, dozens of national newspapers have played host to this outspoken advocate's cause, and to great effect.

"Now a recovered and spirited man in his mid-30s,' wrote Peirce, "Largen is crusading for toughened police, prosecutor and judicial action to arrest, sentence and hold child molesters. And not for vengeance, but because 'American children are being molested, raped, tortured, even murdered.'

LSI contacted Peirce as soon as his contribution to Building BLOCK became public. Within mere hours he had responded, and thanked LSI for initiating media coverage of the group. "[This is] an amazing story," he wrote. "[Of] how very widespread the phenomenon of sexual abuse is in the United States, how many haphazard police departments and prosecutors are in apprehending and holding dangerous offenders." Included in LSI's correspondence with Peirce were several emails he received in response to his col-

One respondent, identifying himself as a member of Bikers Against Child Abuse, wrote, "Despite what our name says, we are not big burly bikers out to stamp out child abusers – although at times we might like to. We are essentially a support group for victims of child abuse who need our support and sometimes defense against the perpetrators who would intimidate them and bully them into recanting or changing their stories. The 'system' as it is set up does nothing to help these victims, especially in the early stages when the perps are still innocent until proven

guilty." He goes on to plug the group's website www.BACAUSA.com.

Another letter Peirce received expresses concern about predators in the home - not just the

prowler next door. "[O]ne crucial factor you failed to mention is that many – perhaps more than half – of the children who are molested are victims of someone in their own family of a close frienď. ... I know at least three women who told me they were raped by their fathers when they were in their early teens.

None ever pressed charges."

This writer drew a response from Largen, the man at the epicenter of this sudden media spotlight. "This is a very good point," he replied. "Out of my seven assailants, one was in my family, four were acquaintances of my family, and two were strangers. While it is true that stranger assaults are more likely to be of a fixated/ predatorial nature (and more likely to result in a kidnapping and/or murder), family members and acquaintances of family members can also be fixated and predatory. For example, there have been men who have married women simply to gain access to their young children. Nauseating, but true.

Largen's solution: "We need to teach children to be their own first responders, which means they must be given access to information about their bodies and their rights. Contrast the proliferation of DARE programs, while our public school districts often lack an equivalent program to teach kids what sexual abuse is, how to reduce danger, and what to do if anyone hurts them. Children absolutely need to know that someone will be an advocate for them if they speak out. This concept is a bone of contention for some people, because they mistrust the idea of

state officials teaching their children about sex. They want sex to be a private issue for the family, but the reality is, many parents aren't arming their own kids with vital information. We also need better educated parents who know how to talk to their kids about sex, how to spot warning signs, and just as important, how to develop empathetic and

open lines of communication with their children.'

"We argue over issues and vilify people in the press, wrote another réspondent. "What if we instead looked through the lens of development and started to access ethical, psychological, social and cogni-

tive development? When our elected officials think the world is black and white, clearly they are cognitively underdeveloped. When they think it is all about them and power, we are often looking at power addicts. When they lie, cheat and steal, what sort of  $ethical \, development \, have \, they \,$ accomplished? And where are our discernment skills when we elect them? ...I am committed to empowering children with the skills they need to look inside and protect, heal and develop themselves. It's the Pogo thing - the enemy is us; our lack of development individually and collectively."

From the deluge of responses Peirce received after picking up this chalice from Building BLOCK and LSI, he has drawn several conclusions. "[T]he American public wants (1) to see that this issue is addressed because of the immense lifelong peril to children, (2) recognition of how hard it is to prosecute many cases, and (3) both determined and fair prosecution of offenders.

We at The Lone Star Iconoclast could not agree more. and offer our thanks to Neal Peirce of The Washington Post Writers Group for speaking out on this, a formerly Unspoken Injustice.
