

Sheehan To Return To Crawford This August

CAMP CASEY II — After several months of touring the United States and Europe, peace activist Cindy Sheehan is scheduled to return to the Crawford area this August to rekindle her vigil here the year prior.

The length of Sheehan's stay at Camp Casey II, the site of her month-long encampment to confront President Bush on the occupation of Iraq, is still up in the air, but organizers plan to set up two weeks worth of workshops for budding activists there from Aug. 16 to Sept. 2

Two weeks ago Sheehan and four other activists sued McLennan County in state district court over an ordinance banning camping and parking near President Bush's ranch. The suit calls for the ordinance to be repealed.

County officials at the time of the ordinance's passing last year said that the law was needed for the safety of residents and protestors along the 14 narrow roads that weave around the countryside a few miles from Crawford. From July 4 to the start of her return to Crawford, Sheehan will participate in a "rolling fast" in order to raise awareness of the current U.S. occupation in Iraq. With her "Troops Home Fast? protest are an assortment of celebrities, entertainers, and political figures, such as Susan Sarandon, Sean Penn, Danny Glover, Willie Nelson, and the Rev. Al Sharpton.

It is estimated that over 3,000 from across the United States and 18 countries have joined the fast.




WASHINGTON - The Central Intelligence Agency unit charged with finding Osama bin Laden and his network was disbanded late last year after a decade of pursuit. Instead, the agency has chosen to redirect its efforts to combat foreign terrorists through different means.

Intelligence officials last Monday confirmed the closure of the "Alec Station" unit and the reassignment of its analysts inside the CIA. The unit's demise was first reported on National Public Radio.

The change shows a reprioritization within the agency, that bin Laden and Al Qaeda are not seen as a threat to the United States, according to Michael Scheuer, a former senior C.I.A. official who commanded the unit long before the bin Laden became wellknown to everyday Americans

Still, agency officials insist that the pursuit of bin Laden remains a large focus, though the tactics have changed. Officials now feel that their efforts are best trained on regional happenings, not single groups or individuals.



100 March Against British Petroleum In Texas City

TEXAS CITY — About 100 people concerned about the health and safety of oil refinery workers as well as the pocket books of millions of working families marched in protest of BP PLC in Texas City last Tues-

The Rev. Jesse Jackson was at the head of the march calling for an end to oil price, worker, and consumer exploitation at the site of one of the Texas' worst refinery accidents. Last year an explosion at the BP refinery there left 15 workers dead and over 170 injured.

ent. In a related story, an The black leaders involved in ExxonMobil chemical plant suffered an explosion that harmed none of the 23 workers there last week. The investigation into the blast and fire might take weeks, a spokesperson for the company told The Baytown Sun.

The explosion shook nearby houses, but no hydrocarbons were released outside the plant's borders, and all the fires were extinguished within 45 minutes, said the spokesperson.

Letters written in English and Spanish from the plant manager were distributed by hand throughout the neighborhood apologizing for the incident.

Interview With Becky Garrison, Religion Writer

NEW YORK CITY — You can make a solid, be it biblical, argument that God likes laughter.

In the Old Testament, an angel of God stopped Abraham from sacrificing his own son, Isaac, whose very name in the Hebrew language loosely trans-lated means "laughter." Case closed, right?

Not quite.

Fast forward to the New Testament when the world is introduced to God's Son Jesus Christ – a real fun guy who was always partying with whores, lepers, and non-Jews (read: non-humans).

Let me tell you, I have yet to come across a single frat boy who could turn water into wine AND still be sober enough to include the nerds in the shin-dig.


Strange as it all may be two thousand years later, followers of Christ still can't seem to get along to even get along — though most of them agree that God pulled one over on Satan by resurrecting His Boy from the

Well, that's where Becky Garrison enters the story.

Granted, this former debutante from North Carolina is not a character found in the Bible. but her work can be traced to the Dallas-based Wittenberg Door — the world's pretty much only religious satire magazine. Over the last 12 years there, she has risen to the position of senior contributing editor, interviewing such figures as Dick Morris, William F. Buckley, Jr., Molly Ivins, and Jim Wallis.

This past April, Garrison came out swinging against not only the Religious Right but also the Spiritual Left in her book Red and Blue God, Black and Blue Church: Eyewitness Accounts of How American Churches are Hijacking Jesus, Bagging the Beatitudes, and Worshipping the Almighty Dollar (Jossey-Bass, 2006).

"We're all struggling with the question, "What does it mean to be Christians in the 21st century? I think that's the right question to be asking. I'm not saying I have all the answers. I'm not saying we do everything correctly, but I think that's the question we need to be asking,' she explained. "Don't let other people define what a Christian is. What do we say being a Christian is? How do we go back to

I'm going after someone like Benny Hinn who is actually harming people. It's a very fine line. It's an occupational hazard.

ICONOCLAST: But nothing is sacred on earth, right? There's nothing here in the material world that can lead to our eternal salvation — humor included. So you might as well go for it, right?

GARRISON: You also have to bear in mind the fact why someone is believing what they are believing. The average person in the pew, they might, for example, believe in Benny Hinn because of a list of psychological reasons. I don't want to make fun of someone's psyche and put them in a very damaged

On the other hand, it's the people that prey on those people whom I'm going to go after. The actual person being preyed

upon, my heart goes out to those people. To be in a situation in which you really believe that Pat Robertson, Benny Hinn, and all these other charlatans are going to be your savior versus the teachings of Jesus Christ, you've got yourself in that situation I feel for you. I really feel for them. But as I said, it's the people who are preying on them that I'm going

ICONOCLAST: In that case, was writing your book easy or difficult for you? Were there any challenges?

GARRISON: The challenge was that my publisher gave me three and a half months to write it. That was the first challenge. Basically, you had to clear your whole slate. That would be a challenge for any author to turn out a book that was required to be this researched in three and a half months.

Secondly, I had to be really careful and praying that I was not going after what I considered to be the good guys, the people I thought who were following Christ like me. We're going to screw up because we're human. It's the nature of the beast, but are they on the right path? Are they trying to do the right thing? Or are they fol-lowing some other god? None of us are exempt from the little wormwood pecking at us, trying to convince us to go the other direction. It's when someone is iust choosing to really go off the path that I'm going to be liable to slam them.

It's also making sure that you don't do what I would call an ad hominem attack. Are you criticizing Bush for what he did that was really worthy of attack? A lot of these little slams I see which are sometimes attacking him for stuff that he's not even responsible for. It's making sure that you get your facts right and research and make sure that when you're slamming someone, you're doing it justified.

It's also researching and finding people that can shine the light on the Gospel. I mean, nobody wants to read a book that's all full of nastiness and doesn't give them any hope in the end.

ICONOCLAST: So that was the last challenge — giving people hope?

GARRISON: It's a big challenge. A lot of people feel disillusioned, and they read a

me this. They'll read an article about how rotten the Religious Right is and they just fall into a state of despair. I don't feel that's a good way to end a book. There is hope here. I have found pockets of hope. Let's try to move towards those pockets of hope. You can wallow in a lot of despair until you just want to become depressed, but that's not a healthy way to move forward.

You can see this back in Jesus' time. I mean, Caesar was no picnic back then, and yet Jesus chose with his disciples to not fall in a state of despair. How do you keep from falling into a state of despair when everything around you looks like it does today?

ICONOCLAST: Throw a party. (laughs)

GARRISON: Yeah, you go throw a party and wake up with a hangover. That might help you temporarily, and if you do that too many times, you're going to find yourself in AA.

ICONOCLAST: Well, the premise of your book is that both the Right and the Left have hijacked Christianity for their own political purposes. You remind all parties to follow the Greatest Commandment and communicate their differences with love, not hate. Why you? Why did you feel you had to write this book?

GARRISON: Because nobody else was writing it. I mean, every other book I was reading was "nasty Bush," and yet they weren't looking at the speck in their own eyes. As I was looking at the speck in my own eye when I wanted to criticize Bush, I realized that I needed to do

Also, there was nothing funny. Nobody was writing from a satirical standpoint. You did have the Al Frankens and so forth, but that wasn't poking fun at the Right. Nobody who was a Christian was actually going out and saying, "Bush is my brother in Christ, and I have to love him even though he drives me nuts." Someone had to say it, and nobody was.

ICONOCLAST: What has been the response so far to you book?

GARRISON: Generally, very, very favorable. I've got some conservatives that have liked what I've said, which has surprised me greatly.

I'm starting to get — and as the book continues to get out there — people on the ex-

number of books. They've told tremes, especially on the issues of homosexuality and abortion. The moment you do not side with what they believe hook, lock, stock, and barrel, they let you have it. These are what I like to call the Ann Coulter fans. They will rip into you, and there is one of those on the Amazon.com site book review. You have to look at that and take it for what it is.

Some people have said I was too even-handed in my approach. Other people have said I slammed Bush and didn't slam the Democrats. Certain people had certain issues that they said I wish you would have talked more about homosexuality. My response is Jesus didn't talk about it, so I'm not going to.

But overall, if you actually read the book from cover to cover, you will see that I'm trying to suggest that we act like Christians and debate this issue in brotherly love. That message is starting to resonate with a number of people.

I gather that it's selling. My publisher is happy. It's a slow buzz for a first-time author. The buzz is going to continue. There's going to be more press. What made me feel very excited is that I found out that a church in Georgia has been using it as a Bible study. One of the biggest promoters of my book is my improv teacher who just happens to be an atheist. It's one of those things that when you give birth to the baby, you just sit prayer of God. back and watch and see what happens.

Ŷou know, there's a whole plethora of books coming out. I'm one of the few authors whose written a book that is bipartisan, that tries to show a different way. I think that once people finish the whole plethora of books like "I hate the Religious Right. The Religious Right sucks. The Religious Right can go bite me," I'd like to think that at the end of the day, they're going to say, "what do we do next?" And I'm one of the ones starting to offer that. I hope I'm getting other authors to think about at the end of this how to give hope.

We do have conservative and liberal Christians who do not see eye to eye on a lot of social issues. They do not worship the same way... but yet we are brothers and sisters in Christ, and whatever we can do to try to get that dialogue started so much are starting pretty nasty Bush the better. That's the dialogue attacks, and you're going to see that needs to be happening. We a lot of these Religious Right need to turn down the white people responding in kind. IČONOCLAST: So what are your predictions for the coming election years? This next presidential election is going to be the first in 50 years in which no vice president is running for the presidency.

It's a struggle because he annoys the heck out of me, too, sometimes with some of the stuff he does, but then again, when I get an e-mail from a progressive telling me that "Bush bites," I'm like, is that any different?

You can't have a values-less party. The question is, how can the church in this whole debate

voice without being subject to the winds of the political parties? Martin Luther King managed to do this, and I noticed that other people are not able to do that quite as well. I just see too much Bush-bashing going on from the churches that it's really starting to concern me.

Do we respond hate for hate, or do we do as Martin Luther King, Jr. suggested, respond hatred with love? How to respond when someone attacks you in this nature? That seems to be a question that a lot of people were struggling with.

I think a lot of these conspiracy theories are just Oliver Stone smoking something. I just don't get it. There's no evidence that there was a missile and other kind of hooey. I think it's a waste of oxygen and ink to even give these guys the time of day, unless they want to present some concrete evidence about what they are actually talking about.

This is like, I have known some conspiracy nut people in my life, and I find conspiracy theorist people in general to be very sad, lonely, confused, and at times somewhat deranged people that have no friends.

Outsourcing Of Public Services Is Not Working

The state's attempt to change the way Texans in need get health care, food, and temporary cash assistance has been a disaster.

Last June, the state outsourced the enrollment process. As a result, over the last six months, more than 100,000 kids have lost their health insurance. And as of May 9, nearly 7,000 Food Stamp applications were backlogged, leaving thousands of families without food.

Lured by the private sector's promise of saving money, the state signed a five-year, \$899 million contract with a private company, prepared to lay off

2,000 state employees, and launched the new system in Travis and Hays counties.

It all sounded so good. Clients would benefit from state-of-theart technology and no wait times at overcrowded offices, and taxpayers save hundreds of millions of dollars

Unfortunately, this was not

The problems began almost as soon as the contractor took over. Technical difficulties and staff problems arose, and the promised savings never materialized.

Last month, the state postponed extending the new system to more counties and asked 1,000 state workers to stay on the job.

The outsourcing model was flawed from the start. It promised savings not from more effective or efficient ways to help clients, but by replacing trained state employees with fewer, lower-paid, and lessskilled staff.

Admittedly, the old way of doing things had its own problems. For years, state offices have been understaffed and run with outdated technology. But things have gotten worse with the new system.

The rush to outsource misses the point. No matter who runs the enrollment process or how it is structured, the only way to ensure that vulnerable Texans aren't slipping through the cracks is to hire sufficient staff to run the pro-

For years Texas has skimped on an adequate workforce to enroll people in services. Despite growing numbers of Texans in need, the state actually cut eligibility staff by 40 percent between 1997 and 2004. This almost doubled staff workload and compromised client ser-

Mexican Presidential Candidate Asks For Vote Review

MEXICO CITY — The centerleft candidate for the Mexican presidency said he would challenge the results of the presidential election late last week after his conservative opponent was declared with winner by a razorthin margin.

Andrés Manuel López Obrador of the Party of the Democratic Revolution (PRD) lost the election by a half of one percentage point to Felipe Calderón of the National Action Party (PAN), 35.88 percent to 35.31 percent.

These results were accounted for by a recount of the ballot re-

turns from Wednesday to Thursday. The recount process itself was administered by Mexican citizens, independent election officials, and political delegates.


López Obrador can present his appeal to the Federal Elections Court, an option provided for by Mexican electoral law. Then the court has until Aug. 31 to rule. In that time, a ballot-by-ballot recount could be called by the federal tribunal.

López Obrador, who had declared himself the winner, though not all the ballots were tallied, is claiming that "a fraud" was made in the electoral process. Election officials and European observers have noted that Mexico has exemplary voting practices and have questioned why Obrador would lose faith so quickly.

About 42 million of the 70 million Mexicans registered to vote did cast their ballot in this year's election on Sunday, July 2. The total population of the country is 103 million.

The final winner of the election will have a tough job of governing the Mexican Congress since there is no majority party in which to take the lead on directing legislation.

Visitor Safety, Resources, Services Now 'Seriously Compromised' As Result Of Cuts

37-Park Review by Coalition of National Park Service Retirees (CNPSR) Finds Nearly All Parks Suffer From Reduced Law Enforcement, Emergency Response Personnel; No Longer Able to 'Hide' Service and Maintenance Woes From Public

ing a national park this summer? If so, you should expect reduced law enforcement protection, longer emergency response times, fewer lifeguards, scaled back water and trail safety patrols, dirtier campgrounds and other visibly deteriorating facilities resources, according to a major new report based on a 37-park review by the Coalition of National Park Service Retirees (CNPSR), an organization of more than 515 former NPS employees with an accumulated 15,000 years of national park experience.

Entitled "Reality Check: What Visitors to America's National Parks Will Experience During Summer 2006," the CNPSR report concludes: "Despite 'happy talk' assurances from political appointees at the Department of the Interior and National Park Service, all is not well this summer in America's national parks. A Coalition of National Park Service Retirees analysis of the status of 37 national parks finds widespread evidence of major problems that will be evident this summer including decreased safety for visitors, longer emergency response times, endangerment of protected resources, and dirtier and less well-maintained parks - and that the problems will only grow worse in the coming years.

Bill Wade, the former superintendent of Shenandoah National Park and chair of the Coalition's Executive Council. said: "The budget crisis in our parks is real and it will be felt keenly by park visitors this summer. Nearly all surveyed parks will have fewer law enforcement rangers on the job this summer to protect park visitors and park not to be alarmist, but to ensure that American citizens and lawmakers know the facts: Forget about cutting the flesh or any 'fat.' We are now cutting deeply into the sinews and bones of our national parks. Congressional budget increases of recent vears have been welcome, but these modest hikes have only succeeded in bringing some parks out of the depths of the financial abyss — and back to its brink. The sad fact is that these budget add-ons are the proverbial drop in the bucket of at least

ing deficits and an enormous maintenance backlog of up to \$7

Bill Supernaugh, the former Superintendent of Badlands National Park and a member of the CNPSR Executive Council, said: "It is important to understand that there is more to the problems this summer in national parks than a higher level of risk posed to visitors and resources.

Effectively, there is no meaningful preventative maintenance program today in the NPS because very few parks now have the resources to carry out such a program. Unfortunately, today's preventative mainte-nance deferral turns into tomorrow's increase in the already multi-billion-dollar NPS maintenance backlog. Reduced seasonal employee hiring contributes directly to increased maintenance backlogs, increased resource crimes, and the increased prevalence of the already shameful number of shabby and ill-kept national park sites and facilities.

OTHER KEY FINDINGS

In addition to the findings about extensive law enforcement and other emergency response personnel cuts, the CNPSR report also found:

* Visitors to parks this summer will see evidence of deteriorating park operations resulting from reduced preventative maintenance, in terms of scheduled custodial checks, roadside litter pickup, and grounds and buildings maintenance.

Widespread cuts are putting national parks in an almost purely "reactive" posture, falling far short of the law and Congressional intent to protect the resources for future genera-

Whose Bottom Line Is It Anyway? Wading Into Texas' Biennial Budget

More than 30 years ago a U.S. senator asked how much the president knew and

when he knew it. The senator knew there was a bottomline answer, whether he got it or not. It was, after all, a simple question. Ask a simi-

larly simple question about the budget of Texas (or that of just about any government for that matter) and you are no more likely to get a simple, bottom-line answer than did that senator

With relative ease and simplicity any taxpayer should be able to find the answers to some pretty basic questions regarding what government is doing with his or her money. How much money has been, or will be, spent? What has or will it be spent on? Who is spending it? What is it accomplishing?

The current Texas state budget runs almost 900 pages and just a quarter inch shy of two inches thick. It documents the almost \$140 billion appropriated for fiscal years 2006 and 2007, of state, federal and some local (from school districts) funds.

Much of the volume of the state budget is made up of "riders," special, detailed instructions the legislature gives to the 188 separate agencies, including universities, to which these funds are distributed.

Additionally, the budget contains lists of "outcomes" and "efficiencies" – measures supposedly there to answer at least a couple of the questions mentioned above. Whether accidentally or on purpose, though, these measures do not really tell us very much.

For example, under the Texas Commission on Environmental Quality, there is an "outcome/impact" measure for the "Percent of Identified Noncompliant Sites and Facilities for Which Appropriate Action Is Taken." This measure, a goal really, is set at 85 percent. Why is it not 100 percent? Or how about the "Percent of Inspected or Investigated Air Sites in Compliance," with a goal of 98 percent. While it is an admirable goal to have all

air sites in compliance, could not this measure create a perverse incentive to inspect and investigate sites in compliance and ignore violators?

In the budget, no history or context is given to any of the outcome and efficiency measures. Central missions and goals go unstated. Ultimate

results seem, well, ultimately unimportant. This is true for all state agencies. It is only with rare exception that one can trace any specific program's expenditures back even five years (though never in the budget and only with a great deal of sleuthing), much less gauge its successes or failures.

There is more information available in agencies' Legislative Appropriations Requests, but few of these are available online. What's more, the history these documents do give leaves a gap in every agency's actual spending history because of the way these standardized documents are arranged.

Studying the state's budget and trying to get answers to basic questions is a little like a physicist studying the big bang. One answer seems only to lead to a half dozen more ques-

But the Texas state budget is not the cos-

Currently, individual programs are almost impossible to identify in the state budget. That must be changed, making it more accessible and useful. Additionally, generally accessible documents clearly detailing the strategic plans for each program should be produced, including sound measures for defining success at the end of each year and over the course of the program.

Taxpayers need to know what is really being accomplished with their money. If such answers cannot be had, then that taxpayers' money should stay with the taxpayers.

Foster Children Death Rate Up 60% In Texas, Says Strayhorn

AUSTIN - Texas Comptroller Carole Keeton Strayhorn has released information found during her investigation into possible Medicaid prescription drug fraud and abuse about the deaths, poisonings, rapes and pregnancies of children in the state's foster care system that shows a significant death rate increase for foster children — 60 percent.

"In April 2004 I said I would give our forgotten children in foster care something they need - a voice," Strayhorn said. "I have been and I will continue to be their voice. This Governor's Health and Human Services Commission continues to stonewall my investigation and this Governor continues to hide the

"In October 2004, I urged Gov. Perry to immediately create a Family and Protective Services Crisis Management Team by executive order to finally take serious steps to save children's lives. Now it is June 2006. Gov. Perry's failure to act is unconscionable.

Strayhorn found, from information provided by the Texas Department of Family and Protective Services, in Fiscal 2003, 30 foster children died in Texas' care; in Fiscal 2004, 38 foster children died; and in Fiscal 2005, 48 foster children died.

Data shows that while the number of foster children in the state's care increased 24 percent from 26,133 in Fiscal 2003 to 32,474 in Fiscal 2005, the number of deaths increased 60

"If you compare the number of deaths of children in our state's population to the number of deaths in our state's foster care system, a child is four times more likely to die in our state's foster care system," Strayhorn said.

Based on Fiscal 2004 data provided by the Health and Human Services Commission, about 100 children received treatment for poisoning from medications; 63 foster children received medical treatment for rape that occurred while in the foster care system; and 142 children gave birth while in the state foster care system.

"When I called on Gov. Perry in October 2004, to create a Crisis Management Team I said the crisis was minute-by-minute and

child-by-child," Strayhorn said. In Fiscal 2004, four-year old twin boys living in the same foster home received medical treatment in the hospital for rape. A five-yearold boy in the same foster home received medical treatment in the hospital for rape two days later.

A 15-year old girl who was not pregnant when she entered the state's foster care system in May 2002 gave birth in Febru-

ary 2004.

"The state is supposed to be protecting than shildren, but in all too many cases these children are taken from one abusive situation and placed in another abusive situation," Strayhorn said. "Many children are in more abusive situations now than they were before the state intervened. Children are being neglected,

abused and are dving.'

As reported by the media, a 12-year-old boy died in December 2005, while in the state's care at a facility that treats children with learning disabilities and emotional problems. The boy suffocated while being restrained from behind by an employee of the facility. Another boy in the state's care at the same facility died May 30, after drowning in a creek during a May 6 bicycle outing.

A three-year old was treated for poisoning from an atypical, mind-altering antipsychotic drug. These drugs are not approved by the Food and Drug Administration for children under the age of 18 years old, noted

Strayhorn launched her investigation in November 2004, after her report, Forgotten Children, uncovered the fact that large numbers of psychotropic drugs are being prescribed to children in the foster care system, even though, according to the FDA, some of these drugs are not approved for children and have serious side effects such as suicidal tendencies, diabetes, and cardiac arrhythmia.

"Since that time, repeated and continuing roadblocks and stonewalling have been encountered by me and my staff in attempting to secure basic and necessary data from the Health and Human Services Commission,' Strayhorn said. "It has been 19 months and 25 letters, emails, meetings and phone calls since I first requested foster care and corresponding Medicaid data from HHSC. The Commission finally provided Fiscal 2004 data. But, 10 months into Fiscal 2006, we have yet to receive the Fiscal 2005 data, which we know has been available for months and months.

"In March 2006, I requested all of the same data for Fiscal 2005. Claiming confidentiality, the Commission to this day refuses to cooperate and provide the Fiscal 2005 data needed to complete my investigation, despite that the statute requires that they cooperate and the Court of Appeals ruled on June 16 that HHSC's view about the confidentiality of its records is clearly wrong.

"What I have found from the information that was made available should be and is of grave concern, but the picture painted by Gov. Perry's Health and Human Services Commission's secret 2005 data must paint an even grimmer picture on all fronts," Strayhorn said. "The people of Texas can handle the truth. What they will not tolerate is this Governor's callous indifference in hiding the truth and placing our forgotten children at high risk."

Child Poverty Rises 5 Percent Since 2000: Report

AUSTIN - A new national report on child poverty shows that the rate of children living in poverty in Texas increased by five percent since 2000.

Other factors contributing to children's health have decreased over the last six years, according to the KIDS COUNT Data Book, a report released by the Annie E. Casey Foundation.

The Data Book, whose full findings will be published this fall, also indicates that from 2000 to 2004, the percentage of children living in poverty in Texas increased from 22 percent to 23 percent. The national average of children living in poverty is 18 percent.

To be considered living in poverty in 2004, a family of three would have to make less than \$15,219 per year, according to the report. Children living in extreme poverty in Texas (50 percent of the poverty level) increased by 10 percent since 2000. Also since 2000, Texas has seen a nine percent increase in the number of children in low-income families (200 percent of the poverty level).

When in comes to the immunization of two-year-olds in Texas, only 75 percent of them in 2004 were given their shots, down from 78 percent the year prior. Only Nevada trailed Texas with 71 percent of their children immunized in 2004.

Texas ranked 22nd in the percentage of low-birthweight babies with an increase of seven percent from 2000 to 2003. Texas dropped from 9th to 22nd in its national ranking of its infant mortality rate. The rate jumped increased 16 percent from 2000 to 2003.



Perry promised to help Texas homeowners with high insurance costs; however, two years ago home insurance premiums doubled overnight due to lax legislation and officials looking the other way

When home insurance premiums doubled, the governor and [at that time] Texas Insurance Commissioner Jose Montemayor and current TDI Commission Mike Geeslin promised to force the insurance industry to reimburse homeowners at least 10 percent of the recent 100 percent jump in costs — has anyone gotten a check back from an insurance company — except maybe our special interest officials?

The governor traveled around Texas pushing legislation to eliminate "frivolous" medical malpractice lawsuits with the promise that doing so would lower medical and health care costs; however, after voters took him for his word and voted for the legislation costs are still

high and are continuing to rise Two years ago Perry cut important social services, including children's healthcare, to balance the state budget; one

Phony Millionaires Spend Themselves Into Poorhouse

A Gainesville jury tried to decide on June 30, 1967 whether **Ernest and Margaret Medders** were a couple of folksy con artists or bumbling bumpkins caught up in an incredible cha-

The strange saga began in 1961 in Memphis, Tennessee, where the impoverished parents struggled to support ten children. Ernest was a fourgrade dropout, who worked days as a mechanic's helper and peddled vegetables out of his station wagon on the weekends. Margaret, a practical nurse, pulled 16-hour shifts at a local hospital.

Then one day an attorney informed Ernest that he and his many kinfolks were among the 3,000 plaintiffs in a class-action lawsuit challenging a petroleum company for the rights to a Texas oilfield. At stake was an estimated \$500 million in royal-

In their ignorance and desperation, the wishful thinkers jumped to a preposterous conclusion. They convinced themselves the suit would succeed and that every last cent would go to Ernest.

The jubilant nurse naturally shared the wonderful news with co-workers. In no time flat, the Medderses' good fortune was the talk of the hospital, which happened to be run by a religious order called the Poor Sisters of St. Francis Seraph of the Perpetual Adoration.





The Sisters were, in fact, far from poor and always on the lookout for well-heeled benefactors. Viewing the Medderses as potential contributors, the order lent them money to cover household expenses and legal

When the generous loans started to exceed \$60,000 a month, Ernest and Margaret moved to North Texas. They purchased a 185-acre farm near the small community of Muenster and built a 15-room residence. The total tab for the new homestead was a whopping \$307,000.

Margaret enrolled her daughters in Hockaday, an exclusive girls' school in Dallas. To spare the little darlings the indignity of dormitory life and to improve their social standing, she presented them with a \$40,000 home away from home.

By 1965 Margaret was eager to rub elbows with the high-rollers of Big D society. She threw a party for a thousand people in their brand-new rodeo-size barn dubbed "the coliseum."

A slick public relations specialist hired for the occasion smooth-talked the Dallas media into covering what he billed as exaggeration

Guests within a hundred-mile radius came in buses, while others flew chartered airplanes to Gainesville and completed the trip by helicopter. Guy Lombardo and his band provided the musical entertainment for the truly memorable night.

The spectacular shindig opened a lot of doors for the ecstatic hosts, most notably the one leading to the pinnacle of power Following visits by Congressman Graham Purcell, Gov. John Connally and Attorney General Waggoner Carr plus substantial donations to the Democratic Party, Medderses attended a presidential ball in Houston on April 28, 1966.

At the personal invitation of President Lyndon Johnson, the couple went to Washington six days later for a reception at the White House. Since LBJ was returning to Texas the next morning, he asked the dazzled duo to accompany him on Air Force

Soon after the Potomac adventure, the Poor Sisters finally turned off the tap. However, the publicity shy nuns hesitated to press criminal charges even though Ernest and Margaret had taken them for a two-million-dollar ride.

The Medderses might still have made it had they come to their senses. The long-shot lawsuit had been thrown out of court the previous year, but they could have lived comfortably on the income from their cattle husiness

Stubbornly refusing to give up their millionaire masquerade, Ernest and Margaret borrowed \$730,000 from obliging banks in Muenster, Wichita Falls and Memphis. They shot the whole wad on lavish parties, including one for psychic Jeane Dixon, and in a matter of months wound up flat broke.

Meanwhile, Ernest's relatives suspected he had taken off with the entire pot at the end of the rainbow. Upset over his apparent refusal to share the proceeds from the lawsuit, they sued to force him to reveal the source of his income.

Ernest candidly confessed in open court that his ship had never come in and the \$500-million bonanza had been lost at sea. For five fantastic years, his clan had lived high on the hog off other people's money, namely the Poor Sisters and a bunch of gullible bankers.

Ernest and Margaret Medders eventually lost everything except their freedom. No jury had the stomach for putting



Endless War

As we approach the 5th Anniversary of 9/11, I believe it is time to question the concept of Endless War.

You probably haven't heard the government use this phrase but let's examine why it is a perfectly appropriate term. The government has very effectively convinced us that we are at war with a bunch of terrorists. Since terrorists have been around for a long time and will likely be around until the end of time, it follows that a war against terrorism will last a long time—hence endless war.

Clearly we should not be willing to so freely give *Carte Blanche* power to a government not known for competence as we so painfully learned last hurricane season. Perhaps we would have more to fear from a competent one.

I would suggest that things like the Patriot Act, widespread phone tapping and tracking of our phone calls are really just a symptom of this huge grant of war power. Ap-

parently as indicated by recent polling, the President has lost the confidence of the public which is most unfortunate but perhaps due to many of us having second thoughts about fighting an endless war.

Although the Bush Administration might be able to make a case for operational secrecy, the debate about what I have suggested in this essay has never taken place, certainly not in the place where it must—the Congress. Until that occurs we shall flounder in a general malaise that places us on a yo-yo course between inaction and over reaction

So if you accept this premise, of what should the debate be about?

I would suggest that the first part of the debate should be about identifying the enemy. This may seem strange to some but it is essential if we are to arrive at a consensus concerning the nature of the powers we should be willing to confer on the government in order to prevent the reoccurrence of events like 9/11. Wars are declared against nation states not individual or groups of individuals.

This is not to say that because the enemy is not an organized nation state, it is not a grave threat. When you attempt to go to war against a mere group of individuals, you have elevated them to a status to which they are not entitled.

But this doesn't tell us anything about who the enemy really is. For that I would sug-

gest that you read or go see the recent best seller, THE DA VINCE CODE. In this seemingly unlikely source for this discussion you will find a pro-file and character study of the enemy, you need only substitute Islam for Catholic Christian, but the resulting personality type is the same. There you will find the foot soldier, Silas and the leader Aringarosa. Fanaticism has universal components, one of which is the ability to pervert a perfectly good and righteous belief system to a single purpose objective that can justify anything for the cause. In this connection some level of competence is to be expected but only so far and it is their very obsession that should be viewed as an opportunity to seize control. Their obsessive nature should be a means to

right to them. The debate should at least ask if this is being pursued. This is apparently exactly how they were able to find and kill al-Zarqawi. We may still need to ask the guestion—are

undermine them if we

could only devote re-

sources in that direc-

tion. Their peculiar habits should if prop-

erly studied lead us

the question—are they doing this enough.

The next phase of the debate should turn to what is being done to protect the nation from further attacks? It is very unlikely that the same type of attack will happen again. The enemy's competence includes a certain level of creativity—so the next attack will likely be something completely different. Since they have followers all over the world, it is likely that the next wave of perpetrators will not be Arab. So how will the next attack come? We must be equally creative in figuring out what it will be. The debate should certainly include at least a general discussion of what is being done to figure out what they are up to. This is not an easy subject but it should at the very least include the funding of think tank efforts at profiling the

enemy, a data base of all prior terrorist plots whether carried out or discovered and anything else that a serious discussion can lead us to.

This debate must occur before we can be restored to our
rightful place as a truly free
country. The idea that the government knows best and will
above all protect us is really
nothing more than a sheepish
acceptance of BIG
BROTHER.
