Political Consultants Unhappy Over New Primary Dates

— State Party Activists Say Otherwise —

SACRAMENTO, Calif. - Republican and Democratic political consultants alike are unhappy with the way states are moving their presidential primary dates up the calendar this year.

Democratic consultant Jenny Backus told the Associated Press that the process served the American voters better when the primaries were spread out over the

"It's very disappointing to see all these states to try to frontload the process," Backus said. "I think the party and the process got stronger in 2004 by trying to stretch out the calendar."

Republican consultant Rich Galen said purse strings will become tighter due to the shortness of these campaigns, but he added that time will tell how voters will

"I don't think it helps democracy, but it's not clear to me that it hurts it," he said.

However, some state party activists replied that the result of the move has swung their way. Now, candidates are campaigning longer through their state instead of raising money and leaving for the next state.

California Gov. Arnold Schwarzenegger said he happily signed a bill moving his balling Feb. 5 as the date for state's presidential primary up from June to Feb. 5.

"Now California is important again in presidential nominating politics ... and we will get the respect that California deserves," he said.

The last time California made an impact in the presidential primary was 1972. At that time, Hubert Humphrey lost the Democratic nomination to George McGovern.

A host of other states are eye-

their Democratic or Republican primaries or caucuses.

Among those 15 states considering the move are Florida, Illinois, Michigan, New Jersey, New York, and Texas.

Alabama, Arkansas, Delaware, Idaho (Democrats only), Missouri, and Utah have already set their date for Feb. 5.

The states with primaries in January include Iowa, New Hampshire, South Carolina, and

Senator Seeks Hearings Over Halliburton Move

HOUSTON - Sen. Byron company, he said. Dorgan said last week that he would seek hearings to investigate the relocation of Halliburton's corporate headquarters from Texas to the **United Arab Emirates.**

The intention of this investigation is to see whether the world's second-largest oilfieldservices company is attempting to avoid taxes, sidestep prosecution of ongoing legal prob-lems, and continue doing business with prohibited countries like Iran, he said.

Halliburton CEO David Lesar said the decision to move his office to Dubai was made for purely business reasons, specifically to focus more on its Middle Eastern operations where it has operated since 1946.

In fact, over 38 percent of Halliburton's \$13 billion in oil services revenue came from the eastern hemisphere alone last year.

The company would still be incorporated in the United States, Lesar added.

A corporate lawyer from the firm Williams and Connolly told the Washington Post that only part of Halliburton's tax allocations would be affected by the relocation.

Specifically, the United States could not collect taxes on the company's income earned abroad and paid to a foreign

Otherwise, the Foreign Corrupt Practices Act and Sarbanes-Oxley would still apply to Halliburton because it is traded on U.S. stock exchanges.

In terms of tax purposes, the relocation is cosmetic, according to H. David Rosenbloom, director of the international tax program at New York University School of Law.
"[M]oving the chairman's of-

fice to Dubai is the same as moving it from the fourth to the 18th floor," Rosenbloom told financial web site MarketWatch

Legal experts also point out that moving completely offshore would hurt Halliburton's chances of landing contracts in

Still, Halliburton's move to the UAE fits its pattern of avoiding accountability to federal authorities, according to one watchdog group.

Halliburton Watch noted that Vice President Dick Cheney's former company is currently being investigated in the U.S. for rigging bids for government defense contracts, defrauding the military over contaminated food and water products and faulty equipment and services, illegally profiting in Iran, and bribery of Nigerian officials.

Cheney could be implicated in these investigations since he is said to have ran Halliburton as its CEO when one of the bribes to the Nigerian govern-ment officials allegedly happened. Cheney continues to receive compensation from the company.

Halliburton has also been accused of eluding federal oversight by using multiple subcontracts for work in Iraq and post-Katrina and refusing to pay benefits to former employees.

Last month, Halliburton said that it would sell all of its maiority shares in its scandalplagued engineering and military-services subsidiary KBR – the Pentagon's largest

contractor in Iraq.
Thus far, KBR, formerly known as Kellogg, Brown, and Root, has acquired \$20 billion in revenues from defense contracts in Iraq. Last year, the entire company gained \$6 billion in contracts.

'With various ongoing investigations, Halliburton's sale of KBR and the move to UAE are tantamount to fleeing the scene of a crime," said Jim Donahue, co-director of Halliburton Watch.

"It's an example of corporate greed at its worst," said Sen. Patrick Leahy, chairman of the Senate Judiciary Committee, referring to the company's relocation.

Referring to Halliburton as "a war profiteer in the worst way," Green Party co-chair Jim Coplen demanded that Congress cancel all contracts with the oil-services company and its subsidiaries.

Halliburton's shareholders meeting was moved last year from its corporate offices in Houston to the hometown of its founder in Duncan, Okla. These meetings over the last few years had been plagued by anti-war and anti-globalization protesters, and the 2006 meeting was no different.

The move from Houston, Texas, to Dubai, the fast-growing city in the UAE, has mixed results for the wealth and safety of Halliburton's employees.

While Dubai has no income tax, it gives less importance to the rights of employees than the United States does. The UAE has outlawed trade unions there.

Dubai – a known financial hub for terrorist groups - has a lower crime rate than that of New York

However, Halliburton employees could still be targeted since they work so closely with the unpopular U.S. military in Iraq, according to security experts.

Halliburton is the only company mentioned by Osama Bin Laden in an April 2004 tape.



Resolution To Impeach George W. Bush Introduced To Texas Legislature On Fourth Anniversary Of Iraq Invasion

AUSTIN — Lon Burnam is prepared to face what he is sure will be a political fallout over his actions.

Burnam, a six-term State Representative from Fort Worth's 90th district, spends his off hours as the Director of The Dallas Peace Center; a position he has held since May 1, 2000. To Camp Casey alumni who spent weeks in Crawford, he's one of the big wheels that helped open the flood gates during Cindy Sheehan's first summer in Texas. To the leadership of The Crawford Peace House, he's a close and frequent ally, ever-present at peace planning sessions. But to his colleagues in the Texas House, many of them moderate Republicans, he is, as of March 19, 2007, a definitive persona non-grata.

ICONOCLAST: Representative Burnam, you are going to propose an impeachment resolution to the Texas legislature on March 19, which is also the fourth anniversary of the invasion of Iraq. Correct?
BURNAM: Correct.

ICONOCLAST: That's pretty audacious, considering the state you are in. Why do you feel this must be done?

BURNAM: There are a number of these resolutions being filed around the country, and I think it is about time. We have to get a reality check. We're going to have to stop, look, and see where we are. BURNAM: That's pretty straightforward. If you recall the facts, and we go further into the charges in the resolution, that's exactly what he did. I think a lot of people have forgotten that

ICONOCLAST: Doesn't it say in the resolution authorizing President Bush to use force that it was given because Al Qaeda was known to be in association with Saddam Husain in Iraq?

BURNAM: I don't know if it said that precisely in the resolution, but everybody was given that impression at the time.

ICONOCLAST: The second reason you give in the resolution states taht the decision to go into Iraq was unnecessarily reckless, and though Saddam Husain was a despotic leader

ons against a neighboring country's Kurdish and Shia people, the invasion of Iraq was not necessary.

Being in Texas, a lot of the legislature is going to disagree with you. How are you going to put it forward to these other legislators to convince some to be more receptive to these allegations?

BURNAM: I ... am not anticipating that I will have very much dialog at all with Republican members of the legislature. I am expecting that I will be able to hammer home to some of my Democratic colleagues exactly how bad this was, and what an awful time we've gone through.

ICONOCLAST: What about your charges of keeping secret prisons, citizens being held illegally and without the writ of habeas corpus and so on. Could you cite some various examples that people not necessarily attuned to current events might not have heard of?

BURNAM: All of that information is out there in the public domain. I don't have it at my fingertips ... But there's not a week that passes without news items on this.

ICONOCLAST: Would you please explain the extent of your involvement with The Dallas Peace Center? And isn't the Peace Center in association with other area groups like DallasRally.com? They are putting on a protest in Dallas on March 19th. Is there going to be any effort to cross-promote your resolution?

BURNAM: Well, on March 19 the Peace Center is hosting a blood drive. We're doing a blood for oil exchange that day. We're inviting people to come to the Peace Center and give a pint of blood for a quart of oil, because we want to draw a very, very clear analogy of what's been going on here. A very few Americans have been sacrificing a great deal for the President's expansionist oil

ICONOCLAST: But how much a part of it all is oil? Given the number of other industries that are profiting off Iraq, don't you think there are bigger rea-

BURNAM: I think its a huge part of it. And yes, there are corporations that know how to profit off war. But the reason for the entire mismanagement of our relationship with Iraq, and almost the entire Middle East, is our almost insatiable craving for oil, and the fact that we've allowed the Bush family and other corporate oil giants to

who had used chemical weap- have way too much control over resolution, but I think we need our national public policy.

ICONOCLAST: In your resolution, you charge the President with releasing classified information in an attempt to sway public opinion. Obviously, you are referring to the Valerie Plame case. But there have been no convictions ...

BURNAM: But there may be a court ruling [by the time this interview is published].
ICONOCLAST: Yes, but it

would be for a perjury charge, not for revealing classified information.

BURNAM: But you can see, in that process, I think there's been further evidence of the release of classified information. But you're just trying to raise the question, so, um, yes ... You're probably not going to have that court ruling on the illegal release of classified information, but its going to be the next best thing: lying about the illegal release of classified infor-

ICONOCLAST: Are there any additional events or gathering that will be promoting or supporting this resolution that will encourage members of the public to support it?

BURNAM: I have been approached by a number of people that know I'm going to file this, and they asked what I think they should do in support of this. I frankly don't know. I've been struggling with that. I am verv deeply involved with the entire legislative process right now, while I think that being creative in thinking of ways to close the war is important, I just haven't had enough time. Ask me again

I'm polling people; I'm talking to people. Its going to cost me, personally, in the legislative process to file this resolution, but I think it is extremely important that we get everybody we can. Its kind of like Sudan. I wear a wrist-bracelet to remind me to keep things in perspective; to help me remember what's important. There's a lot of things that go on in the legislature that eat your time up, but aren't exactly necessary or important. But this is critical.

this is going to cost you, politically, among your constituents? BURNAM: I don't think it will

cost me among my voting constituents in my district. I have a fairly liberal district in Ft. Worth. But, you know, the general population in this country - 70 percent of the people - think we're totally on the wrong path on this war. Some people will be offended that I offer an impeachment

to galvanize the thinking here on what's been going on.

ICONOCLAST: You mentioned it will cost you in the legislature. Do you mean cost in allies? Perhaps moderate Republican allies?

BURNAM: Yes. And a lot of times, people that are primarily focused on anti-war opposition, are not going to be very focused on the subtle nuances of interpersonal relationships in the legislative process, which are extremely important. This will offend a number of my col-

IČONOCLAST: It seems a lot of Democrats are more concerned with victory in 2008 than preventing dangerous precedents from being set by the current administration. Why do they appear reticent to uphold the rule of law?

BURNAM: That's not unusual for people that are more directly involved with and interested in electoral politics. The little chicken and egg rhetorical question that I began back in the 80's with a friend of mine -'When is the peace movement going to become relevant to electoral politics?' - and the other question - 'When is electoral politics going to become relevant to the peace movement?' There's been way too long where there's no intersect at all.

ICONOCLAST: There is significance in polls which show 50, 60 percent support impeachment, should it be found that high crimes and/or misdemeanors had been committed. MSNBC has sponsored polls on their website which show an upwards of 80 percent support for impeachment.

BURNAM: I was not aware of those polls. I'll look that up.

ICONOCLAST: Do you have plans to seek higher office should political opinion continue to travel in a direction which favors the peace movement?

BURNAM: Well, I wouldn't foreclose any options right now ... I don't have any specific plans one way or the other.

ICONOCLAST: Have you ICONOCLAST: Do you think seen the poll which shows only 42 percent of Texans give the President a positive review of his job performance?

BURNAM: That doesn't surprise me. I've heard polls in the low 40's. But I hasten to remind you, that's not the case in the Texas legislature or the Texas state government.

ICONOCLAST: Among all the charges against the president contained within your resoluwhat do you believe to have been the most damaging to our Republic?

BURNAM: I think the bottom line is, no country should ever start a war. Our image, in the international community, is very, very badly damaged by him starting a war, by him lying to justify starting a war, by his pressuring other governments to participate in the war ... It is amazing how forgiving some foreign governments can be of the American people. But the universe as a whole has no use for this national government we have right now.

ICONOCLAST: Do you see any dangers in future presidencies should the Congress at least not attempt an impeachment on the grounds that high crimes and misdemeanors have

> BURNAM: "I clearly think that bad precedent has been established. It is in the republic's best interest that impeachment proceedings ... I mean, my God, they impeached Bill Clinton for lying about his personal, private life. This guy has lied about a war! To my mind, George Bush committed treason.



Concurrent ResolutionFor The Impeachment Of President George W. Bush

Filed in the 80th Legislature of the State of Texas by Representative Lon Burnam of the 90th Representative District on 19 March, 2007.

WHEREAS, The elemental source for initiating congressional impeachment proceedings is found in *The Constitution, Jefferson's Manual, and Rules of the United States House of Representatives*; Section 603 of *Jefferson's Manual of Parliamentary Practice* authorizes federal impeachment proceedings to be initiated by joint resolution of a state or territorial legislature as a matter of privilege; and

WHEREAS, Precedent for employing this authority is well-established and documented in *Hinds' Precedents of the House of Representatives of the United States*; one such entry related to a 1903 joint resolution passed by the Florida state legisla-

ture requesting that the U.S. Congress impeach U.S. District Judge Charles Swayne that resulted in a senate trial; and

WHEREAS, Invoking this authority, the people of the state of Texas charge that President George W. Bush has violated the United States Constitution and other federal law and abused the power of his office to the extreme detriment of the country and the interests of its citizens, actions that constitute high crimes and misdemeanors; and

WHEREAS, President Bush conspired with others to defraud the United States of America by intentionally misleading the congress and the nation regarding an Iraqi threat to the American people to justify a war in direct defiance of the United Nations Security Council and in violation of Section 371, Title 18, United States Code; in so doing, President Bush and members of his administration: 1) overstated the offensive capabilities

of Iraq, including that country's supposed possession of weapons of mass destruction, and manipulated and distorted intelligence relating to Iraq's weapons program during a plenary session of the United Nations and in direct contradiction to evidence gathered by international weapons inspectors; 2) manipulated public opinion by repeatedly and erroneously linking Saddam Hussein and the Iraqi government with the terrorist organization responsible for the attacks of September 11, 2001, al Qaeda; and 3) manipulated public opinion by stating in the State of the Union Address that Saddam Hussein had sought "significant quantities of uranium from Africa," despite confirmation from the Central Intelligence Agency and officials from foreign governments that the documents supporting these claims were forged; and

WHEREAS, The Bush Administration's decision to invade Iraq in 2003 was an unnecessarily reckless endeavor; while Saddam Husein was a despotic leader who had used chemical weapons against Iran, as well as the Kurdish and Shia people, and required prudent and efficacious attention by the United States and the international community in order to maintain peace and stability in the Middle East, the invasion of Iraq, in fact, necessitated the removal of United Nations weapons in spectors who were on the ground in Iraq and uninhibited from performing their job of monitoring Iraq's weapons of mass destruction capabilities; in fact, during the two years before the invasion, the United States enforced a no-fly zone over 60 percent of Iraq's airspace, significantly restricting the country's military movement and activity through its territory; and

WHEREAS, Indeed, Iraq posed no threat to the territory or people of the United States, yet the 2003 invasion of Iraq has resulted in the deaths of more than 2,400 American soldiers and a reported 38,000 Iraqi civilians, tens of thousands of wounded American soldiers, and severely diminished American military readiness; the fiscal cost of the war has surpassed \$370 billion; and

WHEREAS, In addition, to meet the needed manpower to execute the invasion, President Bush has federalized and deployed members of the Texas National Guard overseas, thereby subverting the power granted to the congress under Section 8, Article 1, United States Constitution, to call "forth the militia to execute the laws of the Union, suppress insurrections and repel invasions"; regrettably, the illegal deployment of the Texas National Guard deprives the state of its primary mechanism for defense and emergency response, needlessly jeopardizing the safety of Texans; and

WHEREAS, Under the guise of the war on terror, the Bush Administration has held American citizens and citizens of other sovereign nations without charge or trial; despite these secretive detentions, the United States has been embarrassed by revelations of torture and abuse of prisoners at Abu Ghraib, and evidence suggests that President Bush has authorized the use of similar acts of torture in the interrogation of detainees in American facilities around the world; and

WHEREAS, These detentions are clear violations of international and federal

law; as a signatory to the Geneva Conventions, the United States is bound to provisions of Article 13 requiring that "Prisoners of war must at all times be humanely treated..." and Article 17 stating that "no physical or mental torture, nor any other form of coercion, may be inflicted on prisoners of war to secure from them information of any kind whatever"; and

WHEREAS, Furthermore, the War Crimes Act of 1996 provides that a person who acts in breach of the Geneva Conventions has committed a war crime and is subject to punishment under federal law; similarly, Article VI of the United States Constitution provides that "... all treaties made, or which shall be made, under the authority of the United States, shall be the supreme law of the land ..."; and

WHEREAS, The Bush Administration's defiance of the Geneva Conventions has potentially threatened the lives and well-being of American soldiers captured as prisoners of war in future conflicts; likewise, the Bush Administration's defiance of international law has tarnished the United States' reputation as a country founded on principles of human rights and diminished America's integrity and influence in the international community; and

WHEREAS, In an effort to further manipulate public opinion relating to the justification for the Iraq war, the Bush Administration leaked classified information, knowingly revealing the identities of covert U.S. Intelligence agents and exposing them to potential harm and retribution; and

WHEREAS, The Bush Administration's breaches of law are not limited to international affairs, having similarly violated the public trust by suppressing scientific information and altering

government documents relating to the causes and effects of global warming with the intention of deceiving the American public; and

WHEREAS, President Bush's illegal actions have also undermined the balance of power between the branches of government; in clear violation of the Fourth Amendment, President Bush has publicly admitted to ordering the National Security Agency to contravene provisions of the Foreign Intelligence Surveillance Act of 1978, specifically authorizing the agency to spy on American citizens without securing a search warrant; and

WHEREAS, President Bush has also subverted congressional authority with regard to domestic policy by filing hundreds of signing statements that declare the administration's official legal interpretation of legislation passed by congress; in more than 750 instances, the president has asserted an authority to ignore numerous sections of the bills he has signed into law, including legislation relating to military rules and regulations, affirmative-action provisions, requirements that congress be told about immigration services problems, "whistle-blower" protections for nuclear regulatory officials, and safeguards against political interference in federally funded research; and

WHEREAS, Moreover, President Bush has overtly undermined the authority of congress; the Bush Administration has undermined specific provisions of the Clean Air Act by changing Environmental Protection Agency rules to allow older power plants, refineries, and factories to upgrade their facilities without installing newer, more advance pollution control technologies, thereby increasing the amount of pollution and threatening the health of all Americans; and


WHEREAS, In order to secure passage of the Medicare Prescription Drug, Modernization, and Improvement Act of 2003, the Bush Administration knowingly misled congress regarding the cost of the bill by providing a \$400 billion cost estimate to lawmakers while government documents revealed the true cost was calculated by administration officials to exceed \$500 billion; and

WHEREAS, Despite overwhelming evidence supporting these charges, the Republican-controlled congress has declined to fully investigate any of these incidents to date; now, therefore, be it

RESOLVED, That the 80th Legislature of the State of Texas submit the charges contained herein to the United States House of Representatives under the authority of Section 603 of *The Constitution, Jefferson's Manual, and Rules of the United States House of Representatives*; and, be it further

RESOLVED, That the charges contained herein constitute proof that the president of the United States has willfully violated his oath of office to preserve, protect, and defend the Constitution of the United States; and, be it further

RESOLVED, That George W. Bush, if found guilty of the charges contained herein, should be removed from office and disqualified to hold any other office in the United States.



Cheney Wrongly Links 9/11, Iraq Again

WASHINGTON - Vice Presi- appropriation will help finance dent Dick Cheney once again wrongly linked the planners of terrorist attacks of Sept. 11, 2001, to the past head of the Iraq government last week.

"Iraq's relevance to the war on terror simply could not be more plain," Cheney said in his first public speech since his former top deputy was convicted of a felony.

Findings by the Senate Intelligence Committee and the presidential Commission on Intelligence Capabilities, however, showed no relationship between Saddam Hussein and al-Qaeda before the U.S.-led invasion that happened four years ago this month.

Incandescent Light Bulbs To Be Phased Out

WASHINGTON - The world's largest manufacturer of light bulbs is phasing out a 125-yearold piece of inefficient technology – the incandescent light bulb.

In its place, Philips Lighting Company will market cleaner, more efficient lights and lighting systems.


The Natural Resources Defense Council (NRDC) praised the move with Philips at the National Press Club last week.

"This is a bright idea whose time has come," said Noah Horowitz, NRDC senior scientist. "The average incandescent converts roughly 95 percent of the incoming electricity into wasted heat. We can do better."

Horowitz noted that while efficient products are already on the market, such as compact fluorescent light bulbs (CFLs), the best has yet to come from Philips and other manufacturers, such as improved halogen light bulbs and light-emitting diodes (LEDs).

"There are roughly four bil-

lion light sockets in the United States alone, so screwing in cleaner, better technologies will dramatically lessen our power consumption and pollution production, while increasing our pocketbook savings," he said.



Britain's Labor Party Unable To Stop Nuke Renewal

LONDON – Britain's parliament by a 409-161 vote passed a bill renewing its nuclear arsenal last Wednesday.

The bill put forth by Prime Minister Tony Blair overcame dissent from 87 members of his own Labor Party.

The opposition Conservatives backed the plan to replace submarines armed with Trident nuclear weapons systems - to the tune of up to \$39 billion.

Anti-nuke protestors rallied outside parliament, the Scottish parliament, and a submarine base in Scotland before the

Members of the Labor Party - which has pushed for nuclear vowed to stop the nuclear weapon build up from continu-

'We must lead the world in campaigning for the eradication of the nuclear threat, and we must lead by example," said Nigel Griffiths, a Labor politician who left her government position in protest of the build

The last time Blair received so much criticism from within his party was in 2003 before a vote to back the U.S.-led war in

Blair justified the nuclear build up due to supposed threats from North Korea or

disarmament in the 1980s - other clandestine powers. After a decade in power, he is to step down in the next few months.

Critics of the rearmament point out that it would not only now be more difficult to prevent powers from seeking nuclear weapons, but it would also be a waste of resources.

Compared to the nuclear arsenals of the other four permanent members of the U.S. Security Council, Britain's is the smallest with four submarines holding 16 U.S.-made Trident long-range missiles and UKmade warheads.

Experts Blast UK Anti-Drug Law As Unscientific

LONDON - The British version of the U.S. Controlled Substances Act should be scrapped, according to a report by an expert panel released earlier this month.

The panel's 335-page report found that the Misuse of Drugs Act was not only unscientific but also unrealistic.

"The main aim of public policy should be to reduce the amount of harms that drugs cause. ... [A]ny approach that has total prohibition as its principal objective is bound to fail," stated the report.

The panel also noted that marijuana should be controlled much like the way legal drugs, such as alcohol and tobacco, are regu-

Drug policy reformers are attempting to use the RSA report to ignite discussion across the United States.

"If our marijuana laws were based on science rather than myths, we wouldn't arrest nearly 800,000 Americans each year for a drug that's safer than tobacco or alcohol, said Rob Kampia, executive director of the Marijuana Policy Project in Washington,

The authors of the report were brought together by the Royal Society for the Encouragement of Arts, Manufactures, and Commerce (RSA). Their study of the drug laws lasted two years.

States Department of Agriculture should finalize an organic standard for farmed fish before allowing imported seafood from "organic" label, says a watchdog group.

'U.S consumers cannot trust that imported farmed salmon sold as 'organic' is as pure as they expect," said Andrea Kavanagh, Director of the Pure Salmon Campaign. "The USDA should not allow use of

Currently, a number of European agencies have certified farmed salmon and cod being sold in the U.S. with an imported Norwegian, Irish, and Scottish farmed salmon as "organic."

However, the USDA's National Organics Standards Board (NOSB) has yet to develop an organic standard for farm raised fish within the United States, though its Livestock Commission has raised

some recommendations.

The Pure Salmon Campaign said that it does not support the organic certification of carnivorous fish (i.e. salmon) raised in open net cages in the marine environment.

These cage systems, the campaign explained, allow wastes, diseases, and parasites to spread throughout the

sachusetts, said she tells her from farms that directly discustomers there is "no such thing" as "organic" farmed salmon.

"As a chef and wife of an organic farmer, the term organic has no meaning to me when applied to fish," she said.

The same goes for Rick Moonen, chef and co-owner of RM Seafood at Mandalay Bay Resort & Casino in Las Vegas, Nevada

General's Anti-Gay Ideas Not Practical: Military Experts

NEW YORK - The U.S. military is running out of practical answers as to why homosexuals open about their sexual preference should not serve in the armed forces, say experts.

They point to Marine Gen. Peter Pace's comments last week referring to homosexuality as "immoral" and akin to adultery.

"I believe homosexual acts between two individuals are immoral and that we should not condone immoral acts,' said the chairman of the Joint Chiefs of Staff.

broke the story, Pace has said that he should have kept his personal beliefs to himself and instead spoke more directly to the military's decade old "Don't Ask, Don't Tell" policy.

This policy prohibits homosexuals from serving in the U.S. military. Those that do serve are obligated to hide their preference for the same sex from their fellow soldiers and supe-

Aaron Belkin, director of the Michael D. Palm Center and associate professor of Political Science at University of Califorpolicy is hypocritical when homosexuality is framed as a moral issue.

"The whiff of hypocrisy is even stronger when you realize the military let in 1,600 convicted felons under the moral waiver program last year, but Pace wants to draw the line at gays," he said in a press release.

The number of convicted felons enlisting in the U.S. military almost doubled over the last three years under the very same moral waiver program that bans candidates unqualified to serve due to bad behavstudy.

In recent years, the military has been recruiting more drug abusers and high school dropout to replace soldiers coming home from numerous tours of duty in Iraq and Afghanistan, according to reports.

Nathaniel Frank, a senior research fellow at the Palm Center, noted that evidence from the world's militaries shows that open homosexual soldiers do not undermine the morale of their fellow soldiers.

Frank pointed to a recent op-ed piece in the New York Times written by Pace's predecessor, Gen. Shalikashvili. In it, the general said that research has shown that gay service does not undermine cohesion.

Gen. Shalikashvili is not the only big name calling for the practice of gay exclusion in the military to end.

Vice President Dick Cheney has referred to the idea of gay exclusion "a bit of an old chestnut."







EDITORIAL **Bills Strengthen Democracy In Texas**

Democracy requires guts.

The state of Texas is fortunately in a good position to gain a little bit of both.

Two bills have been filed in this 80th Legislative session that, if passed, would increase participation and restore faith and account-

ability in electoral process here.

The first bill is Texas HB 2280 introduced by Rep. Mark Strama (D-Austin).

It removes "primary screen-out," the long election practice which denies voters the right to sign a ballot-access petition if they vote in a political party's primary.

Should this bill be approved, it would allow any registered voter to sign a petition for a new party or an independent candidate.

Texas is the only state in the union that has the restrictive law on the books.

House Bill 2280 came as a result of last year's heated gubernatorial election that featured five contenders, two of whom were running as independents while the other ran as a member of the Libertarian Party of Texas.

The primary screen-out law prevented the Green Party of Texas, for example, from collecting enough signatures to gain legal ballot access with which to then field a candidate for governor.

There were two reasons for the Green's misfortune.

One was that many registered voters had already voted in the primaries, causing them to be ineligible to sign petitions for other can-

The other was that remaining eligible voters were often confused by the fact that the law prevented them to sign a petition for more than one independent, nor for more than one third party, but they could sign one

Such a law mocks the basic principles and rights guaranteed in the First Amendment of the U.S. Constitution.

The benefits of HB2280 to the people of Texas also outweigh its expenses - which under the current system are costly and unruly for the Secretary of State to enforce.

Once the screen-out provision is eradicated, political debate, democratic participation, and candidate competition will increase – allowing more citizens to engage in the political process.

It should also be noted that HB2280 still protects existing political parties by preventing voters from affiliating with more than one political party. The bill would also not require a Texas constitutional amendment to enact.

The other bill is HB3119 as introduced by Rep. Borris Miles (D-Houston).

It provides a framework for both the Secretary of State and electronic voting machine vendors to properly certify election systems using open-source software for vote tabula-

House Bill 3319 is also said to protect counties from price exploitation by mandating vender competition.

Companion bills now in the Legislature advocate paper ballots to be retained in order to verify votes on electronic voting machines in cases of recounts and audit.

As one can see, the movement for a more democratic election process in Texas is gaining ground and should not be stopped.

To do so would only serve to dry the stain already on this state's reputation. Both HB2280 and HB3119 will allow voters

to choose candidates who better reflect their beliefs, values, and direction for the Lone Star

Together they increase fairness and accountability in democratic process.

They should be championed for the sake of the people of Texas.

No You're Not Paranoid, The SEC Is Out To Get You

If you think that the Securities and Exchange Commission extrudes those volumes of regulations to protect you the consumer, then I have a bridge to sell you; Quite the opposite. Those regulations that the SEC mandates actually make it nearly impossible for you to dream the big American dream. The chances of the ordinary investor getting a chance to invest in that little start up that will become the next Microsoft. IBM or CISCO Systems are slim to impossible, especially if the SEC has anything to do with it!

Don't feel alone, however; smaller companies are also being converted into cash through the machinations of the SEC's familiars.

That is why your chances of living out a comfortable retirement, or having the luxuries you see enjoyed by others, or participating in the wealth reserved for the elite few; those 'qualified" to invest in a Hedge Fund are null.

The SEC wants you exactly where you are; a working "John" who makes a day's wages for two days' work, worrying about whether your 401K will be enough, and whether the corporation you spent your life working for will go through down-sizing, or worse, "bankruptcy," and thus default on your retirement benefits.

It is ugly, but it is the reality faced by most Americans today.

carefullv Government couches the text in terms both esoteric and bland, designed to firmly close the door on your real participation in the wealth produced by America. This happens in ways you never even imagined, all the while simulating a system they proclaim to be for your protection. But the only ones protected are the "Good Ole Boys." You scrape by with pennies, they make trillions. Hedge Funds are at present their favorite form of thievery.

Welcome to Plantation America, where ownership is more subtle but as sure as any experienced by a shackled slave in the Old South.

Here are a few terms you need to understand before we get started.

Hedge Fund. This is an investment pool where a limited number of elite investors, usually 100 or less, invest usually one million or more dollars each. Many Hedge Funds are so exclusive that their minimums are 100 million for each investor. Hedge Funds are often described as "a managed portfolio

goal regardless of market conditions." Translation: To do whatever is required to bring in the money. Those "strategies" include several sophisticated strategies such as: short selling, arbitrage, hedging, and leverage. These are few words that disguise the meaning of "steal it" with more taste

Short selling. This is selling stock or another commodity whose value is expected to decline. It has two flavors — naked and covered. Naked means to sell what you do not really own. Covered means you own it and you sell it, repurchasing for less after its price has declined.. Remember this because it's an important part of the rest of the story! I should point out that this is illegal in every other aspect of life, but was declared legal by those closely associated with the Fed, the securities industry, and U.S. Treasury, which makes perfect sense if you understand what they really do.

Arbitrage means trying to profit by exploiting price differences of otherwise identical or similar "financial instruments." You move around to find different values placed on these. Financial Instruments are things that are paper, but valuable, like mortgages, notes, bonds, and securities. They like this best when they can simultaneously buy and sell the same item, making money instantaneously through a spread. A simple analogy of arbitrage is... ever notice that when you buy a stock you always seem to pay the highest ask, and when you sell it you always get the lowest bid! You have just been arbitraged!

Hedging. This is like betting on both horses in a two-horse race. One horse is the favorite and you bet enough there to cover the whole amount of both bets if Dobbin wins. But you collect really big if the other horse comes in first. You risk nothing! Brokerage firms lend out your stock that you have in the street name, and do this all day long with your assets and don't have to pay you a dime! To prevent this, simply take delivery of all your long-term stock investments. Otherwise know that the firm will use your stock to make them money. They will not tell you this or share the profit.

Leveraging is when you borrow money from someone else and use that money to buy something at a lower price than you can sell it for. You will althat targets a specific return ready have it sold before it ar-

a brokerage firm this means you borrow money from your clients, without their knowledge, to lend to a company issuing the stock who you are helping go public. The brokerage company sells you the stock for 50% less than it will be priced on the street at the IPO. Now you get commitments from clients who are agreeing to buy that same stock in the underwriting syndicate with a 5% markup over the IPO price or 55% more than you are paying. The price charged here is referred to as a premium, for whom you can see. From this is deducted the kick-backs, reimbursements of expenses, and that vacation to Hawaii on the private jet for the firm's major executives.

If you have kept track of the profit the firm made, here's how it works. They used your money (no firm capital at risk), they lent it to a private company they are taking public to buy stock at 50% or less of the market value. and they sell it to you for 5% more than the IPO that's a 105% profit on your money for the firm, and all you get as Joe Paycheck investor is to own the stock that has now been fully diluted. This is the protection racket run by those friendly folks we call the SEC and its network of crony brokerage firms and political watchdogs.

They don't pay you interest on the money most of the time; the subject is never mentioned. When the market turns south you wonder how you could lose so much money so quickly!

PIPES - Private Investment in Public Enterprise is also a type of Hedge Fund.

Brace yourself, this one will be a shock. Ever notice how certain things always have innocuous names that disguise what is really going on? This is just one of those things, PIPES, a type of hedge fund where millionaires or billionaires use the exclusive unregulated domain of private equity investment funds to manipulate the markets of thousands of small companies. Now, I will go slow, because I want to make this very clear and easy to understand. You remember Joe Paycheck. He has been wondering how he will retire on his present savings rate, so he begins looking for an investment he could buy that will present a better-than-average return on investment.

His friend John Doe tells him he was reading an article that recommended looking at small cap, micro-cap or penny stocks as potential opportunities. These are stocks just like the behold, the next day the stock is

rives. In other words, if you are NYSE stocks but the share prices are much lower per share, and the SEC regulates these companies just like the big ones.

Joe never really knew much about the stock market and so had always played it safe with mutual funds,. Those, however didn't make much. When he asked about buying stock he was told he needed to buy a round lot (100 shares), or he would pay a premium. One-hundred shares made the cost too high. With companies like IBM selling at \$58 per share (or \$5,800) or, say, Microsoft at \$24 per share (or \$2,400) that represented more money than Joe had at the time, and he had always heard it was best to diversify by owning at least a half a dozen companies or so to spread the risk around in case one company went south. It was impossible to do this when he had to buy 100 shares of each.

But Joe is worried about that retirement and so he decided to look around. After a few weeks of looking, Joe decides he will start watching the subscription services like PR Newswire, Business Wire, and Reuters. One day he reads a press release about a small startup company that has gotten a patent on the next big thing, and, low and behold, they just received \$100 million dollars in equity funding from a venture capital fund that struck a private equity deal with the company and its principals. But they are only going to take a draw against it right now of \$100,000. And can you believe it, those guys at the venture firm are even willing to take stock in return for the money they loaned! This has got to be a winner! More importantly, they are willing to wait on registering the stock they are getting until the company does its next stock offering! Joe assumes that these venture guys must have done their homework or they would never have agreed to loan \$100,000,000 dollars to a small startup company.

Going back a bit, a few weeks earlier. Joe had received a gift from his mom and dad for \$11,000 and he had gone to DATEK and opened a self-directed investment account in anticipation of doing something.

So with all this new found courage Joe logs onto DATEK and places an order for 100,000 shares of this stock in Big Thing Enterprises trading at .011 cents per share or \$1,100 total. Wow that's just over a penny a share! A penny is nothing! I will own 100.000 shares of the Next Big Thing! I'm rich... and, low and

trading at 3 cents and Joe has tripled his money.

So he decides he has to have more of this before it gets away from him and everybody else finds out about the next big thing! He decides he will buy another 100,000 shares at .03 and spends another \$3,000 of his parents' gift.

The next day he gets home from work and checks the market, and the damn thing is 8 cents per share. He has nearly a 400% total investment return and there are still three trading days left in the week.

So he says, well I am way "in the money,"so he decides what the hell, he takes the entire remaining \$6,900 in his account and buys 90,000 more shares at 8 cents a share, and for the next few weeks the company issues even more press releases and the stock goes as high as 18 cents a share on low volume but rather thin trading (more buyers than sellers). Then the company announces that they have spent all the money on research and development and needs to take another advance against the equity line of credit for another \$100,000. The venture firm says okay and another big spurt in the stock occurs with heavier volume (more sellers than buyers). All the company had to give up for the \$200,000 it borrowed was 30 million shares of stock (or .007 cents a share) and they still have 40 million shares in treasury and the principals have the rest (20 million). The company had a float of 10 million shares before this all started. That makes a 100,000 million share capitalization.

Then, all of a sudden, news stops coming out, and the company freezes its borrowing from the venture firm, and things go very quiet. The stock continues to fall in price all the way down to3 cents a share. Then it hits 2 cents a share and them 1 cent a share the next week. Joe decides he's just going to hold onto his stock and wait for it to come back. Then the company decides it isn't going to borrow any more of the \$99,800,000 left on its equity line of credit with the venture firm, because the cost of capital is just too high and the they would have to give up the company and still never have borrowed all the money on the equity line. Joe and the company have both received the same news, the light bulb has gone on.

Bush, Blair, And The Terrorism Shell Game

Deceit, Scams, And Coercion In The Formulation Of 'Synthetic Terrorism'

"Synthetic Terrorism" is the result of deceitful acts on the part of the Bush administration that later turned criminal, treasonous, and potentially result-

ing in the most serious crime against humanity since the Holocaust.

"Is it high treason or just a simple case of dereliction of duty?" detailed the potential crimes of the Bush administration but there is also

ample evidence in the public domain implicating U.S. allies; some of whom could be considered active collaborators in the deceptions.

At the center of this deception is a covert video of Bin Laden, the result of a sting operation executed by Saudi intelligence under the direction of U.S. intelligence. On the videotape, Bin Laden confessed to prior knowledge of the 9/11 attacks.

It was shown with a high degree of accuracy that the sting operation (the taping) took place on Sept. 26, 2001, two weeks after 9/11, and 10 days prior to the invasion of Afghanistan on Oct. 6, 2001. If Bin Laden were captured on Sept. 26, as per Bush's promise "dead or alive," there would have been little support, internationally or in the U.S., for an invasion of Afghanistan.

As soon as the sting team, which executed the taping, extracted itself from Afghanistan, around Sept. 30, 2001, Tony Blair made a strong statement relating to Bin Laden's guilt.

The BBC reports the Prime Minister's statements thusly:

"UK Prime Minister Tony Blair says he has been shown strong evidence linking Bin Laden to the attacks against the World Trade Center in New York and the Pentagon in Washington which cost more than 6,000 lives.

In a BBC interview, Blair said the evidence from intelligence services was "powerful and incontrovertible.

I had to look up the word incontrovertible in the dictionary - incontrovertible; not open to question or dispute; indisputable; absolute and incontrovertible truth.

Four days later, on Oct. 4, 2001, Tony Blair addresses Parliament and informs it that a document detailing Bin Laden's guilt would be placed in the Li-

The document covers the history of Osama Bin Laden, his relations with the Taliban, what we know of the acts of terror he has committed; and some of what we know in respect of Sept. 11. I enter a major caveat, much of the evidence we have is intelligence and highly sensitive. It is not possible without compromising people or security to release precise details"

Actually, no details of such evidence, precise or vague, were given in the "evidence document," just a new qualifier of a very specific nature. The following is the complete statement:

"There is evidence of a very specific nature relating to the guilt of Bin Laden and his associates that is too sensitive to release.'

Not much could have changed in four days and what we can conclude from these statements is that the *incontrovertible* evidence was of a very specific nature, gathered by intelligence, too sensitive to release, and that it was shared with **some** of the allies.

The only evidence that fits such description is the product of the intelligence sting operation - the Bin Laden confession tape of Sept. 26, 2001.

Other than Tony Blair, the only allies that made similarly strong statements around that period were NATO, and Pakistan; allies who are critical to the success of Operation Enduring Freedom.

From a State Department document:

"On Oct. 2, 2001, ...After a briefing by Coordinator for Counter terrorism Francis X. Taylor, NATO Secretary-General Robertson said that the United States had provided

dence of bin Laden's role in the terrorist attacks. As a result of the briefing, NATO concluded that the attacks were directed from abroad and will "therefore be regarded as an action covered by Article 5 of the Washington Treaty, which states that an armed attack on one or more of the allies in Europe or North America shall be considered an attack against them all." NATO was therefore prepared to provide unconditional support for U.S. military actions.

From the same document:

"On Oct. 4, 2001, ...In Pakistan. Foreign ministry spokesman Riaz Muhammad Khan said that the evidence shown to his government "provided sufficient basis for indictment" of bin Laden'

Why was this damning evidence shared with those allies essential to prosecute a war and why was it *not* shared with the rest of the world that was looking for a fair and peaceful outcome?

Now it becomes too obvious that the invasion was the real goal and what that entailed in terms of geopolitical gains for the U.S.; in Bush's own words of Feb. 14, 2007, "sometimes money trumps peace." It was not a slip of the tongue; it was an intentional jab at the European leaders' position on Iraq. Bush stood by his words saying that he knew the statement is general but he considers it accurate; does this accuracy apply to his own approach to Afghanistan?

The invasion went ahead and the Pentagon was counting on a total media blackout over the operations in Afghanistan in order to contain international and domestic public opinion. The Pentagon's control of journalists in the field of operations was so tight that a mutiny among journalists was brewing. The Pentagon even had to apologize, as reported by The New York Times:

"We owe you an apology." Victoria Clarke, the assistant secretary of defense for public affairs, wrote Thursday in a letter to the Washington bureau chiefs of major news organizations. "The last several days have revealed severe shortcomings in our preparedness to support news organizations in their efforts to cover U.S. military operations in Afghanistan."

The only news organization that was not affected by this blackout was Al-Jazeera and its

"clear and compelling" evi- coverage exposed the atrocities intimidated or to act as Bin endured by civilians. This prompted war cheerleader. Johns Hopkins professor, CNN pundit, and later demoted to FOX News pundit, Fouad Ajami, to publish "What the Muslim World Is Watching" in the New York Times, on Nov. 18, 2001. A 6,178-word document that can only be described as a tirade that is too large for even a magazine format; yet a newspaper published it. The whole article can be summed in this relatively small excerpt from a paragraph that describes Al-Jazeera's impact on the Muslim viewer:

> "The aim is to win the propaganda war, or the battle of public diplomacy in the Muslim world.... The Bush administration is eager to explain America's war, eager for the Arabs and the Pakistanis to accept the justness of its military actions. But how can it possibly expect to persuade the reporters at Al Jazeera to change their deep-seated view of this conflict? It would therefore be folly for America's leaders to spend too much energy trying to moderate Al Jazeera.'

> This paragraph must have gotten etched in Bush's mind and might be behind his wish to bomb Al-Jazeera's headquarter in Doha; it seems bombing their offices in Kabul and Baghdad was not enough. Anyway, that is another story and the bottom line is: Al-Jazeera's coverage prompted the Arab and Muslim street to keep asking for evidence and forced the leaders of the invasion to keep trying to produce it.

An attempt in mid Nov. 2001, by Blair failed. An Al-Jazeera bureau chief explained what happened; Blair attempted to release a tape of a Bin Laden interview conducted by Al-Jazeera. The interview was to be comprised of responses to questions by both Al-Jazeera and CNN. When the Al-Jazeera's team reached Bin Laden's hideout to conduct the interview, their questions were tossed out and were informed that Bin Laden had his own set of questions with prepared answers. The news team objected. but feeling threatened, accepted to conduct the interview. Also, Bin Laden put a condition on Al-Jazeera, either Al-Jazeera airs all or none of the interview. Such a condition forced Al-Jazeera to choose *none* and refused to be

Laden's mouthpiece.

Somehow, Al-Jazeera's decision reached the west, and British intelligence managed to lift the tape. On Nov 11, David Bamber of the SUNDAY TELE-GRAPH in London introduced the lifted tape. Bamber informs us that the Telegraph had access to it and reports it this way:

"The footage, to which the Telegraph obtained access in the Middle East yesterday, was not made for public release via the al-Jazeera television network used by bin Laden for propaganda purposes in the past. It is believed to be intended as a rallying call to al-Qa'eda members. He also tells us: "The video will form the centrepiece of Britain and America's new evidence against bin Laden, to be released this Wednesday.

Those translated quotes were recognized by Al-Jazeera as their tape and moved to prevent Blair from using it.

The U.S. distanced itself from the video unveiling and left Blair twisting in the wind trying to save face armed with only a partial transcript.

On Nov. 14, Spin Meister Blair quoted the transcript in Parliament as evidence. To the rest of the world and in legal terms, those quotes can only be considered as hearsay on hearsay and fell too short to be accepted as evidence.

On Nov 14, T.R. Reid, the Washington Post Foreign Service correspondent, reported from London on Blair's predicament; he wrote:

"The British government did not release the video or a full transcript, saying it does not have a copy of the video but has information about it from intelligence sources.

This feeble attempt by Blair to supply evidence can only be described as a desperate act. Its failure augmented the feelings of anger and impatience of the Arab and Muslim streets. Proper evidence needed to be presented and the only evidence of value that can counteract Al-Jazeera's coverage of the atrocities was the tape produced by intelligence services on Sept. 26,

It took Washington a month to produce the evidence. One, they needed to put space between them and Blair's failed attempt. Two, they needed to clean it up as much as possible to prevent the viewer from realizing it was a covert tape.

How many government officials, western and otherwise, read The Observer that weekend? I would find it hard to believe if the answer is. none. I also find it hard to believe that no intelligence services vetted those words.

The world is on the brink of another war instigated by the Bush administration as part of its fake war on the "Synthetic Terrorism" it created.

Lawyer Accepts Pardon But Nothing Else

On March 22, 1877, Guy M. Bryan wrote the new President of the United States, who happened to be an old college classmate, to recommend a relative for the Supreme Court.

William Pitt Ballinger had no idea why the caretaker governor summoned him in the middle of May 1865. He was relieved to learn that Pendleton Murrah and Gen. John Bankhead Magruder had accepted the fall of the Confederacy as an irreversible fact.

The war was over, and they needed someone to negotiate a separate peace for Texas. For once Ballinger's stubborn opposition to secession would come in handy. The victorious Yankees might be willing to talk to a Unionist, who had not shed a single drop of blood for the Lost Cause.

Accompanied by Ashbel Smith, a diplomat that negotiated treaties for the defunct Republic, Ballinger sailed for New Orleans on May 27, 1865. His twin objectives were to keep northern soldiers out of Texas and the freed slaves working for their former masters.

Gen. Edward Canby was polite, even gracious, and let the visitors have their say. He then told them there was no way Texas could avoid military occupation, which began on June 19 with the arrival in Galveston of 800 troops. But Canby and his better known superior, Gen. Philip Sheridan, did assure the two-man delegation they would do everything in their power to maintain a stable black labor This Week In Texas History

For a discussion of political matters, Gen. Canby suggested the Texans speak directly with President Andrew Johnson. Ballinger and Smith decided to heed his advice and hung around New Orleans waiting for their travel documents.

But the Washington trip was canceled by soreheads back home. Radical Republicans, whose property Ballinger confiscated as Confederate receiver, opposed me representing Texas for I had been engaged in the most odious work of the rebellion."

Ballinger learned upon returning to Galveston that Johnson had issued a general amnesty, which wiped the slate clean for most southerners. Only two groups of former Confederates, government officials and those with assets in excess of \$20,000, were exempt and had to apply for presidential pardons.

Since he fell into both categories, Ballinger wasting no time in penning a personal appeal to the president. But he realized that full restoration of his rights could not accomplished through the mail.

Carrying glowing testimonials from the provisional governor and lesser luminaries, Ballinger made the difficult journey through the war-ravaged South. His first stop in Washington was the home of a profit after expenses was \$7,500, a kinsman, whose influence could handsome sum for those times. tip the scales in his favor.

Ballinger and Samuel F. Miller had been close since their Kentucky childhood, and their warm friendship had weathered the war. Miller now sat on the Supreme Court, one of five Lincoln appoin-

The reunion with his brother-inlaw left Ballinger worried and depressed. Miller told him flatly, "Reason dictates that in some way you should be punished." The justice insisted that examples had to be made of Confederate leaders, which meant prison for most and the gallows for "a half dozen of the most prominent and wicked."

When Ballinger called again, Miller had letters of introduction to the president and secretary of state William Seward waiting for him. One sentence leaped off the parchment: "I have never known a man whose integrity I would rely on more confidently.

Miller had gone to bat for him and knocked the ball out of the park. The pardon — the first to a Texan — was granted without the applicant setting foot in White

Ballinger suddenly found himself in the absolution business. He presented 40 petitions from other worthy Texans to the obliging president and within the month had wonderful news for 40 grateful clients.

Texas' top attorney had not secured the priceless pardons out of the goodness of his heart. His net 152, Friendswood, TX 77549.

handsome sum for those times.

Even though Ballinger's fortune steadily grew after resuming his law practice, he always seemed preoccupied with money. It was the paltry pay that he cited as the reason for turning down a seat on the state supreme court offered in 1874 by Gov. Richard Coke.

Another brother-in-law put Ballinger on the spot three years later. As soon as Rutherford B. Hayes was sworn in as president, Guy Bryan launched an all-out campaign to convince his college chum to chose Ballinger for the highest court in the land.

This time the public-service shy lawyer could not plead poverty nor trot out his second-favorite excuse that he could not bear to be parted from his family. So Ballinger argued that his Confederate past was certain to come back to haunt him and cause public embarrassment for all concerned. He successfully planted the seed of doubt that undermined Bryan's efforts and eventually allowed him to withdraw his name from consideration.

The year after William Pitt Ballinger spurned a seat on the U.S. Supreme Court, admiring Texans handed him the governorship on a silver platter. Once again he said turned up his nose at the honor, and that was the last time anyone bothered to ask.

It wasn't as if all we had to do was lay off our upstairs maid and the butler and everything would be fine. Instead, it was all those little things that we buy and don't really think about that had

been adding up. So, we took a certain amount of money out of the bank and put the cash in a secret place in our house. (Note to Burglars: Since we no longer are doing the cash-only system, we don't keep cash in our house anymore). We would each take some cash out of our stash whenever we felt we needed to replenish the money in our wallets. However, we'd be very careful about those "withdrawals" because the money in our hiding place would have to last the entire month.

I had never been in the habit of carrying much cash on me. I would usually just have a few dollars stuffed in one of my pockets. Similarly, when we pay for something with a plastic credit card, it doesn't "hurt" as much as actually reaching into our wallets and handing over our cash to a stranger.

As I said, the cash-only system worked. I was much more likely to ask myself the question, "Do I really need this?" before I bought something.

Since it worked so well, why did I hate our "no credit card" system? For one thing, I felt like I was a kid on an allowance. I resented that I couldn't buy whatever I wanted. And there was guilt attached to every purchase – "Should I really be buying this?" "If I do, will that mean I'll have to take more money out of our hiding place?" "If I buy it, does this mean I'm an irresponsible person with no self-control who is a poor role model for my children and a bad citizen of the world?" (Sometimes, I'm a little rough on myself).

After two months, we decided, thankfully, that we had learned how to spend money more wisely, and we could go back to a more normal, relaxed "sometimes credit card, sometimes cash" system.

But the damage had already been done. Even though I am now "allowed" to make an impulse purchase with my credit card, the leftover guilt from the two-month experiment stops that purchase from being a joyous one. It's no fun to be responsible.

I think the only thing that would get me out of this mood is if we would go out and have a ridiculously expensive evening, throwing our money around extravagantly, celebrating the fact that we have learned how to be responsible with our money.


